### **STATE BUDGET MAKES MAJOR INVESTMENTS IN OUR COMMUNITIES**

I am pleased to report the new 2022-23 state budget takes steps to address many of the issues important to our community.

The \$45.2 billion spending plan includes a historic increase in state funding for education, including an additional \$525 million for basic education and an additional \$100 million for special education. The budget also provides \$225 million in Level Up funding to Pennsylvania's most underfunded school districts.

In addition to the basic and special education funding, our school districts and others throughout the state will each receive more than \$200,000 to fund school safety and mental health resources.

Other highlights of the new state budget include additional funding for childcare; a one-time benefit increase for the Property Tax/Rent Rebate Program, which helps seniors; the Whole-Home Repair Program, which will provide grants to homeowners for needed home repairs; and major investments in the outdoors to preserve and protect Pennsylvania's parks, forests, trails and streams.

While no budget is perfect, I believe this year's state spending plan makes important investments in our communities and more importantly, in our families.

### **PROPERTY TAX/RENT REBATE UPDATE**

The 2022/23 state budget includes a \$140 million boost to the Property Tax/Rent Rebate Program, which means seniors and people with disabilities who receive the Property Tax/Rent Rebate will receive a bonus one-time payment.

Here are some things to know about this supplemental payment:

- The one-time check is equal to 70% of what they receive in this year's rebate.
- The extra payment will be made to applicants who qualified for a regular rebate on taxes or rent paid in 2021.
- There's no need to act. The supplements will be made automatically.
- Anyone eligible for the extra rebate will receive it in the same way they chose to receive their regular rebate, either by check or direct deposit.

The rebate program benefits eligible Pennsylvanians 65 and older; widows and widowers 50 and older; and people with disabilities 18 and older.

If you received a rebate last year, you should have received a 2021 application form in the mail. If not, applications are available online at www.revenue.state.pa.us or by calling 1-888-222-9190. Residents can also call or visit my office to obtain the form. The application period closes on December 31, 2022, so please do not delay!

#### SUPPORT FOR VETERANS AND FIRST RESPONDERS

Our veterans and first responders have given so much of themselves to protect our country and our communities. It's only right that we do everything we can to help and support them in any way we can. As a member of the House Veterans Affairs and Emergency Preparedness Committee, I hear the concerns many of our veterans and first responders face, which is why I've proposed the following legislation:

House Bill 2597 – This bill would amend the Tax Reform Code to provide a sales tax exemption to firefighters who purchase firefighting equipment with their own money.

House Bill 2708 – Currently, a veteran's disability benefits are considered income for several state senior citizen programs. This bill would exempt those disability benefits from being counted as income for the Property Tax/Rent Rebate Program, the PACE/PACENET pharmaceutical drug assistance program funded by lottery proceeds and the reduced vehicle registration fee program.

I am also supporting the following legislation:

**House Bill 2492** – The collapse of the Fern Hollow Bridge in Pittsburgh earlier this year highlighted the need for a second type 1 urban search and rescue team in Allegheny County. Right now, the only team that exists is based out of Philadelphia. This legislation would create a new team that would assume primary coverage in western Pennsylvania with the same level of capabilities, resources and training.

**House Bill 2237** – This bill would provide a cost-of-living adjustment or COLA to retired municipal police officers and firefighters. This proposed COLA would add an additional \$480 annually to the pension of an officer with 20 years of experience and 20 years in retirement. The last time the General Assembly provided a COLA to our retired public servants was nearly 20 years ago.



In August, I hosted an informative and productive hearing at CCAC Boyce Campus on my legislation to ease the tax burden on equipment that volunteer firefighters have to purchase themselves. Both statewide leaders and local first responders in my district gave valuable testimony at the hearing.

#### NEW NUMBER OFFERS QUICKER CONNECTION TO CRISIS SERVICES

Pennsylvanians in crisis will now have easier access to help, thanks to a new three-digit dialing code. Dialing 988 will link callers directly to trained counselors who are part of the National Suicide Prevention Lifeline.

Veterans can reach the Veterans Crisis Line by dialing 988 then pressing "1."

Counselors can activate a mobile mental health crisis team that will arrive on site to provide a therapeutic intervention, or they can make referrals for outpatient services or transportation for further evaluation. According to data from the Department of Human Services, 90% of calls are resolved by phone, without the need for further intervention. All counseling is free, confidential and available on a 24/7 basis.

The current Lifeline phone number (1-800-273-8255) remains active.

Lifeline reports that in 2020, it received more than 76,000 calls from Pennsylvanians.

# ARE YOU PREPARED TO VOTE THIS NOVEMBER?

The General Election is right around the corner, happening on **Tuesday, Nov. 8**. Unlike our closed primaries, **this election is open to all of Pennsylvania's registered voters**, so I wanted to ensure you have all the information you need to carry out your civic duty.



- The last day to request a mail-in/absentee ballot is Tuesday, Nov. 1. Anyone interested may request one online at https://bit.ly/3yoeDmS (link is case sensitive). If you'd prefer a paper application, my district office can provide you with one.
- The county election office must receive all mailin/absentee ballots by 8 p.m. on Nov. 8. Postmarks are not enough. For more information about voting in Allegheny County, visit: https://www.alleghenycounty. us/elections/index.aspx.
- Voting in person? Visit pavoterservices.pa.gov/ Pages/PollingPlaceInfo.aspx to find your polling place. Polls will be open 7 a.m. - 8 p.m. on Election Day.
