### The governor's 2023-24 budget proposal

I was honored to sit in the House chamber watching Gov. Josh Shapiro deliver his first official budget address. His proposal prioritizes so many issues for our community, and I look forward to voting in favor of fair education funding, programs for gun violence prevention and raising the minimum wage, just to name a few. This commitment builds on the 2022-23 budget that was enacted with bipartisan support.

In addition to the budget, a new day was ushered into Pennsylvania state government when the first female speaker and the first Black lieutenant governor were sworn in.

The governor's budget plan makes sound investments while maintaining fiscal responsibility by assuring our Rainy Day Fund remains at \$5 billion, all while leaving the commonwealth with a healthy multi-billion-dollar surplus.

### Here is a brief breakdown of the proposal:

#### Education

Under this proposal, basic and special education would share a \$671 million increase in funding. Higher education receives a \$60 million increase, including community colleges. Head Start would see a \$2.7 million increase, while Pre-K Counts would see a \$30 million increase. \$100 million would go to school safety and security, with another \$100 million for environmental repairs. The environment in which our children exist all day during the school year matters. Crumbling schools that are asbestos-laden or have poor drinking water, no drinking water or lead paint falling from the walls are unacceptable and deplorable conditions that we need to change now.

#### Investing in our workforce

In order to bring in employees that are licensed and ready for some of our most critical jobs, a new Individual Recruitment and Retention Tax Credit - \$24.7 million - would be included for those vital professions facing shortages like first responders, nurses, teachers, and public policing. Current Pennsylvania residents could qualify for a credit against their personal income tax of up to \$2,500 per year for three years if they acquire a license or certification in one of those areas.

\$20 million would go to a pandemic-era federally funded program to support historically disadvantaged small businesses.

#### Stronger, Safer Communities

At this moment in time, our community safety is at the top of everyone's mind. Guns are too accessible, and we routinely are not feeling safe in many of our communities. \$105 million would go for the Violence Intervention and Prevention Program and \$5 million for the Nonprofit Security Grant Program. Additionally, the plan would call for hiring 384 state troopers and providing \$20 million for equipment upgrades.

#### The governor's 2023-24 budget proposal Continued

#### **Property Tax/Rent Rebate**

If you qualify for the Property Tax/Rent Rebate Program, this information will be important to you. The governor's plan would increase the income cap for homeowners from \$35,000 to \$45,000. It also increases the income cap for renters from \$15,000 to \$45,000 to match the cap for homeowners. It would allow the maximum income threshold to grow with inflation rather than legislative vote beginning in claim year 2024. And it would increase the maximum rebate to \$1,000 from the current \$650.

#### **Reducing Food Insecurity**

Food insecurity is real, and it boggles the mind to think here in the commonwealth it exists. But an annual review from 2019 shows that more than 1.3 million Pennsylvanians didn't always know where their next meal was coming from. So, in this budget, the governor proposes a \$16 million state investment in SNAP benefits, which increases the minimum monthly benefit from \$23 to \$35. Another \$2 million for the Fresh Food Financing Initiative would be an investment in lower-income communities and food retail businesses that are Black/indigenous/peopleof-color owned.

#### **Criminal Justice Reform**

\$10 million is included in the budget to ensure access to constitutionally required legal defense and ensure that public defenders have the resources they need to provide legal representation to defendants who cannot pay for it on their own.

#### **Minimum Wage**

A conversation we continue to have and hope to accomplish is the proposal to increase the minimum wage from \$7.25 per hour to \$15 per hour effective Jan. 1, 2024.

#### Adult Use Cannabis

The governor is serious about a new Adult Use Cannabis Tax at a rate of 20% of the wholesale price of products sold through the regulated framework. This would include making adult-use cannabis legal in the commonwealth.

#### In Summary

In order for this proposal to become reality, it must be vetted through the legislative process and both the House and Senate need to vote on it. I will do all I can on my end to ensure we see these favorable proposals become law and help to move the commonwealth in a more positive, prosperous and safe direction for now and many years to come.



#### Committee Assignments

Each of these committees focuses on issues that can greatly benefit our community and communities across the commonwealth, and I look forward to serving on them.

In addition to these committees, I also serve as co-chair of the PA Safe Caucus, which addresses gun violence, gun safety and expanding mental health resources.

Legislation

In my first six months in Harrisburg, I have voted to pass multiple pieces of legislation to do things such as: provide no-cost cancer screenings for highrisk patients (I'm pictured to the right at the press conference where Gov. Shapiro signed this legislation into law), address the teacher shortage, keep our communities safe from gun violence, and much more.

- I have also introduced legislation to:
- Curb the illegal dumping of waste tires.
- Ensure all property owners in Philadelphia are made aware of future development projects near them.
- Establish the Freedom School Grant Program.
- Require bullying prevention education to be taught in schools across all grade levels.
- Promote access to Advanced Placement courses.
- Bring drivers education to schools.
- Urge Congress and the president to direct additional aid and support to Haiti.



### **Gun Safety Bills**

Recently, we passed two bills in the House to help address gun violence. Those bills were:

- H.B 1018 to create Extreme Risk Protection Orders.
- H.B. 714 to enact universal background checks.

As co-chair of the PA Safe Caucus, it is my No. 1 focus to pass sensible gun safety legislation. I applaud my colleagues who joined us in voting for these bills in the House. We are in the midst of a gun violence crisis in Philadelphia and across the commonwealth. Passing these bills in the House was a step in the right direction to making our communities safer. The bills are now in the Senate for consideration, and I urge the Senate to act immediately.

In March, I joined students, activists, and violence prevention organizations on the Capitol steps in Harrisburg for a rally against gun violence.
