KEEPING YOU IN THE KNOW

I arrived in Harrisburg as one of the youngest members of the House of Representatives. Since then, I have never forgotten where I came from or where I grew up.

Family, neighbors and friends have helped keep me grounded.

One of the greatest joys about this job has been to work tirelessly as an advocate for Erie County. In the Capitol, I fight for the state funding we need to make a difference in the lives of the workers and families who call Erie home. That means advocating for our fair share for schools, first responders, police, nonprofits, small businesses and more.

Here at home, I'm proud to have one of the hardest working offices in the state.

We don't sit back and coast, we hustle.

In the first 100 days of the year, my team and I helped an average of three people each day complete Property Tax/Rent Rebate forms. By the end of August, we helped connect more than 500 people with that program, returning an estimated \$250,000 to Erie County seniors, widows, widowers and people with disabilities.

I have brought that same dogged determination to my duties as the House Majority Policy Committee

Chairman and as a member of the House Majority leadership team. I am not afraid to reach across the aisle to do what's right. We crisscross the state examining big-topic issues – including allocating more money to technical education – as well as emerging concerns. One of the biggest victories this year came in the form of the state budget, which included historic education increases. It has been a difficult

SETTING THE AGENDA

I'm currently in my second legislative session as the House Democratic Policy Chair. I'm proud to announce that I held more than 100 Policy Committee hearings during my first session, and we've already held more than 47 hearings this session alone. But our work isn't nearly finished. We've got a busy fall schedule as we continue to travel the state focusing on the issues that matter to everyday Pennsylvanians.

As Chair of the Policy Committee, I focus on the issues that matter to you: job creation, infrastructure reinforcement and expansion, helping businesses grow and thrive, access to healthcare, and investments in education.





BUDGET WINS

House Democrats passed a sensible budget in early July. It took until August, but Senate Republicans finally signed the budget and sent it to Governor Shapiro's desk to be signed into law. While the final spending plan wasn't exactly what we had imagined, we did see several budget wins, including:

- ▶ \$717 million increase in education funding
- \$10 million increase in violence intervention and prevention grants
- \$20 million in new funding for Historically Disadvantaged Business Assistance
- \$50 million in new funding for Whole Home Repairs program

BRINGING TAX DOLLARS BACK TO OUR REGION

In just seven months, I have already secured nearly \$14 million for the region.

Bizzarro announces:

- \$7.3 million for local road construction, building restoration, equipment
- Portion of \$4 million headed to Erie for community- > \$250K for apprenticeship driven drug and alcohol recovery services
- \$335K for water quality improvements
 - programs
- \$242K for affordable housing programs
- \$157K for violence prevention programs
 - \$120K for school safety improvements

MOST PRODUCTIVE HOUSE SESSION

Despite working with the slimmest majority, PA House Democrats passed 150+ bills just this year to lower your taxes, help you save for retirement, put more teachers in your schools, and make our neighborhoods safer.

BEAGLE FREEDOM BILLS

In April, I teamed up with fellow animal advocates, local and state shelters, and families to host a reunion for some of the 4,000 beagles that were rescued from a mass breeding facility in Virginia last summer. The ANNA Shelter, a nonprofit, no-kill open admission animal welfare organization located in Erie, took in 50 of those beagles, all of which have since been adopted.

As a result of those heinous acts on our four-legged friends, I unveiled my legislation to protect animals from inhumane tests and abuse. Specifically, my bills would protect animals being bred and used for

research in animal testing laboratories and from kennels and dealers who face serious or multiple citations under the Animal Welfare Act. I'm doing everything I can to make sure these animals are protected, that they're able to be in someone's lap, not someone's lab.





BETTER REPRESENTATION AT PENNDOT

People with disabilities who drive currently don't have a voice at the table when it comes to PennDOT. That needs to change.

My bill would ensure someone who is an advocate for people with disabilities, someone who works with people with disabilities who drive, would be placed on the Medical Advisory Board at the state Transportation Department. This is key since the board is responsible for creating the physical and medical criteria drivers must meet to obtain a license.

EXPANDING PARAMEDICINE OPTIONS

Jam-packed hospital ERs are often clogged with patients needing nonurgent care. There's a better option.

Started in Pittsburgh, community paramedicine offers an efficient alternative to primary care and emergency services. EMS providers deliver care to patients, in their home – freeing up ER staff and facilities for urgent care. It also allows people to receive the care they need in the comfort of their own home.

Instead of rushing to a hospital, patients can receive health assessments, disease monitoring and follow-up appointments without leaving their home.

SAVE OUR SCHOOLS POLICY TOUR

In August, The House Majority leadership team joined the Policy Committee for a statewide SOS tour to Save Our Schools, crisscrossing the state, covering more than 675 miles in four days. The committee heard from educators, school administrators, advocates and parents on the funding challenges facing public schools. The tour made stops to talk about the need to fix toxic schools, to discuss disparity in education funding, for a hearing on the importance of bolstering rural education, and to talk about the cyber charter school reimbursement issue.

We visited four counties in four days, having important conversations with the teachers and administrators who dedicate their time to our students, and we've heard the same thing at each stop—we must properly and equally fund education in Pennsylvania. It's time to get to work.

ARMORED VEHICLE FOR MILLCREEK

In the fall, I was proud to secure \$312,000 for the Millcreek Township Police Department to help them purchase an armored vehicle. These are life-preserving vehicles built for the specific purpose of saving the lives of local law enforcement. It's extremely rewarding to see state funds



being used to protect the well-being of officers who are called on to step into harm's way to serve our community. It's been an honor to work so closely with the Millcreek Township Police Department.

Note: You will NOT receive a plate on the day of the event, and you will NOT receive the same plate back from PennDOT. Your old plate must remain on the car until the new plate is sent back to our office. Once a new plate is delivered, owners should replace it immediately. Our office will take the old, damaged plate and return it to PennDOT.
