Burns sponsors largest tax cut for seniors in 20 years

"An additional 3,500 seniors in Cambria County now qualify for Property Tax/Rent Rebate checks – and the maximum rebate is now \$1,000." – Rep. Burns

Always on the lookout to help seniors on fixed incomes, Rep. Burns delivered help by expanding eligibility and increasing amounts returned to them under the state's Property Tax/Rent Rebate Program.

The targeted change Rep. Burns supported benefits those 65 or older, widows and widowers 50 or older, and adults with disabilities who earn less than \$45,000 a year.

To make sure all who qualify get the money, Rep. Burns and his staff host Property Tax/Rent Rebate clinics throughout his district – and offer the same application help at his offices, in person or by calling 814-536-8400 or 814-472-8021.



Burns refuses paycheck until state budget gets passed

Rep. Burns ALWAYS refuses to accept a paycheck until the state budget is passed – and did so again this year.

If you don't get paid until the job is done, Rep. Burns thinks the same standard should apply to state legislators. He's proud to be one of a handful of House members who take that stand – and he's been able to back it up with an official letter of confirmation from the House comptroller.

Burns protects seniors, CONSISTENTLY opposes tax hikes

Seniors living on fixed incomes are especially vulnerable when Harrisburg starts angling for more money, and Rep. Burns always spares them financial agony by voting against higher taxes.

Rep. Burns has an indisputable track record of staunchly saying "No" to power brokers from both parties every time they've tried to strong-arm him into a vote for higher taxes:

- He **refused** to vote for Democratic Gov. Tom Wolf's **higher sales and income taxes**.
- He **refused** to vote for Republican Gov. Tom Corbett's **higher gasoline taxes**.
 - He **refused** to vote for **back-door tax hikes** on tobacco products, income tax on lottery winnings, and downloaded internet data and apps.
- And he refused to saddle taxpayers with \$1.29 billion in debt for capital projects, because he knows borrowed money must be repaid through taxes.

Burns works to LOWER prescription drug costs

Any idea that helps seniors pay less for the medicines they need has Rep. Burns' full support, because he knows what a financial struggle that can be.

That's why Rep. Burns has:

- Supported a mechanism to lower drug prices that included a pathway to drug importation when a drug company refuses to sell medication at the purchasing limit.
- Voted for a reform package to regulate Pharmacy Benefit Managers, who were often pocketing the money they saved by negotiating lower drug prices with pharmaceutical companies.
- Supported change that helps independent and community pharmacies get reimbursed more appropriately for drugs, enabling more of them to stay open and giving seniors more access.

Rep. Burns is sponsoring a bill to end insurer discrimination against Medicare supplement plan enrollees based on a pre-existing medical condition!

Burns offers seniors help applying for PACE/PACENET

With prices on the rise and many seniors on fixed incomes, Rep. Burns knows they will be looking even harder to save money where they can.



One source that could help is the state's

prescription assistance program, known as PACE and PACENET, which assists seniors with paying for their medical prescriptions.

Rep. Burns' offices are always ready to determine if you are eligible – and will even help you apply.

Burns helps speed Property Tax/Rent Rebates to seniors

Noting its strong bipartisan support, Rep. Burns voted for a bill that helped seniors by automatically sending them their property tax or rent rebates.

Rep. Burns then urged the governor to sign the measure into law as quickly as possible so the rebates from the popular state program could be processed immediately.

The bill also allowed school districts to set up programs whereby senior citizens could perform volunteer work to receive a partial credit against their school property taxes.

Burns seeks Property Tax reduction, ways to ease seniors' burden

From introducing legislation that would freeze property taxes for those 65 or older, to advocating that a portion of any state budget surplus be used for additional property tax relief, Rep. Burns has proposed, supported and voted for every viable avenue to lower that burden and keep people from being taxed out of their homes.

Spanning every year of his time in Harrisburg, Rep. Burns' efforts include ensuring that revenue from casino gambling went toward property tax relief – and making sure the state budget has increased funding for the Property Tax/Rent Rebate Program for seniors and disabled individuals.

Rep. Burns has also supported efforts to eliminate property taxes and shares your frustration that even with today's unprecedented state budget surplus, Harrisburg hasn't done more on this front.
