Burns wants State Department to investigate Cambria election snafu

Cambria election fiasco prompts Burns inquiries, action

Legislation would require better voting machine testing

Rep. Burns knows the powers-that-be in Cambria County government are downplaying the massive countywide Nov. 5 voting system failure, which left voters confused, frustrated and wondering about the integrity of the process.

County officials are blaming improperly printed paper ballots, which refused to scan properly, as the culprit. Yet, in information Rep. Burns worked to uncover, all 125 electronic scanners used on Election Day were tested beforehand – and all passed the inspection!

However, when the Cambria County scanners were tested, they were not being fed the actual paper ballots that were going to be used on Election Day.

That seems pretty stupid to Rep. Burns, who has proposed legislation – in line with a PA Department of State recommendation – that would require ALL counties in Pennsylvania to perform pre-election scanner testing using the ACTUAL BALLOTS printed for that specific upcoming election.

Rep. Burns' legislation would also allow observers from the public to witness the testing – and would require the Department of State, which oversees elections in the Commonwealth, to post the certifications of accuracy on its public website.

Firmly established as an elected official who rises above party politics and political labels, Rep. Burns is unafraid to serve as prime Democratic sponsor of a voter ID bill that would fulfill his longstanding commitment to election integrity.


His stance and lead role in this bipartisan effort are not surprising, as Rep. Burns at times in the past has been the only House Democrat to vote in favor of voter ID. To address fears that requiring ID would disenfranchise some voters, Rep. Burns supports provisions to ensure that IDs are accessible to all voters, with free identification options for those who may need them.

Rep. Burns' bedrock view is that we need to have fair, transparent and secure elections – and that starts with making sure EVERY vote cast is legitimate.

Burns urges Trump, McCormick to pare down Johnstown public housing



Rep. Burns wrote the incoming President and Senator letters, asking them to use the weight of their federal offices to get HUD, which funds the bloated JHA operation, to correct the gross imbalance of public housing.

Noting that Johnstown has five times the number of public housing units as other cities its size, and that 80 families per month (mainly from Philadelphia) are moving to Johnstown just to live in public housing, Burns wrote that he is "able and eager" to work with Trump and McCormick to address this matter, "which would greatly benefit our local community."

Dear President-elect Trump,

As state representative for the city of Johnstown, Pa., I offer sincere congratulations on your resounding election victory – and my support for your high priority of eliminating waste and duplication in the federal budget.

I believe your commendable effort at curtailing excessive federal spending could start with the U.S. Department of Housing and Urban Development's bloated funding of the Johnstown Housing Authority at a level that far exceeds our local need for public housing.

Johnstown's population has shrunk considerably since the 1960s, plunging from nearly 54,000 to fewer than 18,000 people, yet HUD inexplicably continues to fund 1,504 public housing units that are no longer justified by true local demand.

It's estimated that HALF of the people living in Johnstown Housing Authority public housing came from outside Cambria County, primarily Philadelphia. News reports have documented that many of them stay in Johnstown public housing just long enough to obtain a Section 8 Program voucher, which they then "port" back home, tapping the Johnstown Housing Authority's federal funds to foot the bill for their subsidized housing in Philadelphia and elsewhere.

HUD allows this gaming of the system to continue, creating a revolving door of poverty, crime and drain on local resources. Our county district attorney and Johnstown school superintendent have both noted its debilitating effects on Johnstown.

Seeing is believing, so Rep. Burns used his clout and seniority in the House to bring Pennsylvania Governor Shapiro to Johnstown for a September tour and firsthand view of the area and its needs. Two months later – and with persistent advocacy from Rep. Burns – the state awarded **\$5.5 million for four big-ticket projects:**



\$2.5 million for construction of a new Johnstown Public Safety Building.



\$1.5 million for the Cambria County War Memorial renovations project, where significant construction work includes a new kitchen, new equipment installation and a parking lot upgrade.



\$1 million for Westmont Hilltop School District school renovations, where the elementary school is getting six additional classrooms, bathroom renovations and new cafeteria flooring; and the junior-senior high school is getting HVAC/ environmental upgrades, a roof restoration, a new exterior door and a new bathroom with exterior access.



\$500,000 for Gallery on Gazebo, to renovate a downtown building to create a center for the arts, including classrooms, offices and rental space.

Burns' seniority, personal touch yield

\$4.1 million for 19 projects

Rep. Burns brought Matthew McCarry, special assistant to the House Majority Leader, to learn firsthand the needs of the district – including this visit with Roxann Tyger, executive director of the Women's Help Center.

The naysayers who think seniority doesn't matter sure got their bubble burst in October, when Rep. Burns announced in one fell swoop a whopping \$4.1 million for 19 projects in his legislative district.

Rep. Burns' personal meetings with officials from many of these municipalities and organizations were a key factor in the following results – many of which prevent local tax hikes:



- (5) 1st Summit Arena \$220,693 to renovate the kitchen and \$100,000 to renovate the parking area.
- S Blacklick Valley Foundation and Ambulance Service \$202,713 for a new ambulance to be used in Nanty Glo.
- (5) Conemaugh Township \$59,499 to purchase a crack sealing trailer to help repair roads, \$150,000 for a new excavator and \$72,861 to replace its 17-year-old Dodge Charger with an all-wheel drive Ford Expedition.
- Gonemaugh Valley Junior-Senior High School \$2 million for HVAC upgrades.
- **East Conemaugh Borough** \$107,805 to purchase an additional maintenance vehicle and replace a high-mileage police vehicle.
- **Section Ebensburg \$52,747** to purchase and install two rapid flashing beacons at the corner of West High and Julian streets for increased pedestrian safety.
- S Hyndman Area Health Center \$242,000 for new medical and dental equipment for its Johnstown office.
- Sackson East Taylor Sewer Authority \$57,500 to replace a damaged portion of sewer main along state Route 271 near Mundy's Corner.

- Solution Johnstown's Women's Help Center \$31,431 to renovate the shelter's bathrooms, boiler and HVAC systems.
- **Solution Lorain Borough \$58,252** for a small excavator for various public works projects in the borough.
- S Lower Yoder Township \$101,268 for the Elk Run culvert rehabilitation project.
- (§) Middle Taylor Township \$25,821 to upgrade the antiquated siren at Middle Taylor Township Volunteer Fire Co.
- Southmont Borough \$324,315 for updates to the municipal building.
- **⑤ Upper Yoder Township \$61,848** to buy a 2024 Ford SUV for the police department.
- **9 Upper Yoder Township Authority \$150,000** for a van and related equipment to aid in the maintenance of the sanitary sewer.
