# **BURNS CONTINUES SUPPORT OF CHILD SEX ABUSE VICTIMS**

Rep. Burns was shocked when a grand jury report revealed widespread child sex abuse and related cover-up in the Altoona-Johnstown Diocese for decades, especially when he learned in retrospect that some of the victims had been his classmates at a local parochial high school.

Convinced that a strong message needs sent to perpetrators of such sadistic crimes, Rep. Burns has steadfastly stood with his colleague, state Rep. Mark Rozzi of Reading (himself a victim of sex abuse at the hands of a priest) and Burns' longtime friend, Shaun Dougherty of Johnstown, who was molested in the Altoona-Johnstown Diocese starting at age 10.

Like they and many others who support a change in the statutes of limitation so victims of these crimes can seek justice retroactively, Rep. Burns was upset that the state Supreme Court interceded to delay public release of a more recent grand jury report that focused on child sex abuse in six other Pennsylvania dioceses.

Rep. Burns believes that the public should not be kept in the dark about these illicit behaviors that took advantage of innocent children.

## Burns supports work requirements for able-bodied medical assistance recipients

Rep. Burns was one of only four House Democrats who recently voted in favor of a bill that would impose work or job-training requirements on many able-bodied, adult medical assistance recipients.

The bill supported by Burns would require either 20 hours a week of work or completion of 12 job training-related activities per month. It passed the House 115-80.

"For every person who gets a free ride in the welfare system, the rest of us end up paying more, which isn't fair." – Rep. Burns.

Burns noted that those who are disabled, younger than 20 or older than 65, pregnant or caring for a child younger than 6 or a disabled person would be among those exempt from the work or job-training requirements.

Burns believes in helping those who truly need it – but he is also keen on weeding out abuse in the welfare system and making sure people aren't allowed to take advantage of it.

# Welfare reform at top of Burns' agenda

Rep. Burns is all for helping those who truly need it – but he draws a hard line at giving your tax dollars to those who make a mockery of the welfare system. That's why he supports these legislative initiatives designed to crack down on fraud and abuse:

**Drug testing for welfare recipients:** Burns supports requiring the state Department of Human Services to test (and retest) public assistance applicants and recipients who are under suspicion of substance abuse. Before they get any of your money, they shouldn't be spending their own cash on drugs.

**Proof of citizenship and proper identification:** Burns supports requirements that any applicant for public assistance be a resident of Pennsylvania and the United States, and that their photograph be displayed on any welfare benefits card.

**Stop cash withdrawals using electronic benefits cards:** Burns wants to prohibit welfare recipients from using their cards to buy tobacco or tobacco products, or to withdraw money at casinos, gambling establishments or adult-oriented entertainment venues.

**No booze purchases or sending money to inmates:** Burns believes in blocking users of welfare electronic benefits cards from using them to buy alcohol or to deposit money into the accounts of prison inmates.

**End double-dipping at the public trough:** Once someone applies for and receives public assistance in Pennsylvania, Burns wants the Department of Human Services to notify all other states where that person previously received such assistance, so that person is cut off in other states.

#### **Burns delivers over** \$1.7 million to district thus far in 2018

Rep. Burns continues having great success in bringing state dollars back into the communities of the 72nd Legislative District. These grants benefit a wide range of projects and in many cases offset the need to use local tax funds. Here's a recap of what he's brought in so far this year:

- \$666,026 to Mount Aloysius College to provide pedestrian access from its campus to the Cresson Business District.
- \$4,000 to the Cambria County Historical Society to enhance and sustain its general operations.
- \$43,144 to Conemaugh Valley School District to purchase a double combination oven at its junior-senior high school.
- \$341,661 to 27 local fire departments and ambulance companies to help them continue their vital, life-saving work.
- \$440,000 to Portage Borough for Phase 2 of its sidewalk improvement project.
- \$268,254 to Cambria County to combat homelessness, including helping homeless veterans.
