## BURNS LEADS CAMBRIA SENIORS IN FIGHT TO RESTORE POPULAR BUS SERVICE DESTINATIONS



Rep. Burns took action when seniors started complaining that the Cambria County Transit Authority had cut

Shared Ride Program bus transportation to several of their favorite destinations back on July 1.

"By eliminating travel to and from several very popular locations that seniors in our region have long enjoyed visiting – such as the Flight 93 National Memorial – CamTran is hampering the quality of life for seniors in Cambria County." – Rep. Burns

Rep. Burns researched the matter, finding out from PennDOT that although the state provides operational funding, local transportation agencies have sole discretion when it comes to setting routes, schedules and destinations.

In short order, Rep. Burns fired off letters to CamTran and the Cambria County commissioners, urging immediate reversal of this controversial decision.

Rep. Burns also wrote an open letter to his constituents, informing them neither his office nor PennDOT were involved in this decision.

# Property Tax/Rent Rebate deadline extended to Dec. 31

Good news! The deadline to apply for a rebate on property taxes or rent paid in 2017 under the state's Property Tax/Rent Rebate Program has been extended to Dec. 31, 2018.

The program benefits eligible Pennsylvanians 65 or older; widows and widowers 50 or older; and people with disabilities 18 or older. The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters. For purposes of calculating income, half of Social Security income is excluded. Spouses, personal representatives or estates may also file rebate claims on behalf of claimants who lived at least one day in 2017 and meet all other eligibility criteria.

The maximum standard rebate is \$650, although supplemental rebates for certain qualifying homeowners can boost rebates to \$975.

You can pick up an application at my office. It costs nothing to apply, and my staff can help you determine if you're eligible and fill out the paperwork. Please bring proof of local (county, borough and school) property taxes and proof of income, such as a 1099 form.

If you've already applied for a rebate, my staff can assist you in checking the status of your rebate. Just give my office a call at 814-472-8021.

If you haven't already done so, I encourage you to check it out and see if you're eligible!

#### REFUSES STATE CAR AND CELL PHONE

# Grandparents raising grandchildren

Kinship caregivers (grandparents and other relatives, 55 or older who are primary caregivers raising children younger than 18) face a variety of emotional, legal and financial challenges.

The National Family Caregiver Support Program helps to relieve the caregiver burden by offering qualified primary caregivers up to \$200 per month in reimbursements for approved out-ofpocket expenses.

#### Under special circumstances,

some kinship caregivers can receive up to \$500 per month in approved reimbursements. If qualified, the program also provides up to \$2,000 in preapproved reimbursements to modify a home or purchase assistive devices or technologies.

Contact your local Area Agency on Aging for additional information on eligibility and to apply for the program. You may also visit the Aging Department website at <u>www.aging.pa.gov</u> for more information about programs to help kinship caregivers.

## **PACE and PACENET program guidelines**

Pennsylvania's prescription assistance programs for older adults, PACE and PACENET, offer low-cost prescription medication to qualified residents, 65 or older. For more information, call 1-800-225-7223.

#### **ELIGIBILITY:**

Social Security Medicare Part B premiums are now excluded from income. This has the same effect as raising the income limits by that amount.

PACE and PACENET eligibility is determined by your previous calendar year's income.

#### PACE

You must be 65 or older.

■ You must be a Pennsylvania resident for at least 90 days prior to the date of application.

You cannot be enrolled in the Department of Human Services' Medicaid prescription benefit.

■ For a single person, total income must be \$14,500 or less.

 For a married couple, combined total income must be \$17,700 or less.

#### PACENET

You must be 65 or older.

■ You must be a Pennsylvania resident for at least 90 days prior to the date of application.

You cannot be enrolled in the Department of Human Services' Medicaid prescription benefit.

PACENET income limits are slightly higher than those for PACE.

■ For a single person, total income can be between \$14,500 and \$23,500.

■ For a married couple, combined total income can be between \$17,700 and \$31,500.
