Dear Neighbor,

Spring is finally here. That means you no longer have to fly down to Florida for nice weather – you can enjoy it here in beautiful Delaware County.

But please know that I am not just out golfing every day. I've been pushing myself and my colleagues in the House to deliver the best results for you, my neighbors in the 162nd Legislative District.

My personal favorite accomplishments this session, passing OSHA protections for public sector workers, such as nurses, firefighters. and police; passing the first COLA (cost-of-living adjustment) for public employee pensions in 23 years; and passing the Working Pennsylvanians Tax Credit. If you're a working person but still with lower or moderate income, you can receive a tax credit of up to 30% of what the Federal EITC gives you. For example, a \$2,000 federal tax credit would result in an additional \$600 tax credit from the state.

Safety, lower cost of living, and a dignified retirement for all workers have always been a high priority for me, both as a legislator and a Teamster.

For the rest of 2025 I have several priorities, as always. One of them is doing all that I can to ensure SEPTA gets all the funding from the commonwealth that it needs to avoid service cuts. Another is a bill I recently introduced that deals with a medication-induced movement disorder called Tardive Dyskinesia. Public education about this disorder is inadequate, so the bill would prompt the Department of Health to supply educational information to providers and the public on the importance of screening and recognizing symptoms, and to develop clinical guidance for treatment.

Thank you for your support. Whether I'm on the House floor or at the negotiation table, I am always working for you. NEW LAW ON CELL PHONE USE WHILE DRIVING NOW IN EFFECT

PA's new distracted driving law went into effect on June 5. Known as Paul Miller's Law, it prohibits drivers from using interactive mobile devices while operating a vehicle – even when stopped at traffic lights – in an effort to reduce accidents caused by distracted driving.

Here's what you need to know:

What's banned: Holding or supporting a phone or other device with any part of your body while driving. This includes texting, browsing, or dialing unless it's a single-button press.

What's allowed: Using hands-free technology like Bluetooth or dashboard mounts for calls, navigation, or music. Emergency calls to 911 are also permitted.

Enforcement: Starting June 5, 2026, a first offense will carry a \$50 fine, plus court costs and fees.
