VACCINE ASSISTANCE FOR SENIORS

Older adults in Philadelphia can call the city's COVID-19 hotline for help setting up an appointment to receive the COVID-19 vaccine.

Residents 60 and older can call 1-800-424-4351, Monday – Friday, 8:30 a.m. to 5 p.m.

The city also offers a homebound vaccination program, where homebound individuals or anyone with a disability preventing them from going to a clinic can receive the vaccine at their house.

PA RESCUE PLAN

We have a plan to invest in our families and communities so we come out of this pandemic even stronger. The PA General Assembly received \$7 billion from the federal government through the American Rescue Plan and we propose investing that money to:

- Raise the minimum wage.
- Provide hazard pay and paid sick leave to working families.
- Fully fund every public school.
- Remove and remediate all toxic hazards from school buildings.
- Fund high quality childcare.

This fall, I am continuing to push for these federal relief dollars to be invested right here in South Philadelphia through the Pennsylvania Rescue Plan. We can:

- Create grant opportunities for local businesses.
- Ensure stable and affordable housing.
- Make quality, reliable Internet affordable and accessible to everyone.



SECURING \$30 MILLION TO COMBAT GUN VIOLENCE

With Philadelphia on track to have its deadliest year on record for gun violence and gun deaths, my colleagues and I worked tirelessly to secure \$30 million in this year's state budget to reduce gun violence.

The funding will support Community Violence Prevention Grants for neighborhood-based programs that are committed to preventing gun violence.

Our hearts remain with the families of every victim of this public health crisis.

GUN BUYBACK

APPLY NOW FOR PROPERTY TAX OR RENT RELIEF

Applications are being accepted for rebates on property taxes or rent paid in 2020. If you already filled out your application earlier this year, there is no need to reapply. If you are still waiting for your rebate check, contact our office and we can assist you in getting a status update.

The Property Tax/Rent Rebate Program is open to individuals 65 or older; widows and widowers 50 and older; and people with disabilities 18 or older.

The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters, and half of Social Security income is excluded.

Spouses, personal representatives, or estates may also file rebate claims on behalf of claimants who lived at least one day in 2020 and meet all other eligibility criteria.

My office can find out if you're eligible and help you apply before the Dec. 31, 2021 deadline.
