A. Brief Concept

Directs the Legislative Budget and Finance Committee to review the Philadelphia Tobacco Policy and Control Program's investigations of tobacco outlets.

C. Analysis of the Bill

House Resolution 244 directs the Legislative Budget and Finance Committee to conduct a performance audit of the Philadelphia Department of Public Health's Tobacco Policy and Control Program.

The Resolution states:

- The Tobacco Policy and Control Program works to lower smoking rates and increase smoke-free areas in the city.
- The program enforces rules that limit smoking and who can buy tobacco products.
- In fiscal year 2024, Philadelphia received \$408,645 in state funding for the Tobacco Policy and Control Program through the Comprehensive Tobacco Control Program Grant.
- The Comprehensive Tobacco Control Program Grant aims to prevent tobacco-related health problems through prevention, quitting programs, public awareness, and other services.
- The Tobacco Policy and Control Program conducts investigations to ensure tobacco laws are enforced consistently.
- Some have raised concerns that these investigations are not being done consistently.
- The Legislative Budget and Finance Committee can review the program's performance because it is funded by a state grant.

The Resolution therefore requires the Legislative Budget and Finance Committee to:

- to audit the Philadelphia Department of Public Health's Tobacco Policy and Control Program, focusing on investigations of tobacco outlets in the city.
- review the program's performance measures and goals; and
- report its findings to the House within 18 months of the resolution's adoption.

G. Relevant Existing Laws

Act 195 of 1959 establishes the Legislative Budget and Finance Committee and has the power to study state expenditures.

Act 77 of 2001 created Pennsylvania's tobacco control program, requiring 70% of funds for local CDC-based programs and 30% for statewide initiatives such as the Quitline, youth prevention, evaluation, and media (with no more than half of that spent on media), and it mandates an annual Department of Health report on efforts to reduce tobacco use.

Act 112 of 2002 created new fines for clerks and owners of tobacco retail stores and prohibitions on selling to individuals under 18.

2019 Act 111 of 2019 prohibits the sale of any tobacco, nicotine or related item to anyone under 21 years of age.

The Clean Indoor Air Act of 2008 regulates tobacco smoking in certain public places.

E. Prior Session (Previous Bill Numbers & House/Senate Votes)

HR 54 of 2023 was referred to the House Health Committee, where it received no further consideration.

HR 203 of 2021 was referred to the House Health Committee, where it received no further consideration.

A RESOLUTION

Directing the Legislative Budget and Finance Committee to conduct a performance audit of the Philadelphia Department of Public Health's Tobacco Policy and Control Program as it 2 3 relates to the investigations of tobacco outlets in the city. 4 5 WHEREAS, The Philadelphia Department of Public Health 6 established the Tobacco Policy and Control Program to address tobacco use and its health implications; and 8 WHEREAS, The goal of the Tobacco Policy and Control Program 9 is to reduce smoking rates and expand smoke-free environments 10 throughout the city; and 11 WHEREAS, The Tobacco Policy and Control Program enforces 12 policies that restrict smoking and restrict those who can buy 13 tobacco products; and 14 WHEREAS, For the City of Philadelphia's fiscal year 2024, 15 \$408,645 of State funding was specifically allocated toward the 16 Comprehensive Tobacco Control Program Grant designated for the 17 Tobacco Policy and Control Program; and 18 WHEREAS, The purpose of the Comprehensive Tobacco Control

Program Grant is to reduce health complications related to

- 1 tobacco use through prevention, cessation, community-based
- 2 public awareness and other services and initiatives; and
- 3 WHEREAS, The Tobacco Policy and Control Program helps to
- 4 conduct investigations to ensure that tobacco restrictions are
- 5 systematically and uniformly enforced; and
- 6 WHEREAS, However, concerns have been expressed that the
- 7 investigations are not being conducted in a systematic and
- 8 uniform manner; and
- 9 WHEREAS, The Legislative Budget and Finance Committee has the
- 10 authority to conduct a performance review of the Tobacco Policy
- 11 and Control Program due to the program's funding through a State
- 12 grant; therefore be it
- 13 RESOLVED, That the House of Representatives direct the
- 14 Legislative Budget and Finance Committee to conduct a
- 15 performance audit of the Philadelphia Department of Public
- 16 Health's Tobacco Policy and Control Program as it relates to the
- 17 investigations of tobacco outlets in the city; and be it further
- 18 RESOLVED, That the audit include a review of the performance
- 19 measures and objectives of the Tobacco Policy and Control
- 20 Program; and be it further
- 21 RESOLVED, That the Legislative Budget and Finance Committee
- 22 report its findings and conclusions to the House of
- 23 Representatives within 18 months of the adoption of this
- 24 resolution.

A. Brief Concept

Requires the Joint State Government Committee to study perimenopause and menopause policies.

C. Analysis of the Bill

House Resolution 287 directs the Joint State Government Committee to study policies regarding perimenopause and menopause.

Specifically, it requires the committee to review:

- menopause and perimenopause education and awareness policies in both public and private sector workplaces;
- workplace policies, such as reasonable accommodations, paid leave and other supports for employees experiencing perimenopause-related and menopause-related symptoms;
- Recommendations for how state agencies can support women during perimenopause and menopause;
- Recommendations for how the House of Representatives could help improve public awareness and support for women during perimenopause and menopause.

The Joint State Government must issue a report to the General Assembly within 18 months of the adoption of this legislation.

A RESOLUTION

Directing the Joint State Government Commission to conduct a 1 study and issue a report on workplace policies related to 2 perimenopause and menopause offered by public and private 3 employers. 5 WHEREAS, Menopause is defined as the point at which a woman has not menstruated for a continuous period of 12 months, with 6 the transitional period leading to menopause commonly referred 7 to as perimenopause; and 8 9 WHEREAS, Perimenopause and menopause are frequently 10 associated with symptoms that may include weight gain, joint and muscle pain, cognitive impairment often described as brain fog, 11 increased risk of depression and anxiety, hot flashes, night 12 sweats, sleep disturbances, changes in sexual function, bone 13 loss, fluctuations in cholesterol levels and vaginal and urinary 14 15 tract complications; and 16 WHEREAS, In the United States, approximately 1.3 million

women enter menopause annually, with the average age of onset at

51 years of age; and

- 1 WHEREAS, The symptoms associated with perimenopause and
- 2 menopause may result in absenteeism, reduced workplace
- 3 productivity and increased health care costs, with economic
- 4 estimates indicating that lost productivity and medical expenses
- 5 related to these symptoms total approximately \$26.6 billion per
- 6 year nationwide; and
- 7 WHEREAS, Treatment options for perimenopausal and menopausal
- 8 symptoms may include hormone replacement therapy, prescription
- 9 medications and dietary or lifestyle modifications, yet many
- 10 women remain unaware of the available interventions; and
- 11 WHEREAS, A study conducted by the American Association of
- 12 Retired Persons found that only approximately 61% of women in
- 13 the perimenopausal stage felt knowledgeable about menopause; and
- 14 WHEREAS, The same study indicated that more than half of the
- 15 women surveyed believed there should be greater focus on
- 16 menopause education and women's health generally; and
- 17 WHEREAS, The House of Representatives is committed to
- 18 advancing the health and well-being of women in this
- 19 Commonwealth and ensuring that accurate, accessible information
- 20 concerning perimenopause and menopause is widely disseminated
- 21 and promoted; therefore be it
- 22 RESOLVED, That the House of Representatives direct the Joint
- 23 State Government Commission to conduct a study and issue a
- 24 report on workplace policies related to perimenopause and
- 25 menopause offered by public and private employers; and be it
- 26 further
- 27 RESOLVED, That the study include the following components:
- 28 (1) An examination of existing perimenopause-related and
- 29 menopause-related education and awareness policies in both
- 30 public and private sector workplaces.

- 1 (2) A review of workplace policies related to
 2 perimenopause and menopause, including policies concerning
 3 reasonable accommodations, paid leave and other supports for
 4 employees experiencing perimenopause-related and menopause-
- 6 (3) Recommendations for actions that the Department of
 7 Human Services, the Department of Health or other appropriate
 8 State agencies may implement to support women during the
 9 perimenopausal and menopausal life stages.
