  The General Assembly of the Commonwealth of Pennsylvania
  hereby enacts as follows:
- 6 Section 1. Legislative findings.
- 7 The General Assembly hereby finds and declares as follows:
- 8 (1) Rosh Hashanah, the Jewish New Year, marks the
  9 beginning of the High Holidays and signifies a time for
  10 reflection and celebration.
- 11 (2) Yom Kippur, the Day of Atonement, is the holiest day
- in Judaism, representing the apex of the High Holidays
- season, and is dedicated to prayer, fasting and
- 14 introspection.
- 15 (3) Eid al-Fitr, the Festival of Breaking the Fast,
- 16 commemorates the end of Ramadan, a month of fasting for
- 17 Muslims, and is celebrated with prayers, feasts and acts of

- 1 charity.
- 2 (4) Eid al-Adha, the Festival of Sacrifice, is
- 3 considered one of holiest holidays in the Islamic calendar
- 4 and is similarly celebrated through prayers and acts of

- 6 (5) This Commonwealth was founded on the principles of
- 7 religious freedom and tolerance, and these holidays,
- 8 celebrated by many Pennsylvanians, deserve official

- 11 (a) Jewish tradition. -- In accordance with longstanding

### A. Brief Concept

Provides for the annual designations and holiday observances of Rosh Hashanah, Yom Kippur, Fid al-Fitr and Fid al-Adha in the Commonwealth.

### C. Analysis of the Bill

This legislation would provide for the annual designations and holiday observances of the following:

In accordance with longstanding Jewish tradition:

- The secular calendar date coinciding with the first day of the Hebrew month of Tishri in any given year would be designated as the beginning of Rosh Hashanah in the Commonwealth.
- The secular calendar date coinciding with the tenth day of the Hebrew month of Tishri would be designated as the observance of Yom Kippur in the Commonwealth.

In accordance with longstanding Islamic tradition:

- The first day of the Islamic month of Shawwal would be designated as the beginning of Eid al-Fitr in the Commonwealth.
- The tenth day of the Islamic month of Dhu al-Hijjah would be designated as the beginning of Eid al-Adha in the Commonwealth.

An employer would not be required to treat a day designated above as a legal or official holiday or to provide paid leave to an employee on a day designated above solely by virtue of the date being designated in this legislation.

#### **Effective Date:**

This legislation would take effect immediately.

### G. Relevant Existing Laws

Act No.138 of 1893 designates state holidays in the Commonwealth, including Dr. Martin Luther King, Jr. Day, Presidents' Day, Good Friday, Memorial Day, Flag Day, Independence Day, Labor Day, Columbus Day, Election Day, Veterans' Day, Thanksgiving Day, and Christmas Day.

<u>Title 38 (Holidays and Observances) of the Pennsylvania Consolidated Statutes</u>, provides for the observance of Persian Gulf War Veterans Day, Global War on Terrorism Veterans Day, Women Veterans Day, Tuskegee Airmen Commemoration Day, and First Responders Day.

### E. Prior Session (Previous Bill Numbers & House/Senate Votes)

No single bill from last session would have designated this specific group of holidays.

### A. Brief Concept

Sponsor:

Requires trustees, board members, appointed or elected officials who stand in a fiduciary relationship to the members and beneficiaries of a State fund or a public pension system fund to complete training in fiduciary law.

### C. Analysis of the Bill

This legislation would amend Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes to require training of certain State fiduciaries as follows:

An individual who becomes a State fiduciary after the effective date of this legislation would be required to complete two hours of training within one year and one hour of training annually each year thereafter. An individual who is already a State fiduciary on the effective date would only be required to complete one hour of training annually.

State fiduciary is defined in this bill as a trustee, board member or other appointed or elected official, or a designee thereof, who stands in a fiduciary relationship to the members and beneficiaries of a State fund or a fund of a public pension system.

Training completed by an individual who is a board member of PSERS or SERS could be applied towards the individual's 10 hours of mandatory training in investment strategies, actuarial cost analysis, asset allocations, risk assessment, and retirement portfolio management on an annual basis as required by current law.

Annual training would be required to cover updates and case studies related to the following four topics required by the initial training:

- · The definition of fiduciary.
- · Conflicts of interest.
- The prudent expert standard.
- Self-dealing.

A State fiduciary would be entitled to payment of legal fees unless their conduct was found by a court to constitute a criminal offense, willful misconduct, or self-dealing.

#### **Effective Date:**

This legislation would take effect December 31, 2025, or immediately, whichever is later.

### G. Relevant Existing Laws

<u>Title 20 (Decedents, Estates and Fiduciaries)</u> of the Pennsylvania Consolidated Statutes provides for the administration of decedents' estates, the regulation of wills, powers of attorney, fiduciaries, and the governance of guardianships.

<u>Section 8501(f) of the Public School Employees' Retirement Code in Title 24 (Education)</u> of the Pennsylvania Consolidated Statutes requires each member of the board to obtain 10 hours of

mandatory training in investment strategies, actuarial cost analysis, asset allocation, risk assessment and retirement portfolio management on an annual basis.

<u>Section 5901(f) of the State Employees' Retirement Code in Title 71 (State Government)</u> of the Pennsylvania Consolidated Statutes requires each member of the board to obtain 10 hours of mandatory training in investment strategies, actuarial cost analysis, asset allocation, risk assessment and retirement portfolio management on an annual basis.

### E. Prior Session (Previous Bill Numbers & House/Senate Votes)

### 2023-2024 Session:

House Bill 1496 (Fink) was referred to the House State Government Committee on June 22, 2023. No further action was taken.

House Bill 1460 (Mullins) was referred to the House Finance Committee on June 21, 2023. No further action was taken.

#### 2021-2022 Session:

House Bill 2010 (Ryan) passed the House on June 21, 2022, with a vote of 200-0 and was then referred to the Senate Finance Committee on June 24, 2022. It was not brought up for consideration in the Senate.

Dear Chairman Harris:

This letter responds to your request of September 19, 2025 concerning an actuarial note for House Bill 1322, Printer's Number 1514. The bill would amend Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes to update training requirements for fiduciaries of public pension systems and State funds. The bill defines public pension systems as the Public School Employees' Retirement System (PSERS), State Employees' Retirement System (SERS), the Pennsylvania Municipal Retirement System (PMRS) and any pension plan maintained by a municipality or a county. A State fund is defined as a fund or account in the State Treasury or under the care, custody or control of a Commonwealth agency. Individuals appointed or elected to a qualified position after the effective date shall be required to complete two hours of training in fiduciary law within one year of the date of appointment, and one hour annually each year thereafter. For those appointed prior to the effective date of the bill, the initial two-hour requirement is not applicable.

The bill also allows for the payment of reasonably incurred legal expenses of a State fiduciary while defending a threatened, pending or completed legal action against the State fiduciary in the individual's capacity as a trustee, board member or other qualified position. Those payments would be prohibited if a court of competent jurisdiction finds that the individual's conduct constituted a criminal offense, willful misconduct or self-dealing. The legislation is effective December 31, 2025 or immediately upon enactment, whichever is later.

Under section 615-B of the Administrative Code of 1929, the Independent Fiscal Office (IFO) reviews legislative changes that could affect public employee pension or retirement plans and provides actuarial notes for such legislation. The IFO determined that the actuarial cost impact from House Bill 1322, Printer's Number 1514 is not material, and further actuarial analysis is not required. The office reviewed the legislation for actuarial cost impact only, and not for potential legal, administrative or policy implications.

#### A RESOLUTION

- Designating October 9, 2025, as "Mary Ann Shadd Cary Day" in Pennsylvania.
- 3 WHEREAS, Mary Ann Shadd Cary was an abolitionist, educator
- 4 and lawyer who was born in Wilmington, Delaware, on October 9,
- 5 1823; and
- 6 WHEREAS, Shadd Cary helped establish schools for Black youths
- 7 in multiple cities and taught in New York City, as well as West
- 8 Chester and Norristown, Pennsylvania; and
- 9 WHEREAS, During her lifetime, Shadd Cary helped enslaved
- 10 people escape slavery through the Underground Railroad; and
- 11 WHEREAS, After the passage of the 1850 Fugitive Slave Law,
- 12 which made it illegal for anyone to help enslaved persons escape
- 13 slavery, Shadd Cary moved to Ontario, Canada, but she remained
- 14 an important activist for abolition in America; and
- 15 WHEREAS, In 1853, Mary Ann Shadd Cary became the first Black
- 16 female newspaper publisher in North America when she founded The
- 17 Provincial Freeman; and
- 18 WHEREAS, The Provincial Freeman was an antislavery newspaper

- 1 with the motto "self-reliance is the true road to independence"
- 2 that publicized the successes of formerly enslaved persons and
- 3 encouraged Black Americans to insist on equal treatment and for
- 4 slaves to travel north for freedom; and
- 5 WHEREAS, Shadd Cary personally smuggled copies of The
- 6 Provincial Freeman into the United States so that the paper's
- 7 message could be spread as far as possible; and
- 8 WHEREAS, Shadd Cary was an important advocate within the
- 9 anti-slavery movement who, in her fight for equality in society,
- 10 demanded action from her peers, such as Frederick Douglass; and
- 11 WHEREAS, Throughout the 1850s, Shadd Cary toured the United
- 12 States, speaking not only for the end of slavery but for full
- 13 legal, economic and social equality for all Black Americans; and
- 14 WHEREAS, In 1874, Shadd Cary advocated for women's suffrage
- 15 as she addressed the Congress of the United States on her
- 16 support for the right for women to vote; and
- 17 WHEREAS, Throughout her life, Shadd Cary was a strong female
- 18 leader who helped break down barriers in her world, and the
- 19 change she fought for continues to persist to this day;
- 20 therefore be it
- 21 RESOLVED, That the House of Representatives designate October
- 22 9, 2025, as "Mary Ann Shadd Cary Day" in Pennsylvania; and be it

Designates October 9, 2025, as "Mary Ann Shadd Cary Day" in Pennsylvania.

### C. Analysis of the Bill

This resolution would call upon the House of Representatives to designate October 9, 2025, as "Mary Ann Shadd Cary Day" in Pennsylvania.

According to the resolution, Mary Ann Shadd Cary was an abolitionist, educator, and lawyer who helped break down barriers in her world and fought for justice and equality. Shadd Cary helped establish schools for Black youths in multiple cities and taught in New York City, as well as West Chester and Norristown, Pennsylvania. Throughout the late 1800s, she toured the United States speaking not only for the end of slavery, but for full legal, economic, and social equality for all Black Americans, in addition to advocating for women's suffrage.

As such, this resolution would honor the life and accomplishments of Mary Ann Shadd Cary and recognize that the change she fought for continues to persist to this day.

### **Effective Date:**

### A. Brief Concept

Authorizes the release of Project 70 restrictions on land owned by the Pennsylvania Turnpike Commission, in exchange for the imposition of Project 70 restrictions on land owned by the Borough of West Mifflin. Authorizes the Department of General Services (DGS), with notice to the Department of Conservation and Natural Resources (DCNR), to grant and convey to the White Birch Golf Course and Restaurant a parcel of State park land in Rush Township, Schuylkill County for \$1.

### C. Analysis of the Bill

### **Borough of West Mifflin, Allegheny County**

This legislation would authorize the release of Project 70 restrictions on land owned by the Pennsylvania Turnpike Commission, formerly owned by the Borough of West Mifflin, Allegheny County, in exchange for the imposition of Project 70 restrictions on other land owned by the Borough of West Mifflin.

It would allow the Pennsylvania Turnpike Commission to have Project 70 restrictions transferred from specified land in order to construct the Mon-Fayette Expressway Project. The impacted properties are both located in West Mifflin Borough.

The impacted Project 70 properties would be:

- Fleetwood Drive Playground: Approximately 25 acres acquired for the Project, and an additional 19 acres of property acquired that will be land locked by construction of the Project.
- West Mifflin Community Park: Approximately 3 acres acquired for the Project.

West Mifflin has agreed to accept ownership of 28 acres of property along Camp Hollow Road as mitigation for the Project 70 impacts.

### Rush Township, Schuylkill County

The bill would also authorize DGS, with notice to DCNR, to grant and convey to the White Birch Golf Course and Restaurant approximately 500 feet by 100 feet of land, together with improvements thereon, part of State park land in Tuscarora State Park in Rush Township, Schuylkill County for \$1.

An appraisal has not been conducted for this property as the property is not considered surplus Commonwealth property. The property is part of state park land and is under the jurisdiction of DCNR.

The proceeds from the conveyance (one dollar) would be deposited into a fund under the jurisdiction of, and as prescribed by, DCNR.

#### **Effective Date:**

This legislation would take effect immediately.

#### **G. Relevant Existing Laws**

The Project 70 Land Acquisition and Borrowing Act (Act 8 of 1964/1) authorized the Commonwealth to issue bonds for use by municipalities for the purchase of land for parks and public recreational use. Section 20 (b) requires that the General Assembly approve other proposed uses of Project 70 land.

<u>Section 514 (a) of Act No. 175 of 1929, known as the Administrative Code</u>, requires legislative authorization for the conveyance of, easement of, or right-of-way to Commonwealth land.

<u>PA House of Representatives Rule 32</u> requires that all land conveyance bills, before being considered by a House committee and reported to the House Floor or an amendment making substantive changes to such a bill be offered on the floor of the House, have a memorandum from DGS, which indicates the present and proposed use of the property, consideration for the transfer, and the appraised value of the property.

### E. Prior Session (Previous Bill Numbers & House/Senate Votes)

There was no similar legislation to the West Mifflin, Allegheny County portion of the bill.

The Rush Township, Schuylkill County portion of the bill is similar, but not identical, to Senate Bill 1235. That bill had third consideration and final passage in the Senate October 8, 2024, with a 28 to 22 vote. It was referred to the House State Government on October 9, 2024. The bill was not brought up for consideration by the House committee.
