## REAL ID Update

Beginning **May 3, 2023**, Pennsylvanians will need a REAL ID-compliant driver's license, photo ID card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic commercial flight or enter a federal building or military installation that requires ID.

While REAL ID is optional for Pennsylvania residents, you will need an alternate form of federally acceptable identification (valid passport, military ID, etc.) to board domestic commercial flights and enter certain federal facilities after May 3, 2023.

My district office does not issue REAL ID cards, but we are happy to answer any questions you may have regarding the process.

# NEW LEGISLATION

## COMBATING TEACHER AND SOCIAL WORKER SHORTAGES

Aspiring teachers and social workers must complete field placements, such as internships or student teaching. These positions are rarely paid, causing many to postpone or abandon their ambitions.

Teachers and social workers are vital to society, being responsible for the education, safety, and well-being of our children and our future, which is why I introduced a resolution directing the Joint State Government Committee to study the feasibility of paying individuals for their field placements, internships, and student teaching. This study should provide insight into the challenges prospective teachers and social workers face without paid training, as well as examine what forms of payment might be most appropriate, from wages to tuition reimbursement.

We can no longer ignore staffing shortages in such important professions.

## STREAMLINING UNCONTESTED DIVORCES

Divorce in Pennsylvania is a lengthy and costly process. PA law requires a 90-day waiting period after filing, even for uncontested divorces, and year-plus waiting periods often result due to the overburdening of the courts. Furthermore, exorbitant fees make Pennsylvania one of the most expensive states for a divorce.

For this reason, I am introducing legislation to remove the 90-day waiting period and permit Magisterial District Courts or Philadelphia Municipal Court to hear uncontested divorces. Removing the waiting period and transferring uncontested divorces to a court system with approximately 80 additional judges will expedite uncontested divorces. Additionally, a faster divorce process reduces the uncertainty and financial strain on those involved.

There is no good reason to burden the parties with mandatory or de facto waiting periods for a matter that is uncontested in the first place. Pennsylvanians deserve a faster and more affordable uncontested divorce process.

# RECENTLY SIGNED INTO LAW

Over the past few months, the General Assembly has worked with the Governor to pass a number of important pieces of legislation, including:

**House Bill 245** reduces the clinical residency requirement from three years to two for applicants who have graduated from international medical schools and expands the actions a temporary licensee is allowed to perform.

**Senate Bill 1020** authorizes the conveyance of 4.191 acres of vacant land which is currently a portion of Swatara State Park in Union Township, Lebanon County, to Kyle and Tamara Boltz. As consideration for the conveyance, the Boltzes will convey 11.908 acres of vacant land to the Commonwealth to be added to the Swatara State Park. In addition, the bill authorizes the conveyance of 8.7190 acres of vacant land in Whitemarsh and Springfield townships, Montgomery County, to Erdenheim Farm. As consideration for the conveyance, Erdenheim Farm

will convey a tract of land containing 10.568 acres of vacant land to the Commonwealth to be added to the Marsh Creek State Park.

**House Bill 221** removes language that limits local governments from maintaining open space unless it was acquired under the January 19, 1968, act entitled "An act authorizing the Commonwealth of Pennsylvania and the local government units thereof of preserve, acquire or hold land for open space uses."

**Senate Bill 739** appropriates \$25 million in American Rescue Plan Act funding to support Pennsylvania's emergency medical services (EMS) companies.

# Budget Update

As we move into budget season, I continue working tirelessly to ensure we get everything we need and deserve, both in the 167th District and across the Commonwealth, including our remaining American Rescue Plan Act funds, which must be allocated by the end of 2024.

# Conservation Corner

The Eastern whip-poor-will (*Antrostomus vociferus*) is one of the several species of nightjar birds traditionally found in Pennsylvania. The whip-poor-will, a camouflaged and nocturnal bird, is generally heard and not seen. The whip-poor-will's distinctive call is the source of its unusual name, and has entered the popular imagination, from the stories of Washington Irving to Elton John's "Philadelphia Freedom."

Unfortunately, its song is heard less and less. The whip-poor-will – and nightjars generally – are in decline. The reasons are debated, though some of the more common theories include excessive insecticide use, predation by cats and dogs, and the gradual loss of habitat. The whip-poor-will nests in forests while it hunts in more open areas, and fewer places have this combination readily available, underscoring the need to protect both our open spaces and forests. ## Property Tax/Rent Rebate

The Property Tax/Rent Rebate Program benefits eligible Pennsylvanians aged 65 and older; widows and widowers aged 50 and older; and people with disabilities aged 18 and older. The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters, and half of Social Security income is excluded. Spouses, personal representatives or estates may also file rebate claims on behalf of claimants who lived at least one day in 2021 and meet all other eligibility criteria. **Did you know that the Pennsylvania Treasury is currently holding onto \$3.5 billion in unclaimed property?**

My office is hard at work trying to notify constituents of their unclaimed property, but you don't have to wait for us to reach out: you can search the Treasury's online database at any time to see if you or friends and family have property waiting to be claimed.
