Dear Neighbor,

Since January, we have passed over 150 bills in the Pennsylvania House of Representatives, many of which earned bipartisan support in our chamber. It has been an honor to vote for bills that address many of the issues that our neighbors care about.

This year we passed legislation to raise the minimum wage, address gun violence, expand tax credits for child care, provide accountability for cyber charter schools, improve hospital staffing, increase property tax rebates for seniors, and fund 911 call centers.

All of these bills are now awaiting action in the Senate. I'm hoping the Senate will act soon to send them to the Governor's desk.

This year I have voted to:

- Raise the minimum wage.
- Fund our schools.
- Get more teachers on the job.
- Expand property tax rent rebates for 173,000 seniors.
- Increase support for youth and adults facing mental illness.
- Help survivors of childhood sex abuse get justice.
- Help people who paid their debt to society get an easier path back to the community.
- Protect the right to join a union.
- Deliver safer workplaces.
- Help working parents afford child care.
- Fight discrimination and make sure "We, the People" means *all* the people.

I will continue to reach across the aisle and put people ahead of politics – because better jobs, better schools and better communities benefit everyone.

As we get closer to the start of a new school year, it is up to us to **Keep Kids Safe!** If you plan to apply for employment in public or private schools, are an employee of independent contractor seeking business with a school, are a student teacher, or volunteer at your kids' school, you will need to undergo a background check in order to have direct contact with students. KEEP KIDS SAFE

Pennsylvania School Law requires that all applicants for employment in public and private schools, employees of independent contractors seeking business with public and private schools, and student teacher candidates undergo background checks if they will have direct contact with students.

In addition to employment history reviews, the following background checks are required:

- Department of Human Services Child Abuse History Clearance
- Pennsylvania State Police Request for Criminal Records Check
- Federal Criminal History Record Information (CHRI)

Protecting Access to Contraceptives in PA

For 4 years, I have been working on a bill to expand birth control access in PA. Recently we have seen access to birth control threatened by federal judges, so it is time to enshrine protections for birth control in state law. The Supreme Court granted employers exemptions from Affordable Care Act mandates for birth control if they object due to religious or moral values. Two federal judges recently ruled on the continued access to a medication for miscarriage care, endangering the health and economic security of 2.5 million Pennsylvania women who rely on employer-funded coverage.

May was Women's Health Month, and that month I invited the PA Democratic Policy Committee to Delaware County for a hearing on HB 1140, my bill to expand and protect access to contraceptives in PA. Testifiers included Planned Parenthood Pennsylvania Advocates Executive Director Signe Espinoza; Penn Medicine's and Complex Family Planning Fellow Dr. Blythe Bynum; AccessMatters President and CEO Melissa Weiler Gerber; University of Penn assistant professor of obstetrics and gynecology Dr. Alhambra Frarey; and Women's Law Project managing attorney Terry Fromson.

HB 1140 was referred to the Insurance Committee, and I'm determined to get an affirmative House vote on this bill this session!

Lt. Governor Davis Visits DCTS in Aston

It was an honor to host Lt. Governor Austin Davis in Aston Township for a tour of the Delaware County Technical School and conversation about investing in career and technical education.

Governor Shapiro recently signed an Executive Order to expand workforce development, spur economic growth and create new jobs in PA.

The Shapiro-Davis Administration is committed to increasing funding to build partnerships among career and technical education and industries, trades, and entities that need highly skilled workers. They plan to invest more into apprenticeship programs, expand vo-tech and bring career and technical training back into the classroom, give students the freedom to chart their own course, and prepare them for the future.

I visited Woodlyn Volunteer Fire Company and met with Assistant Chief Shane Ryder and Jeremiah to learn about their EMS program and company needs.



In May, I attended the Delaware County Law Enforcement Memorial Foundation's 25th annual Day of Remembrance Ceremony to honor local police officers who lost their lives in the line of duty.



Some things take time. Four years ago, I worked with Mrs. Knight's fourth grade class at Wallingford Elementary School to advocate for a "Skip the Straw Day" in PA to address plastic pollution's impact on ocean animals. This June, their proposed resolution for a Skip the Straw resolution finally passed the House!



My office teamed up with the Brookhaven and Aston police departments to offer free License Plate Restoration service events in July. We assisted over 60 constituents with this service.
