Legislation Update

I'm honored to be your voice in Harrisburg, taking your concerns and issues to the Capitol and working with my colleagues to find solutions so that every Pennsylvanian can prosper. The following is a small sample of legislation I've sponsored this session that is pending before committees (additional bill information is updated at RepMcNeill.com):

House Bill 838

It's time we know what the big gas companies know, and that's why I'm proud to cosponsor legislation with Rep. Dan Miller that adopts the recommendation from state Attorney General Josh Shapiro that all chemicals in the natural gas fracking process in the commonwealth be disclosed 14 days before use at any stage of the process, including drilling.

It's not too much to ask that a Pennsylvania resident have clean drinking water, nor is it too much to provide our communities insight into what's being trucked through their neighborhoods.

House Bill 460

Working with Rep. Mike Zabel, I reintroduced legislation aimed at capping out-of-pocket prescription insulin prices at \$100 per month.

Sadly, so many people are still struggling to pay for their insulin. There is no reason that people should have to make a choice to forgo food, consider traveling to Canada or turn to the black market to get financial relief from the costs of being insulin-dependent.

It is important that this issue be addressed, especially considering the impact of the ongoing COVID-19 pandemic and the additional financial burdens it is placing on Pennsylvanians.

House Bill 458


Ensuring a child's K-12 educational experience isn't abruptly stopped or disrupted in the event of a residency issue is extremely important, and that's why I introduced legislation

\$1 Million Awarded for Airport Improvements

The Lehigh-Northampton Airport Authority has been awarded a \$1 million state Redevelopment Assistance Capital Program grant. The grant will be used for the terminal expansion at Lehigh Valley International Airport for the security checkpoint and terminal connector project.

This funding will help the airport authority improve the movement and flow in the airport, as well as enhance safety and security by enlarging the terminal and updating the TSA screening area to meet TSA standards. The changes should result in an overall improved passenger experience. This expansion project is greatly needed, and I was glad to help the authority receive this funding.

to maintain continuity in education so that our children aren't left in limbo while disputes are being resolved amongst adults.

Often, residency disputes between school districts can take weeks or more to be fully resolved. As a result, the child suffers.

This legislation seeks to provide protection for children in the event of a residency dispute. Under my bill, a school district would not be permitted to remove a child from school until the dispute has been fully resolved and it has been determined which school district should correctly enroll the child.

House Bill 633

I co-sponsored legislation that would allow patients to register themselves and their families for the COVID-19 vaccine via a statewide database of available appointments.

It's time that we do something that will end the frustration and better streamline the vaccine distribution effort. I've heard from so many people who either don't have a computer or began the registration process only to reach the end and have that initial appointment gone. In some cases, people are getting up in the middle of the night to try and make appointments for themselves, or those without the technology.

House Bill 485

I introduced legislation that would update who can legally officiate marriages in the commonwealth, effectively ending the question of legality regarding marriages officiated by someone ordained online.

Marriage is one of the most important steps two people can take in their lives. Sadly, under our current law, couples who have their marriages officiated by a minister ordained online face uncertainty.
