Grants Awarded to the 165th:

Bringing money from the state back into our community is important to me, as both a resident and as your voice in Harrisburg. Leading into my second year of service to our district, I am happy to report that the following grants have been awarded to the 165th Legislative District.

Tackling the Student Debt Crisis

Pennsylvania has the second-highest amount of student debt, with the average student owing over \$37,000 as of 2018. As a co-chair of the student debt caucus who has first-hand experience with student loans, it is my priority to find a solution to this issue.

A question I'm often asked is, "What is the student debt crisis?" The student debt crisis is the economic reality that graduates are postponing major life decisions due to the mounting debt they've accumulated from earning their degree. On a national level, over 44 million Americans collectively owe nearly \$1.5 trillion in education debt. This prevents borrowers from buying homes and starting families as they struggle to cover monthly loan payments, bills, groceries and the like. Since borrowers aren't spending as much because of this crippling debt, it can severely slow down economic growth.

With all of this in mind, many highly educated workers are living paycheck to paycheck. I've heard from many residents, not just recent college graduates, but families and grandparents, too, about how they've been impacted by this financial ball and chain. Living in indefinite financial distress should not be a side effect from obtaining higher education.

This is why I teamed up with state Rep. Meghan Schroeder, a Republican from Bucks County, to address this crisis in Pennsylvania. We formed the Student Debt Caucus to improve financial literacy among students, go after predatory lenders and draft legislation to protect student borrowers.

Tackling the student debt crisis isn't a fight for free college, it's a fight for fair funding for education, financial literacy, responsible lending, consumer protection and accessible education.

VSO

My district office has a Veteran Service Officer available monthly who can help with VA Claims, reducing property taxes, and identifying education benefits. If you are a veteran and interested in speaking with a VSO, please contact my office to make an appointment.

REAL ID

Beginning Oct. 1, 2020, Pennsylvanians will need a REAL ID-compliant driver's license, photo ID card, or another form of federally-acceptable identification (such as a valid passport or military ID) to board a domestic flight or enter a secure federal building or military installation.



To obtain a REAL ID-compliant driver's license or ID card, you will need to bring all of the following documentation to a full-service Driver's License Center:

- Proof of identity (original birth certificate with a raised seal, or a valid U.S. Passport)
- A Social Security card
- Proof of all legal name changes (marriage license or court order from applicable county's family court)
- Two proofs of current, physical PA address, such as an unexpired PA license or ID, no-more-than-90-day-old a bank statement or utility bill that is no older than 90 days and with the same name and address





Pennsylvanians can now make direct contributions into the Veterans' Trust Fund from their individual income tax return. These donations help the Pennsylvania Department of Veterans Affairs address pressing issues that they do not have the resources to cover, such as those regarding homelessness, aging, mental health, education, transportation and job training.
