Dear Neighbor,

Spring is in the air! As we head into warmer months here at home, we are also heading into the budget season in Harrisburg. On February 8th, Governor Wolf delivered his final budget address to the General Assembly. His final budget proposal is for a total of \$43.7 billion. While this looks like a large number, it does include many critical priorities, including investments in public education which will result in property tax relief, in mental and behavioral health support, in environmental protections, and in programs to provide more support for individuals with disabilities. The budget also includes an initiative I have championed for two sessions — a \$1 million investment into Hunger Free Campus initiatives to help make sure students over the age of 18 receive the same support for food insecurity that they received before they left home. While the budget is being negotiated from now until June, please know I will continue to work to hear from you about your priorities to make sure that this budget reflects the needs of our community.

My office is also hosting several paper and electronic shred events this year—back by popular demand! Please be sure to check out this newsletter and follow my social media pages for more information about our events including location and which items will be accepted. And, as always, please know my office is here to help you with any state-related needs.

Bringing over \$5 million home

- ✓ **\$4.56 million to update Delco's 911 system**
 This project will improve our county's aging 911 system to ensure no loss of communication during emergency situations. This funding will go toward 24 tower upgrades to provide acceptable county-wide communication coverage, shelter structures, ice bridge, grounding, electric, HVAC, core work additions, and 911 center equipment to communicate effectively in crisis situations with citizens and first responders, as well as with surrounding counties in southeastern Pennsylvania. This has been an initiative years in the making and I was proud to work with all of Delaware County's state lawmakers to strengthen the safety of our communities.
- ✓ **It's On Us grants awarded to two local higher education institutions**
 Delaware County Community College and Eastern University both received grants to combat sexual assault/violence on campus. DCCC received \$17,355 and Eastern University received \$30,000. These awards may be used to help fund trainings for staff and students on consent and intervention, reporting means, counseling, resources for students and survivors and more.
- ✓ **\$480K to improve water quality and mitigate effects of flooding in Radnor Township**
 The Pennsylvania Department of Environmental Protection awarded Radnor a \$438,000 Growing Greener grant. This funding will help enhance Radnor's water quality and flood reduction measures. The project benefiting from this grant will reduce pollutant loads of 255.2 pounds of nitrogen, 17.9 pounds of phosphorus and 17.8 tons of sediment per year – helping with water quality and public safety.

Pennsylvania election update: mail-in voting

Recently, the Commonwealth Court ruled that Act 77 – which implemented no-excuse mail-in voting for Pennsylvania – was unconstitutional. The court reached this verdict because the judges said that changes to our election laws must be adopted via amending the state constitution. However, our state constitution does allow lawmakers to decide voting laws. Therefore, this decision is being appealed by the Wolf Administration.

As this legal process unfolds, Pennsylvanians may still request mail-in ballots. Until the state Supreme Court delivers its final verdict, there is no immediate impact on voting by mail. Follow me on social media for updates on this important issue.

If there are any changes in the primary election scheduled for May 17, Delco's voter services will make an announcement and I will post about it on my legislative social media platforms.

Do you have a SEPTA Senior Key Card?

Due to contact issues caused by the pandemic, SEPTA has extended the printed expiration date on Senior Fare Cards. Cards with expiration dates in 2020, 2021 and 2022 have been extended until the same expiration month in 2023.

SEPTA Senior Key Card update

No SEPTA Senior Key Cards will expire in 2022! Senior Key Cards with printed expiration dates of 2020, 2021 and 2022 will now remain effective through the end of the month printed on the card in 2023.

REAPPORTIONMENT: LRC approves new maps

On Feb. 4, the Legislative Reapportionment Commission voted to approve Pennsylvania's final state legislative district maps. However, even though these maps were approved, there is a 30-day window for legal challenges. New districts will not take effect until all legal proceedings have been ruled on and the state Supreme Court certifies the maps. If the maps are certified, the 165th Legislative District will include all of Springfield, Upper Providence, Media, Morton, and Swarthmore, as well as part of Marple (Precincts 4-2 and Wards 5-7.)

Reapportionment happens every 10 years, triggered by results of the census. The demographics of the commonwealth changed considerably over the past decade. Population shifts and entrenched underrepresentation demanded a fresh perspective on mapping.

While the LRC-approved statewide maps aren't perfect – they meet the state's constitutional requirements. Anyone interested in keeping up with this subject may visit <https://www.redistricting.state.pa.us/maps/> for updates.

Need help with water bills?

Are you or someone you know at risk of losing water service at their home? Help is available for Pennsylvanians who need help with water bills or who may lose water service.

The Pennsylvania Department of Human Services opened the Low Income Household Water Assistance Program. Relief is available to families who have past-due water bills, had their service terminated, or received a notice indicating that their service will be terminated in the next 60 days.





Does the PA Treasury have something for you?



IT'S NO SECRET GEORGE, PA TREASURY HAS \$3.8 BILLION IN UNCLAIMED PROPERTY THEY WANT TO RETURN.

PaTreasury.gov/unclaimed-property

The Pennsylvania Treasury has billions of dollars in unclaimed property, and some of that could be yours. Some examples of unclaimed property include abandoned bank

accounts, uncashed payroll checks, contents of safe deposit boxes and traveler's checks. Anyone can visit www.patreaury.gov to see if the state is holding any property in their name. It is free to search the database, so never pay anyone a fee to search for you. My office will host a St. Patty's Day Unclaimed Property Event to help residents find their pot of gold at the end of the rainbow. Make an appointment with my staff or call 610-544-9878 and we'll search the online database for you. If there is something in your name, we can help you collect what's yours.

State tax forms available at my office

My district office in Springfield has the most common state tax forms available. Anyone who needs them must call ahead, 610-544-9878, or email RepOMara@pahouse.net so that my staff can have the documents ready upon your arrival. We're also happy to mail them directly to you. Quantities are limited at this time, so there is a limit to one PA Tax instruction book per person.

Please note that my office does not have federal or local tax forms available.

Watch for spotted lanternfly egg masses

The spotted lanternfly has now been found in 34 Pennsylvania counties, and it's important to keep up efforts to squash this invasive pest.

Spotted lanternfly eggs are laid in the fall and hatch in the spring. During the winter months and early spring, you can be on the lookout for egg masses left on trees, plastic yard objects and other surfaces. If you see an egg mass, you should scrape and destroy it.

Phasing out 3G service

To make room for 5G service, mobile carriers will deactivate 3G networks. AT&T finished shutting down its 3G network in February, while Verizon will finish shutting theirs down by the end of the year. Cellphones that use 3G will completely lose connectivity, including the ability to call 911.

If you utilize 3G, contact your mobile provider or consult your provider's website for more information about their 3G retirement plan and whether your phone, or other connected device, may be affected. Some devices may only require a software update to restore connectivity.
