Welcome to the 153rd Legislative District

What your district looks like as a result of redistricting

As the current State Representative of the 153rd Legislative District, I wanted to be among the first to welcome you to this wonderful district that I have been lucky to call home my entire life. I know that the process of redistricting can be confusing and I'm hoping that I can explain the basics to help alleviate some of that confusion.



Understanding redistricting and what it means for you:

Redistricting is an important part of our democratic process that occurs once every ten years after each U.S. Census is completed. Based on population changes, voting district lines are redrawn to better reflect a more accurate representation of Pennsylvania's demographics.

For example, each state representative in Pennsylvania has approximately 65-68,000 constituents in their legislative district. If populations have changed and drastically altered the number of constituents being served, district lines may change to ensure fair representation throughout the state.

This process occurred recently, and that is why your home will soon be in the 153rd Legislative District. Before redistricting, the 153rd Legislative District encompassed all of Abington Township and a portion of Upper Dublin. After redistricting, this district will retain most of Abington and pick up more of Upper Dublin, basically half, and all of Rockledge.

If you have questions regarding redistricting, or any other state-related question or issue, please feel free to reach out to my office any time at 215-517-6800. My office is open to walk-ins from 10 a.m. - 3 p.m. Monday through Friday. All other regular business hours are reserved for appointments for those who require privacy or a more COVID-controlled environment. My office is located at 1175 Old York Road in Abington and I have hopes for securing a part-time satellite location in Upper Dublin next year.




BUDGET HIGHLIGHTS

On Friday, July 8, the General Assembly passed the 2022-2023 state budget, and it was signed into law by the governor later that evening. Although we were a week late finalizing this \$42.5 billion spending plan, it's overall a good budget and passed with wide bipartisan support – including my own “yes” vote.

Here are some highlights from this year's budget:

- ☑ Education funding received a historic \$1.8 billion increase, benefiting students from pre-K through college.
- ☑ Gun violence intervention and prevention programs were allotted an additional \$105 million.
- ☑ The Pennsylvania Department of Environmental Protection received a \$7 million increase. Plus, \$640 million in American Rescue Plan dollars will go to the Clean Streams Fund, State Parks & Outdoor Recreation Program, and water and sewer projects. State parks will also receive \$100 million, with three new ones soon being added to our commonwealth.
- ☑ PA's Property Tax/Rent Rebate Program received a \$140 million increase. This will allow for eligible recipients to receive an additional one-time check that is equal to 70% of what they receive in this year's rebate. (No action is required to receive this additional rebate.)
- ☑ The Whole-Home Repair Program was established. This \$125 million investment will provide financial assistance to qualifying homeowners and small-scale landlords to help upgrade their properties with the aim of improving habitability, energy/water efficiency, winterization and accessibility for those with disabilities.
- ☑ The newly created Childcare Tax Credit Program, which received \$24.6 million, will help families offset rising childcare costs. Through this program, filers can receive up to 30% of childcare-related expenses back on their tax return.
- ☑ Recognition of like-kind real property exchanges and reduction of corporate net income tax from 9.99% to 4.99% gradually until 2031 will align PA with other states and attract more businesses to a competitive market.

of legislation continue to languish in committee.

Earlier this summer, several of my colleagues and I signed a discharge resolution in an attempt to bring one bill into the chamber for a full vote. House Bill 770, of which I am the prime sponsor, would ban the future possession, purchase, transfer, use or manufacture of assault weapons in Pennsylvania. Sadly, but not surprisingly, HB 770 has been sitting idle in the House Judiciary Committee all session.

No one is safe from gun violence, and it's our job as legislators to talk about how we can solve this problem. I've had enough of saying "enough is enough," we need to act now.

Gun violence touches everyone's lives. It's a nationwide public health crisis.

Measures like my bills that would require lost or stolen firearms to be reported to law enforcement, require ID for ammunition purchases and ban multi-burst trigger activators would not penalize responsible gun owners, but make gun ownership safer for everyone. Unfortunately, these pieces

Establishing a 72-Hour Waiting Period for All Firearm Transfers

Waiting periods are a simple and straightforward practice that have proven to reduce instances of gun violence in states that enacted them. This short pause gives people in crisis the necessary time to gain perspective or seek help, if needed, disrupting spontaneous acts of violence and self-harm. I introduced HB 1306 with Rep. Mike Zabel so we can save lives here in Pennsylvania without infringing upon the rights of responsible gun owners.

PROHIBITION OF THE LGBTQ+ PANIC DEFENSE *House Bill 1582*

Teaming with Rep. Mike Schlossberg of Lehigh County, we introduced legislation that would prohibit the use of any LGBTQ+ panic defense in Pennsylvania. This is a defense theory that currently allows perpetrators of criminal actions against LGBTQ+ people to receive a lesser sentence – or even avoid conviction or punishment – by placing blame for their actions on a victim's actual or perceived sexual orientation, gender identity or gender expression. Use of this criminal justice loophole is a human rights violation and needs to be closed immediately.



BALLOT QUESTION REFORM *House Bill 2261*

Amending our state's constitution is an important, sacred process that ultimately requires approval by the voters in the form of a ballot question. Therefore, we should aim to hear from as many Pennsylvanians as possible when attempting to alter our state's most fundamental document. My bill would ensure that lawmakers cannot discreetly submit a ballot question during elections notorious for low voter turnouts – like municipal primaries. This legislation would only permit ballot questions during a general election and only every two years when there is a presidential or gubernatorial election, helping ensure that more voters have a say in amending our state constitution.

ABORTION REMAINS LEGAL IN PA,

but a proposed constitutional amendment could end that

Despite the Supreme Court overturning of *Roe v. Wade*, abortion remains safe and legal in Pennsylvania – at least for now.

Currently, Pennsylvania is a safe haven for those seeking abortions, for residents and non-residents alike. Governor Wolf signed an executive order on July 12 immediately ensuring that out-of-state individuals may enter Pennsylvania to access abortion services. Further, this executive order affirms that those seeking these reproductive health care services in the commonwealth will not face criminal charges.

However, a proposed constitutional amendment could change that. The amendment, part of Senate Bill 106, reads, "This constitution does not grant the right to taxpayer-funded abortion or any other right relating to abortion."

This language was carefully selected to allow the majority to claim a focus on protecting taxpayer funds, but in reality the second clause was added because the first step to an outright ban is "confirmation" that there is no right to abortion. By attempting to amend the constitution, this could sidestep the governor and courts. I would like to make it clear that taxpayer funds have never been used in Pennsylvania to fund abortions.

Senate Bill 106 will also need to pass during the next full legislative session (beginning January 2023) in order to make it to your ballot.

Abortion is currently legal in our commonwealth. Please know that I will always vote to protect reproductive rights and do all that I can to ensure that everyone has access to vital health care.



I participated in a roundtable discussion with Vice President Harris and colleagues from both the General Assembly and Congress last July. We discussed how we can support each other as we fight to protect reproductive rights in Pennsylvania and the future of accessible health care.

IMPROVING THE NATURAL DISASTERS INSURANCE CLAIMS PROCESS

Hurricane Ida caused millions of dollars' worth of damages to homes throughout southeastern Pennsylvania last September including our own Upper Dublin. Rep. Nancy Guent and I are proposing a bill that would bar insurance companies from delaying claim coverage with excessive waiting periods during the aftermath of a catastrophe and would require them to notify policyholders of all federal disaster funds available to them during these times of crisis.



ARE YOU PREPARED TO VOTE THIS NOVEMBER?

The General Election is right around the corner, happening on **Tuesday, Nov. 8**. This election is open to all of Pennsylvania's registered voters, so I wanted to ensure you have all of the information you need to carry out your civic duty:

- The last day to request a mail-in/absentee ballot is Tuesday, Nov. 1. Anyone interested may request one online at <https://bit.ly/3yoeDmS> (link is case sensitive). If you'd prefer a paper application, my district office can provide you with one.
- The county election office must receive all mail-in/absentee ballots by 8 p.m. on Nov. 8. Postmarks are not enough. Voting in person? Visit www.pavoterservices.pa.gov/Pages/PollingPlaceInfo.aspx to find your polling place. Polls will be open 7 a.m. - 8 p.m. on Election Day.
