# **THE 2020 CENSUS**

Every 10 years, the United States conducts a census. This count of U.S. residents helps determine how \$675 billion is spent by the federal government and how Pennsylvania will be represented in Congress for the next decade.

This year, it will be even easier to make sure that you and your family are counted. You can respond online, by paper or over the phone. The census will be printed in English and Spanish; accommodations are made for those with visual or hearing impairments; and telephone assistance will be available in 13 languages.

An accurate count is incredibly important for all of us in the state. Many things depend on the results of the census, including the number of representatives that Pennsylvania will have in Congress and the amount of money the commonwealth will receive from the federal government for support services for seniors, children or lower-income residents.

It's important to know that it is completely anonymous. Your information isn't shared, and no one will be able to follow up with you about anything, on any basis.

So, please, be on the lookout for invitations to complete the 2020 Census starting in mid-March. Once you receive your invitation, respond either online, by phone or through the mail. April 1 is officially Census Day, a key reference date. When completing the census, you will include everyone living in your home on April 1, 2020.

# HISTORIC CHANGES TO PA ELECTION CODE

In October, Governor Wolf signed Act 77 of 2019 into law. This historic election reform bill makes the most significant improvements

to Pennsylvania's elections in more than 80 years, allowing for more convenient and secure voting.

You can now vote by mailin ballot, and voters have more time to register and to return their absentee or mail-in ballots.

# LEGISLATIVE UPDATE

I would like to keep you informed about some legislation I've sponsored:



#### PA PRO ACT - STRENGTHENING WORKERS' COLLECTIVE BARGAINING RIGHTS

The brave workers who stand up for their rights create better lives for their families. We need to ensure that our health care workers, retail workers, construction workers, factory workers, steel workers – ALL PENNSYLVANIA WORKERS – can fight for fair wages, a safe workplace, dependable health care, reasonable leave time and retirement benefits.

In order to strengthen workers' rights, I introduced legislation making changes and updates to the Pennsylvania Labor Relations Act. We're calling it the PA Protecting the Right to Organize Act (PA PRO Act).

We need to establish that predatory corporations that violate workers' rights are subject to penalties for worker misclassification. Additionally, we need to ensure that newly formed unions and their corporate counterparts have access to mediation and arbitration as they work to complete their first contract. Lastly, we need to refine the process for unions to collect fair-share fees that would cover the costs of representing all workers in the collective bargaining unit.

By protecting workers, we are protecting a bright future for our commonwealth.

#### EXPANDING THE PENNSYLVANIA FILM PRODUCTION TAX CREDIT PROGRAM

A number of states offer film tax credits as a way to encourage production in their states. Pennsylvania offers a number of fee-free and permit-free options for filming, as well as being a beautiful and geographically diverse state. Yet states like California, Georgia and New York continue to dominate in the awarding of film tax credits.

According to the Independent Fiscal office, uncapping and expanding the credit could have significant positive impact on Pennsylvania's economy and provide well paying, long-term careers for residents.

That is why I introduced legislation to uncap the film tax credit and expand the tax credit program to apply to digital interactive media production expenses, which will give the Department of Community and Economic Development the flexibility to fully commit to multi-year productions and to more effectively budget for the program. Even with an uncapped program, the General Assembly would need to budget for the estimated amount of the credit in each fiscal year. By making these changes, our state can better compete with the top three states for filming and production benefits.

#### PENALTIES FOR FAILURE TO REMOVE ICE AND SNOW FROM VEHICLES

Snow and ice create hazardous conditions on Pennsylvania roadways. According to PennDOT, more than 7,349 crashes occurred on our roads during the winter of 2017. Contributing to these dangerous roadways were drivers who failed to remove ice and snow from their vehicles prior to operating them.

To ensure the safety of all drivers and hold all those responsible for these preventable accidents accountable, I introduced legislation that would penalize reckless drivers who do not remove ice and snow from their vehicles.

Under this legislation, it would be a driver's duty to remove snow and ice from their vehicle prior to driving. Failure to do so would result in a fine between \$25 to \$75, regardless of dislodgment. Should dislodgment occur from a moving vehicle and strike another vehicle or pedestrian causing death or bodily harm, the operator who failed to clear snow and ice from their vehicle would be subject to a fine between \$200 and \$1,500.

#### POLICE TRAINING: CHILD ABUSE

Despite many legislative efforts, child abuse is still a major problem in Pennsylvania. According to the PA Department of Human Services, statewide substantiated reports of child abuse increased from 2017 to 2018, and there were 44,063 reports of child abuse in the commonwealth in 2018. Cases are unique and require consistent, objective and proactive action by police and judges.

Police officers and minor judiciary, such as our magisterial district judges, are often the earliest to interact with the parties of a child abuse case. Our state laws that punish child abusers can only be effective if those at the first point of contact with these cases are trained to recognize child abuse.

Under my bill, police officers and the minor judiciary would receive mandatory training that would help them to recognize

child abuse early on and to be fully aware of the reporting requirements, as well as the full complement of resources available to effectively interview abuse victims.

Child abuse cases can be sensitive and challenging to get right, so we must do all we can to ensure that our police and judiciary are prepared to handle these incredibly important situations.



# **Funding initiatives in the 74th**

# Advocating for state funding for local and regional projects is a key part of a state legislator's job.

With that in mind, I am proud to announce the latest list of local and regional projects supported by grant funding. These projects are tied to our economic success and often prevent steeper local tax hikes.

#### Here are some of those projects:

- A \$730,000 grant through the Multimodal Transportation Fund will help fund roadway improvements and stabilization on Mortonville Road in East Fallowfield Township. The project will rehabilitate the road surface after installation of a permanent roadway stabilization system and stormwater drainage system along 502 linear feet of Mortonville Road north of the intersection with Strasburg Road and south of the intersection with Saw Mill Road.
- A \$40,000 grant through the Pennsylvania Department of Conservation and Natural Resources was awarded to Parkesburg Borough for rehabilitation of Minch Park. It will go toward renovation of a comfort station and pedestrian walkways, ADA access, landscaping, project signage and other related site improvements.
- A \$12,750 tax credit through the Neighborhood Assistance Program was awarded to Habitat for Humanity of Chester County for its efforts to serve lowand very low-income families with the completion of a 46-home single family housing development in Coatesville.
- A \$5,000 Historical & Archival Records Care grant for Caln Township will be used to have 18 boxes of permanent documents affected by water and mold cleaned and digitized. The records include resolutions, ordinances and minutes.
- A \$2.2 million investment through the Pennsylvania Department of Transportation for ArcelorMittal in Coatesville will help rehabilitate approximately 2 miles of rail freight track, turnouts and private crossings serving its rolling mill and electric melt shop sites, helping protect a Coatesville institution that pays livable wages to United Steel Workers union employees.
- A \$225,205 grant through PennDOT's Automated Red Light Enforcement Program to install a traffic signal will address a problematic traffic area near the one-lane bridge over Beaver Creek on Lloyd Avenue in Caln Township.
- An \$80,000 Neighborhood Assistance Program tax credit to 2nd Century Alliance, in partnership with Chester County, is helping to kickstart a commercial district makeover in Coatesville. This batch of funding focuses on rehabilitation of blighted properties, business retention, construction of and improvements for quality residential space, attracting diverse and unique retail and hospitality businesses, increasing parking, reducing criminal activity and implementing green and environmentally friendly programs.
- Two Ag and Youth grants totaling \$14,400 will go to the Chester County chapter of the Pennsylvania Future Farmers of America (\$7,500) and the Chester County Intermediate Unit (\$6,900); the former will be used to restore a Farmall tractor and build a log splitter using welding, mechanics and other skills; the latter will be used for students to participate in the Animal and Veterinary Science program.
- A \$68,988 federal grant for Delaware County Community College, including its Downingtown campus, will help expand opioid preventative programs and create naloxone training opportunities for students.
- \$150,000 was awarded to the Chester County Workforce Development Board to help businesses and schools work together to better prepare students for in-demand careers, focusing on soft-skills development, internships, workplace shadowing and career mentoring.
- A \$35,000 PAsmart grant will help expand computer science classes and teacher training at Coatesville Area School District, better allowing teachers to put students on a path to excellence.

## DO YOU NEED A REALID?

Beginning Oct. 1, 2020, Pennsylvanians will need a REAL IDcompliant driver's license or photo ID



card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic flight or enter a secure federal building or military installation.

## SEPTA SENIOR KEY ID CARD UPDATE

SEPTA has informed my office that it is providing a one-year extension of all SEPTA Senior Key ID cards expiring in the 2020 calendar year. Seniors with a card expiring in 2020 can continue to ride SEPTA using their current card for 12 months beyond the printed date of expiration. For example, cards with a May 2020 expiration date will be valid for travel through May 2021.

Even though no SEPTA Senior Key ID cards will expire during the 2020 calendar year, cardholders with a card expiring in 2020 who wish to optionally renew their card in the coming year can obtain same-day card renewal at one of the below locations:

- SEPTA Headquarters 1234 Market St., Philadelphia, 19107.
- SEPTA Accessible Travel Center Room #109, Suburban Station, 15 N. 16th St, Philadelphia, 19107.

The changes noted above apply only to cards expiring in calendar year 2020 and do not affect new applications in any way. My office will continue to process in-person applications for

applications for NEW SEPTA Key Senior ID Cards, which are available to everyone age 65 or older with a valid ID.



# Splitting Valley North voting district

In November, I endorsed the proposal to split the Valley North voting precinct in Chester County into three separate precincts: Valley North 1, Valley North 2 and Valley North 3.

Consistently long lines mixed with unreliable machines have long made for an unpalatable voting experience for many constituents. I'm pleased to report that this proposal was approved by the Court of Common Pleas and will be in place starting in the April primary.

Check out the new voting districts, and let's celebrate this effort to make elections more convenient and accessible.

# Property Tax/ Rent Rebate Program

Application forms for the Property Tax/Rent Rebate Program are available for eligible

Pennsylvanians to begin claiming rebates on property taxes or rent paid in 2019. The deadline to apply is June 30.

It's free to apply for a rebate, and my office can assist. Call us at (484) 200-8256 for help.

Claimants must reapply for rebates every year because rebates are based on annual income and property taxes or rent paid in each year. Spouses, personal representatives or estates may file rebate claims on behalf of claimants who lived at least one day in 2019 and meet all other eligibility requirements.
