My name is Sean Dougherty, and I am your State Representative. Our district, Pennsylvania's 172nd Legislative District, includes the Northeast Philly neighborhoods of Bustleton, Burholme, Fox Chase, Pine Valley and Rhawnhurst. As someone who grew up and still lives here, being able to serve our community in the Pennsylvania House of Representatives is the honor of my lifetime!

The success of our community is my highest priority. In my first two months in Harrisburg, I am fighting to invest in community safety, ensuring adequate school funding, and creating good-paying, union jobs. I am working with my colleagues to secure funding for relief for business impacted by the tragic Med Jets plane crash, develop policy to expand access to Pre-K for everyone across Pennsylvania, and to fight online price gouging. We've already brought in \$15,000 to the district, investing in Burholme EMS's capacity to handle emergencies, and are fighting to make sure every business, community organization, and non-profit has the resources needed to succeed.

In addition to the work I do in Harrisburg, my office is here to assist you with state government-related resources, programs and concerns you may have. SUPPORTING OUR SENIORS, POSTAL WORKERS, AND INVESTMENT IN OUR CITY WITH CITY, STATE, AND FEDERAL PARTNERS

I am proud to collaborate with elected officials at the city, state, and federal level to fight for Northeast Philadelphia. It's important for all of us to work together to invest in our community, keep and increase our good, union-paying jobs, and fight for improvements to our roads and services.

Councilmember Rue Landau invited me as her guest to Mayor Parker's budget address, where we discussed efforts to invest in city and state road improvements, SEPTA funding, public safety, and working together on community events. We listened to Mayor Parker's promise to push for more public safety investment, a promise I will encourage for the Mayor to uphold.





State Sen. Joe Picozzi and I partnered for a "Find Your Pot of Gold" event at the Lafayette Redeemer and Villages at Pine Community. We met with residents and helped them find unclaimed property, sign up for SEPTA Senior cards, and assisted them with other state resources.



I joined Congressman Brendan Boyle at the Sgt. Christopher David Fitzgerald Bustleton Post Office to stand with our postal workers against privatizing the USPS. The USPS, which is older than the United States and written into our Constitution, serves every Zip code across the nation and costs the taxpayer zero dollars. I cannot stand for over 600,000 good, union paying jobs, many held by our veterans, being cut. The U.S. Mail is not for sale!

We cannot cut funding for special education classrooms, counseling staff, and resources when the demand continues to grow.

I will be working hard to ensure that our schools are properly funded and supported for our community's success!



Applications due by June 30, 2025

You can apply now for a rebate on the property taxes or rent you paid in 2024. This year, the maximum annual income one can have and still be eligible is \$46,520, and the maximum rebate amount one can receive is \$1,000. This program is for seniors 65 and older; widows and widowers 50 and older; and people with disabilities 18 and older.
