Momnibus Legislation

The PA Momnibus is a comprehensive legislative package, crafted for Pennsylvania to directly confront the staggering rate of Black maternal mortality and morbidity in our Commonwealth. The Momnibus addresses critical disparities in maternal healthcare, including measures that would improve access to essential services and eliminate maternal health deserts. The package of legislation would establish programs to tackle social determinants of health and provide essential resources and support to new moms and postpartum people. Together, these proposals represent a significant step toward promoting maternal health equity and ensuring the well-being of all moms and birthing people in Pennsylvania.

HB1608 – Extends Medicaid coverage for doula services and establishes a Doula Advisory Board.

HB1618 – Requires health insurance to cover doula services.

HB2097 – Requires Medicaid to cover blood pressure monitors for pregnant and postpartum enrollees.

HB2138 – Requires health insurance to cover blood pressure monitors for pregnant and postpartum enrollees.

HB2136 – Designates maternal health deserts to target investments in maternal health care services.

HB2127 – Enhances access to mental health care services for pregnant and postpartum patients.

HB2178 – Requires health-related boards within the Department of State to complete implicit bias training.

HB2137 – Establishes the Maternal and Newborn Supply Kit Program to distribute essential resources to new moms and parents.

Clean Slate 3.0

House Bill 689 – Act No. 36 of 2023

The Clean Slate Act has facilitated the sealing of over 40 million cases in Pennsylvania, representing an innovative approach to record clearance. Leveraging advanced technology, the program automatically identifies eligible records for clearance, eliminating the need for court appearances, fees, or paperwork. Everyone deserves a chance at a fresh start; our nation is built on second chances. House Majority Appropriations Chair Jordan A. Harris, creator of the Clean Slate Act, is a firm advocate on criminal justice reform expansion, providing opportunities to those who've earned second chances and fostering fairness within the system. In 2018, Pennsylvania enacted groundbreaking legislation with the introduction of the inaugural Clean Slate bill in the nation. This law automatically seals the records of minor non-violent offenses from public disclosure for individuals who

remain free of convictions for ten years. In 2020, Pennsylvania enhanced and extended the scope of this legislation.



Police Data Reporting

PAUL MILLER'S LAW

ENHANCED DRIVER RESPONSIBILITY

(while operating an interactive wireless communication device)

Paul Miller lost his life to a distracted driver. His mother worked tirelessly with state legislators to prohibit drivers from holding cellphones or other electronic devices in an effort to keep Pennsylvania drivers safe. Paul Miller's law also addresses biased policing by requiring law enforcement to collect data on drivers stopped during traffic stops, including race, ethnicity and gender. Supported by Gov. Josh Shapiro and the Legislative Black Caucus, this law is part of the Shapiro Administration's efforts to enhance public trust in law enforcement across Pennsylvania. This data will be made publicly available in an annual report.



Housing

On April 9, 2024, the PLBC conducted a press conference to emphasize fair housing in conjunction with Second Chance Month. Accessible and affordable housing is an essential need that remains elusive for many individuals. Studies on housing and its impact on the Black community reveal a significant increase in homelessness rates. Pathways to Housing PA reports that the proportion of Black individuals experiencing homelessness is three times greater than their share of the general population. PLBC Members' housing achievements within the budget include:

- \$5 million for Right to Counsel for PA tenants
- A \$10 million increase for the Homelessness Assistance program
- A \$50 million increase for the Whole Home Repairs program
- Rep. Justin Fleming (D-Dauphin) Removing Racially Restrictive Deed Covenants (Act 54 of 2023)
- Rep. Ismail Smith-Wade-El (D-Lancaster), secured a \$67K state grant for the Lancaster Redevelopment Fund, for the emergency shelter at the Otterbein United Methodist Church

Third K. Leroy Irvis Days of Action

May 23rd has been designated as K. Leroy Irvis Day of Action at the Capitol, to celebrate the anniversary of Former Representative Irvis' election to Speaker of the Pennsylvania House. K. Leroy Irvis was the first African American to be Speaker of the PA House and the first African American Speaker in any state legislature since Reconstruction. 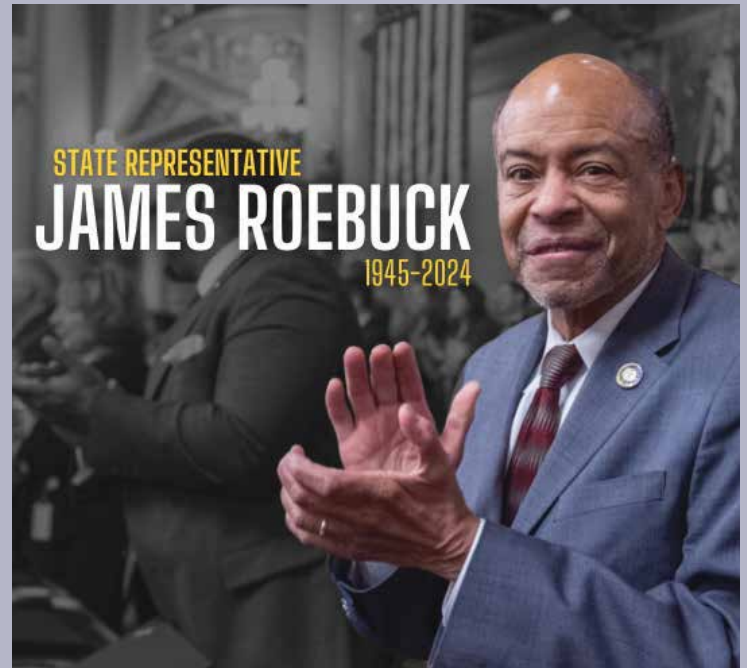
In Honor of State Representative James R. Roebuck Jr.

James R. Roebuck Jr., born in Philadelphia on February 12, 1945; and a 1963 graduate of Central High School, Roebuck earned a degree at Virginia University in 1966 before earning his master's degree at the University of Virginia in 1969. While at UVA, Roebuck became the first Black president of its student council.

From 1970 to 1977, he was a lecturer at Drexel University. Then he was an assistant professor of history at the college until 1984. In the same year, Roebuck worked as a legislative assistant to former Philadelphia Mayor W. Wilson Goode.

Roebuck won a special election on May 21, 1985, to represent the 188th District in the Pennsylvania House and was re-elected 17 times. He fought for many causes, most notably to ensure all Pennsylvania students could receive a quality education. Throughout the commonwealth, he was known as a person who wanted to do his best to improve his community.

In his political life, Roebuck was the chair of the Pennsylvania Legislative Black Caucus (1998-2000), and the House Education Committee. He was also appointed to the Task Force on Higher Education Funding, the Public-School Building Construction and Reconstruction Advisory Committee, the Special Education Funding Commission, and the Higher Education Funding Commission. From 1995 to 2020, he served on the board of the Pennsylvania Higher Education Assistance Agency. In 2022, the then-chair of the Pennsylvania Legislative Black Caucus, State Representative Donna Bullock, named the Pennsylvania Legislative Black Caucus Foundation Scholarship the "James R. Roebuck Scholarship



Awards" for high school seniors and first year college/university students.

His wife, Cheryl Roebuck, was a veteran music teacher, and worked for the School District of Philadelphia for over thirty years. She was active in her West Philadelphia community for over twenty years. She has served as the secretary of the University City Arts League and was a board member of the Garden Court Community Association.

Both were committed to their neighborhood. Rep. Roebuck was a true professional, a good person and will be missed.

The PLBC 2024 James R. Roebuck Scholarship



The PLBC scholarship was established in 2009 during the tenure of then-chair, Representative Ron Waters. In 2021, it was renamed in honor of former State Representative and PLBC Chair, James R. Roebuck. Since then, numerous students from across the Commonwealth have been recipients of this prestigious award.

This year, we were honored to confer this award upon 20 exceptionally talented scholars, several of whom joined us for our Luncheon during the 3rd Annual PLBC K. Leroy Irvis Day of Action.
