We've come up with a plan regarding making sure that we do an internal investigation. We've talked with every single entity there. They're going to help support us in that investigation."

Since Cambria County and its solicitor have been working intimately with the Department of State, have had a meeting with individuals who work there, have come up with a plan, and have talked with every single entity there, there surely exists evidence to back up all that Repak says has been done.

## Please consider this a formal request for that information under the Pennsylvania Rightto-Know Law. So that I may share it with the public as a means of illumination, I am requesting that you provide me with:

+ Copies of any and all documents and communications – including but not limited to text messages and emails – between any elected official or employee in the Cambria County Commissioners Office, the Cambria County Election Bureau, and the Cambria County Sheriff's Office, and anyone in the Pennsylvania Department of State between Election Day of Nov. 5, 2024 and the current date.

+ Copies of any and all documents and communications – including but not limited to text messages and emails – between your main point man Cambria County Solicitor Ron Repak and anyone in the Pennsylvania Department of State between Election Day of Nov. 5, 2024 and the current date.

+ Copies of any and all documents and communications – including but not limited to text messages and emails – between Cambria County Solicitor Ron Repak and any elected official or employee in the Cambria County Commissioners Office, the Cambria County Election Bureau, and the Cambria County Sheriff's Office between Election Day of Nov. 5, 2024 and the current date.

If you choose not to comply with this request, please state your legal objections in writing.
