Dear Neighbors,

I am proud to report that we have been working diligently to introduce various bills and resolutions aimed at building a new, solid democratic foundation for proceedings in the State House. I vow to continue working with legislators on both sides of the aisle to pass legislation that ensures transparency and accountability become the new norm in Harrisburg.

DO YOU NEED A REAL ID?

REAL IDs have recently become available to all residents who want them. However, please note, not everyone needs REAL ID. Beginning October 1, 2020, Pennsylvanians will need a REAL ID-compliant driver's license, photo ID card, or another form of federally-acceptable identification (such as a valid passport or military ID) to **board a domestic commercial flight or enter a federal building or military installation** that requires ID.

To have your documents verified and receive your ID at the time of service, visit one of the two REAL ID Centers in Montgomery County:

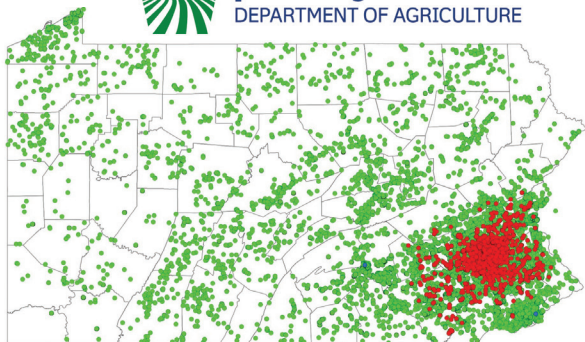

THE SPOTTED LANTERNFLY

Montgomery County is currently located within the spotted lanternfly quarantine zone!

These invasive insects have the potential to negatively impact our local landscape. Please join the effort to control and prevent them from further spreading across our community and commonwealth. The spotted lanternfly can be controlled with a combination of physical disposal of life stages and removal of host trees. To properly dispose of egg masses, nymphs, and adults, scrape them off the tree or surface using a plastic card. Place eggs in alcohol, double bag, and throw away, smash, or burn.



If the spotted lanternfly exceeds the quarantine zone it could become a problem to exterminate. Before traveling outside the quarantine zone, please inspect your vehicles, trailers, or any outdoor equipment (grills, outdoor furniture, landscaping supplies, etc.) for egg masses. If possible, avoid parking in tree lines and keep windows rolled up when parking your vehicle. Any efforts you make in preventing the spread of the spotted lanternfly helps to protect your property and our community from their damaging effects!

LEGISLATIVE CORNER

ENDING THE WAIVER WAITLIST

As of January 2019, there were 13,119 children and adults with disabilities on the waitlist to receive HCBS waiver benefits. Home- and community-based services (HCBS) waivers – under our state’s Medical Assistance program – are one of the essential tools used to ensure Pennsylvanians with disabilities receive the care they require, including specialized in-home health care, medical equipment, mental health crisis intervention, supported employment, and many other vital

support services. Each person on the HCBS waiver waiting list has waived their right to institutional care, saving the commonwealth and taxpayers billions of dollars over their lifetime.

I am currently circulating a memorandum to my colleagues in the House to seek support for my bill that would end the waiting list for HCBS waivers in Pennsylvania.

Forcing thousands of disabled individuals to wait years to gain access to critical services is

unacceptable, which is why I am introducing legislation to require that individuals receive their benefits no later than 90 days after being deemed eligible for the HCBS waiver program. My legislation aims to close this critical gap and increase access to the DHS waiver program, enable our most vulnerable citizens to access essential long-awaited care, and finally allow families throughout the commonwealth to provide their loved ones with proper care.

CURBSIDE VOTING

Participation in our government should be a privilege available to all. As the right to vote is central to our democratic process, accessibility should become central to the voting process. It is critical that we enhance accessibility at the voting booth and work to eliminate as many obstacles as possible by minimizing the physical challenges voters face on their way to the ballot box.

My bill would allow an election official to bring a paper ballot to any voter outside the physical polling place who

has a physical, emotional, intellectual, developmental disability, or short-term inability that would preclude them from easily accessing voting machines.

Voting is a right and a privilege, and we should treat it as such. It is essential that we make participation in our government as accessible as possible to as many Pennsylvanians as possible.



GOOD GOVERNANCE

At the core of any good government, irrespective of the party in power, are fundamental rules which enable all voices to be heard, legislation to be moved forward in a responsible manner, and a way for broadly supported legislation to be enacted into law.

Procedural rules provide the structural foundation on which our state legislature is built and dictate the way our legislature operates on a daily basis. Our current House rules are dictated by party leadership with very little input from members and

fail to create the foundation required for good governance. Under our current rules, just one leader can shut down a vote on a popular bill with broad bipartisan support. The result is a wildly unproductive legislature that continually fails to bring bills with strong public support to the House floor, depriving us all of proper representation.

House Democrats unveiled a package of resolutions aimed at improving these problematic power imbalances. These resolutions introduce reforms that would prevent

any one legislator from having the power to corrupt the process, reduce the power House leadership holds in determining which bills receive a vote, afford junior members of the House more legislative influence, and position bills with broad bipartisan support to receive the attention they deserve.

I am proud to be a co-sponsor on every resolution included in this package and will continue to fight to bring accountability and productivity back to the House floor.

HONORING NORTH WALES BOROUGH

I will soon be introducing a resolution on the House floor to commemorate the 150th anniversary of North Wales Borough. Incorporated on August 20, 1869, North Wales Borough remains a cornerstone of our district’s rich history. I am honored to have the distinguished opportunity to recognize the borough in front of the entire Pennsylvania legislature, and I look forward to sharing a copy of the resolution with you.



REP. HANBIDGE IN THE COMMUNITY



I gathered with my colleagues in February to stand in support of Victoria's Law to stop abusive practices towards animals in Pennsylvania.



In May, I hosted a Drug Addiction Resource Alliance forum with Judge Andrea Duffy to discuss the resources, networks, and supports available in Montgomery County to help youth struggling with addiction. I intend for my office to serve as a resource for those seeking more information about addiction treatment and prevention.



In February, I was pleased to host our Life After School panel in North Wales to empower local families navigating the unique challenges of transition planning for teenagers and young adults with disabilities.



I had the pleasure of getting to know some inquisitive fourth graders from General Nash Elementary School during National Reading Month in April.



We welcomed Mae Krier and Ruth Wilson to Harrisburg on March 21, recently deemed "Rosie the Riveter Day" in Pennsylvania in honor of thousands of working women from our commonwealth who contributed to the WWII effort on the home front.



I had the pleasure to meet North Penn Volunteer Fire Company President Frank Baxter and Fire Chief Don Holt at the North Wales Fire House. I am so grateful to have such an impressive group of public servants working to keep our communities safe, and I look forward to continuing to work with the fire company to secure grant funding for the fire house.



In April, Montgomery Child Advocacy Project hosted a gathering of child advocates, legislators, and community supporters on the steps of the Montgomery County Courthouse to commemorate National Child Abuse Prevention Month.

WOMEN IN THE HOUSE OF REPRESENTATIVES



Women have been historically underrepresented in Pennsylvania politics. In 2018, we ranked 49th in the country for female representation in government. However, over the past year, Pennsylvania voters helped to change that. In last year's midterm elections, voters sent five new women to the State Senate and 18 women to the State House. Since November, three additional women have joined us – including Rep. Movita Johnson-Harrell, the first Muslim woman to serve in the PA legislature. I'm proud to see Pennsylvania embracing diversity in our leadership, and I look forward to continuing to work with my colleagues to empower female leaders across the commonwealth.
