

REAL ID is here! Here's what you need to know

WHAT IS REAL ID? A REAL ID is a new, optional form of driver's license or identification card that PennDOT will issue after verifying certain identification and residency documents provided by you. The REAL ID became available in March and resembles a regular driver's license or identification card, but will have a gold star.

DO I NEED ONE? Getting a REAL ID is not mandatory but it may be useful depending on your needs. After card-based enforcement of the REAL ID Act starts Oct. 1, 2020, you'll no longer be able to use your regular, state-issued driver's license or identification card to board commercial airline flights or enter high-security federal facilities such as military bases. Instead, you will either have to use the new REAL ID or rely on your passport, military ID or other form of federally accepted identification.

You don't need a REAL ID to visit regular federal buildings, vote, apply for or receive federal benefits, or gain access to hospitals and health clinics.

HOW DO I GET ONE? If you decide you want a REAL ID, you can bring the required documents to any PennDOT driver's license center. You'll need to bring:

- Proof of your identity. (An original or certified copy of a birth certificate with a raised seal or a valid U.S. Passport. Please note that birth registration documents or church-issued certificates are not valid for this purpose.)
- Proof of your Social Security number. (You'll need your Social Security card. Please note that **the card cannot be laminated.**)
- Two proofs of your current, physical PA address. (This can include your current, unexpired PA driver's license or ID, your current vehicle registration, your auto insurance card, a utility bill, etc.)



 Proof of all legal name changes, if current full legal name is different than what's reflected on the proofof-identity document. (You'll need a certified copy of your marriage certificate or a court order issued by your county's family court)

Property Tax/Rent Rebate

The rebate program benefits eligible Pennsylvanians age 65 and older, widows and widowers age 50 and older, and people with disabilities age 18 and older.

How much are the rebates?

The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters, and half of Social Security income is excluded. Spouses, personal representatives or estates may also file rebate claims on behalf of claimants who lived at least one day in 2018 and meet all other eligibility criteria.

The maximum standard rebate is \$650, but supplemental rebates for qualifying homeowners can boost rebates to \$975.

How to apply?

My office is here to help you obtain Property Tax/Rent Rebate claim forms (PA-1000) and related information, which can also be done on the Department of Revenue's website or by calling 1-888-222-9190.

Keystone Scholars and PA 529 College Career Savings programs

College tuition is astronomical, so the commonwealth has ways to help you and your family save for college: The Keystone Scholars Program and the Pennsylvania 529 College Career Savings Program.

Through the Keystone Scholars Program, the Pennsylvania Treasury is investing \$100 for every baby born or adopted in 2019 to be used for the baby's future higher education expenses. As part of a demonstration project, babies born in 2018 in Delaware County may also be eligible, but must claim their grant **by the child's first birthday**.

The PA 529 College Career Savings provides a smart, tax-advantaged way for families to save for education. The Program offers two plans: the PA 529 Guaranteed Savings Plan (GSP), where growth is tied to the rate of college tuition inflation; and the PA 529 Investment Plan (IP), in which investment returns are determined by financial markets.

You are invited to have your photo taken for the free Senior SEPTA Key ID cards.

Residents in the 162nd District who are 65 or older and have yet to get their Senior SEPTA ID photo taken can call the district office at 610-534-1002 to make an appointment.

Bring a valid proof of birthdate, such as a photo driver's license, non-driver's ID card, or passport ... and a smile. The SEPTA photo ID card will be mailed to you by SEPTA.

Delloso in the Community




The entire 4th Grade Class of Our Lady of Angels of Morton visited Rep. Delloso, and he took them on a tour of the Capitol in Harrisburg.
