## Dear Neighbor,

On Jan. 1, I was sworn in as state representative in the 34th Legislative District. I am honored to have been elected as your representative and humbled to be able to serve you.

As your state representative, I am in Harrisburg advocating for issues that are important to all of us and our families. I hope that you will all get to know me and the services our offices can provide.

As a lifelong resident of the Mon Valley, I have strived to improve my community from a very young age. After graduating from Woodland Hills High School, I attended Penn State, where I obtained my degree in journalism. Upon graduating, I earned my law degree from Howard University in Washington, D.C.

While at Howard, I was an intern with the NAACP Legal Defense and Educational Fund and a student attorney in the Howard University School of Law Civil Rights Clinic, representing and assisting indigent clients with civil rights complaints.

Since returning home, many of you have connected with me as a community organizer. Together we addressed pressing needs in Woodland Hills School District. This experience revealed that organizing our community, recognizing our issues, and crafting solutions requires co-governance; and that's what I do as your elected state representative.

My pledge is to represent you well in Harrisburg and to assist you with your state-related needs, and concurrently fight for a government and economy that works for all of us. When our community is engaged with leaders in government, we can create a cleaner environment, a healthier future, and deliver justice to people who have been systematically harmed.

# Legislative Update



Currently, I serve on the Judiciary, Local Government and Children and Youth committees. I am also serving as Treasurer for the Pennsylvania Legislative Black Caucus. During my time in the General Assembly, my primary goal will be to focus on issues that are important to our community – jobs, livable wages, quality education, efficient transportation, equal distribution of resources, economic development, and justice for our communities harmed by decades of unhealthy air quality.

Since the beginning of the legislative year, my colleagues and I have introduced a number of bills for debate, and hopefully, eventually enactment if they are voted through the House and Senate.

They include:

- **HR 1382** – Would require the attorney general to appoint a special prosecutor when an on-duty police officer uses deadly force to resolve an incident; and a companion bill that would modernize Pennsylvania's use-of-force laws which govern police procedures, mandating that de-escalation and non-lethal force options be exhausted prior to lethal force being deployed;
- **HR 1009** – Would protect pregnant women who were not convicted of a violent crime by allowing them to receive alternative sentences in a supervised and structured manner;
- **HR 1014** – Would require correctional institutions to provide trauma-informed care to incarcerated people and train staff on how to properly assist trauma survivors, reducing recidivism rates and preparing people to re-enter society;
- **HR 190** – Urging the U.S. Congress to raise the national minimum wage to \$15 an hour;
- **HR 158** – Honors Alpha Kappa Alpha Sorority Inc., the oldest Greek-letter service organization established by African-American college-educated women;
- **HR 91** – Recognizes February as "Black History Month" honoring the triumphs, struggles, accomplishments, artistic and political achievements of African Americans throughout the United States.

In addition to these bills and resolutions, I am also proud to stand with, and cast votes to protect vital public institutions and policies. That includes fighting to ensure that money isn't drained from public schools to support private ones, voting to protect women's reproductive rights, raising the state's minimum hourly wage to \$15, and supporting commonsense gun safety legislation.

We must never sacrifice the health of our community to favor an industry or to save the Commonwealth a few dollars. Therefore, I have voted against regulatory rollbacks which would undo nearly a century of progress toward protecting our air and water. Additionally, I opposed a bill which would strip temporary benefits from our wounded veterans and most vulnerable citizens.

## Happy birthday to the Braddock Carnegie Library!

Braddock Carnegie Library is celebrating a happy 130th anniversary. Dedicated in 1889, the library was the first Carnegie library in the US and is a National Historic Landmark.

More importantly, it has served as a cornerstone of our community for generations, serving the young and the old. Public libraries are dynamic, socially responsive institutions, a nexus of diversity, and a lifeline for the most vulnerable among us, and the Braddock library embodies this mission.

Like many, its staff are often ad hoc social workers and

navigators. They help local people figure out the complexities of life, from navigating the health system to helping those with housing needs. Specifically, they provide assistance with job applications and resumes, food and housing referrals, legal aid, and library music and arts programs.

Without our library – and public libraries in general – our community and Pennsylvania would be a worse place. Libraries are community buildings, and community builders.

We must continue to support the Braddock Carnegie Library and wish for its continued success for another 130 years!
