

INVESTING IN OUR COMMUNITIES

THIS YEAR, I WAS THRILLED TO ANNOUNCE MORE THAN \$2 MILLION IN STATE **INVESTMENT IN OUR COMMUNITIES!**

The former Churchill Valley Country Club will be preserved as a beautiful public green space and recreation area, a project made possible in part by a \$500,000 state grant. Allegheny Land Trust has championed this urban wilderness preservation that residents of our area and region will thoroughly enjoy for generations. Our office enthusiastically supported this grant application from the beginning, and we are excited by its tremendous progress.

Raising the wage has been among the more pressing movements we have discussed in the legislature this year. It has been a decade since the minimum wage has increased in Pennsylvania.

While the Senate has passed a bill to increase the minimum wage to \$9.50 per hour by 2022, it is still not enough to keep pace with the rising cost of living. We still have much work ahead to advance a bill that will substantively improve the lives of our most vulnerable workers and offer Pennsylvanians the wages they need and deserve.

WORKING FOR YOU IN THE MO

In August, we hosted a public forum focused on our legal and moral responsibility to protect our natural environment. A panel of experts addressed the climate crisis and engaged attendees in the policy-making process at the local and state level. Topics included fracking, local and general polluters, and the next steps in the fight for a sustainable and equitable future for the Mon Valley and our planet. The event was held at the new Forest Hills Borough Building, a net-zero energy facility that uses solar panels, geothermal heating, natural light, water reclamation gardens and highefficiency insulation to achieve a surplus in utility bills every month!

In addition to hosting the forum, I am also supporting a number of bills that would improve our environment, including a single-use plastic straw ban (H.B. 1176), tax exemptions and subscription programs for residential solar power (H.B. 1970), expansion of the use of renewable energy in PA (H.B. 1195), expansion of electric vehicle charging stations (H.B. 1908), and the adoption of a carbon trading market in PA (not yet introduced).





UPDATING PA LAW ENFORCEMENT'S USE-OF-FORCE POLICIES



In August, our office, along with Rep. Ed Gainey, hosted a public policy hearing in Rankin to discuss our House Bill 1664, which would update our law enforcement use-of-force statute to maximize the safety of our communities.

Several of my Democratic colleagues from across the state gathered to hear testimony about the need to strengthen relationships between law enforcement and the community. In an impassioned testimony, we heard from Ms. Michelle Kenney, community advocate and mother of Antwon Rose II.

She proclaimed the simple truth, that her son did not have to die so violently last June, echoing a pattern throughout the United States that is worsened by a legal system that routinely acquits law enforcement officers in situations that resulted in death.

Chief Tim Komoroski of the Millvale Police Department also shared his department's efforts to maintain exemplary standards for officers and to build trust in the community.

We need your support to increase accountability and advance protections for our officers, our children and our whole community. Together with H.B. 1382, which requires a special prosecutor to investigate fatal shootings by police, we can reduce the number of deaths in the course of an arrest or investigation, making our neighborhoods safer.

I was thrilled to host students from WPSD in Harrisburg to be recognized in the House Chamber. We are proud to celebrate the school's history of academic excellence, inclusivity and advocacy for members of the deaf and hard-of-hearing community. Here's to another 150 years!



Our office received opioid overdose training by Stacie Brown, the opioid response outreach coordinator at the Allegheny County Health Department. We now carry Narcan, a lifesaving medicine to halt opioid overdoses, at our office on Braddock Avenue. If you or someone you know would like to request Narcan or other overdose prevention tools, please visit the Allegheny County Health Department website, or call our office.



This fall we celebrated the seventh anniversary of the Braddock Free Store at 420 Braddock Ave. This project, which began in 2012, has grown into a sanctuary for our region. Its mission to revive our community redistribution of surplus and donated items has had a tremendous impact on the people of our district.



I was inspired by the youth who attended the Culture Jam in early November at the Ellis School in Point Breeze. It is critical for today's youth to voice their opinions and stand up for what they believe in as they work to make the world a more equitable and safer place.



Our first Senior Health Fair was a great success. We were excited to partner with UPMC Health Plan to connect dozens of seniors to important resources. Thank you to everyone who volunteered. We had a great time meeting seniors and enjoying the scavenger hunt, chair yoga, caricatures and live music from The Marcels with everyone in attendance. In addition, we would like to thank our gracious hosts, the staff at the Turtle Creek Senior Center, for a venue that proved to be spacious and welcoming.

OUR BRADDOCK OFFICE IS AT YOUR SERVICE!

Our office is ready to help you! On the back of this newsletter you can find a full list of things my staff and I can help you with.

Our most popular services are PA Property Tax/Rent Rebates, Port Authority Senior ConnectCards and Unclaimed Property forms.

If you do not know, the state receives millions of dollars annually in unclaimed funds belonging to the public. Many people have unclaimed property just waiting to be reclaimed! Our office can help you contact the treasury and complete your personalized form.

During the winter months, we can also help people with home heating issues through the Low-Income Home Energy Assistance Program (LIHEAP).

And a reminder that the Port Authority is transitioning senior bus passes from paper to electronic ConnectCards! Beginning Jan. 1, the Port Authority will ask for the new cards in order to ride the bus. If you missed the opportunity to sign up for your card at one of our events, there are still plenty of opportunities to apply. To apply for a ConnectCard, please bring a photo ID to our office in Braddock on weekdays and speak with one of our staff.
