At \$7.25 an hour, Pennsylvania has the lowest minimum wage in the United States. In fact, all six states that border Pennsylvania (New York, New Jersey, Delaware, Ohio, West Virginia and Maryland) have a higher minimum wage than we do.

Think about all of your daily expenses -- rent/mortgage, food, clothes, taxes, utilities and transportation expenses. And maybe you want to save for retirement or pay for college. Now think about this: at today's minimum wage, on average, a worker must work 89 hours per week to cover


their rent, which means that folks living on this wage aren't paying for the rest of those things.

Not only is this morally unjust, this is an unsustainable model that threatens our local, and frankly, our national economy. With thousands of hard-working residents of the Lehigh Valley earning only \$7.25 an hour, it is imperative that we do right by these hard-working people. I will not rest until we ensure that these Pennsylvanians get the raise they deserve.

# **EXPANDED HOURS AT TASTING, TAP ROOMS**

I am pleased to tell you that Gov. Tom Wolf signed my bill, House Bill 947, into law. This law expands operating hours for sales at tasting and tap rooms. The craft beer and spirits industry provides good manufacturing and hospitality jobs, invites urban redevelopment and boosts tourism. Here in the Lehigh Valley, we have dozens of tasting and tap rooms (including three in Allentown alone) that will be able to sell more of their product, thanks to this new law.

One such Allentown small-business owner told me that in the days after my bill was signed into law, he was able to book three new holiday parties. This is real business growth right here in our city. Breweries and distilleries are now permitted to sell Pennsylvania craft products between 9 a.m. and midnight Monday through Saturday and 9 a.m. to 11 p.m. Sunday.





#### **BUILDING TRADES JOB FAIR**

In November, I was pleased to join my fellow Lehigh County colleagues, state Reps. Mike Schlossberg and Jeanne McNeill, for a Building Trades Job Fair at the International Brotherhood of Electrical Workers Local 375 in Allentown. Our goal was to connect local residents with building trades organizations and their apprenticeship trainers.

By partnering with dedicated community organizations like Promise Neighborhoods, the Adult Literacy Center and Jordan Heights, we connected talented and hard-working people with good, family-sustaining jobs offered through the Lehigh Valley Building Trades. Job opportunities available through the building trades offer middle-class wages with health care and retirement packages. They also allow young people, folks reentering the workforce or seasoned workers looking to try their hand in a new career an opportunity to earn family-sustaining wages.







#### **GIVING STUDENTS AN OPPORTUNITY**

As a first-generation college student, I know the challenges facing working class families who want their children to continue their education beyond high school. Financial pressures, over-reliance on testing and family concerns often get in the way of a student going to college. These issues are even more obvious for those living at or near the poverty level.

In the Lehigh Valley, our region's poverty is highly concentrated in our urban core. In other words, kids attending Allentown schools are far less likely to go to college than in surrounding districts. As an ASD dad, I know my kids receive an excellent education, but poverty will prevent some of my kids' classmates from going to college. Without a clear path to college, many of them will remain in that cycle of poverty.

In October, I was pleased to join leaders of the Allentown School District and Bloomsburg University to announce a first-of-its-kind agreement between the district and university that will reduce these



barriers and make sure more kids earn a chance at a college degree. ASD students who meet certain academic benchmarks now have guaranteed admission to Bloomsburg. With dedicated scholarships and parent engagement, these students now have the same chance as other kids.

## SAVE THE DATE FOR MY SENIOR FAIR

Save the date for my annual Senior Fair! This year, it will be held on **Friday, May 15** from **10** a.m. to noon.

There was a great turnout for my 2019 Senior Fair and it really is one of my favorite events of the year. Dozens of vendors from government and non profit agencies provide valuable information to older residents about programs and services that are available to them.

The Senior Fair is a great way to hear from our residents, help them get useful information and enjoy doughnuts and coffee! So, plan to join me at the **East Side Youth Center on May 15th.** Look for more information as the event gets closer.








#### VETERANS OUTREACH

Each month, I host a veterans' support program at my district office. A representative from the American Legion is available to assist veterans and their families with benefits and services available to them. #### **REAL ID REMINDER**



This year you will need a Real ID-compliant driver's license or ID card to board a domestic flight or enter secure federal facilities. Real ID is necessary if you don't have a U.S. passport or active military ID. You'll need a Real ID for this purpose by Oct. 1, 2020.

To obtain one, take all of the following to a Driver's License Center:

- Original birth certificate with a raised seal or a valid U.S. passport.
- Social Security card.
- Proof of all legal name changes (marriage license or court order).
- Two proofs of current physical address.

#### PROPERTY TAX/ RENT REBATES


Every year, my office helps hundreds of people file for a Property Tax/Rent Rebate. The best time to file is right now, early in the tax season, but the deadline is June 30th.

The program provides rebates up to \$650 on rent or property tax paid by Pennsylvanians 65 or older, widows and widowers 50 or older, and people with disabilities 18 or older.

The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters. Half of Social Security income and all Social Security cost-of-living increases are excluded.

The application is available in my office and on the Department of Revenue's website at **www.revenue.pa.gov**.

#### **HOME HEATING ASSISTANCE**

The state's **Low-Income Home Energy Assistance Program** is now accepting applications. LIHEAP helps low-income families pay their heating bills and deal with heating emergencies such as a broken furnace, fuel shortage or utility service shutoff.

Renters and homeowners who qualify can have a cash grant, which does not need to be repaid, sent directly to their utility company or fuel provider. Grants range from \$200 to \$1,000 based on household size, income and fuel type. Crisis grants are also available.

Paper applications are available through local county assistance offices or my district office, and my staff can help you apply.
