CENSUS COUNTS 2020

Make sure you fill out the Census!

Every 10 years, the United States conducts a census. This count of U.S. residents helps determine how \$675 billion is spent by the federal government. That's a lot of money!

The census also determines how Pennsylvania is represented in Congress for the next 10 years.

Federal funding for programs like CHIP, Medicaid, SNAP and

WIC are decided based on responses to the 2020 Census. Your response to the census will ensure our community gets its fair share of federal funds for these important programs.

Make sure you complete the census before the Sept. 30 deadline! It only takes a few minutes. Please, visit 2020Census.gov and get counted today!

Does the state have something that belongs to you?

Have you checked the Pennsylvania Treasury's Unclaimed Property database to see if money that belongs to you or a family member is waiting to be claimed?

Unclaimed property can include a closed bank account, uncashed checks, certificates of deposit or lost stocks and bonds sent to the state because the owner could not be found.

My offices work closely with State Treasurer Joe Torsella in returning your property back to you. We can help you search the database to see if there's property in your name and help you claim it. Contact my office at 215-330-3714 for assistance.

Make sure you're registered to vote, and request a mailin ballot now!

It is so important that you use your influence to help shape our community, our commonwealth and our country. Your voice and your vote matter!

If you have not registered to vote, you have until Oct. 19 to register for the Nov. 3 general election. If you are sure you are registered before then, you can also take advantage of applying for a mail-in ballot, which allows you to vote without having to go to the polls on Election Day.

2020 GENERAL ELECTION IMPORTANT DATES





In late May, we passed an interim state budget that funds most obligations until November, in order to help Pennsylvanians who are hurting the most because of COVID-19.

The budget included 100% funding for the 2020-21 school year, along with billions in federal funding provided through the Coronavirus Aid, Relief and Economic Security Act, or CARES Act. This funding continues to be allocated for coronavirus relief efforts, and grants for our first responders, as well as programs to help combat food insecurity and to provide grants to small businesses to help keep their doors open. Our plan is to revisit the budget this fall, to focus on the remaining obligations in an attempt to make ends meet.



Do you need help paying your rent, home heating bill, etc.?

Because of the COVID-19 pandemic, many state programs have been expanded or extended to help people in need. For example, the Property Tax/Rent Rebate Program application deadline has been extended, and LIHEAP is still available.

\$2.8M in Alternative and Clean Energy grants for Rhawnhurst and Anne Frank elementary school projects

Public education is a key to our community's success. It is important that we invest in the facilities to provide a clean and safe environment for our children. I am thrilled to report that in July more than \$2.8 million in grant funding was awarded to Rhawnhurst and Anne Frank elementary schools for building projects expected to reduce energy and water usage.

Anne Frank Elementary School was awarded an \$800,154 Alternative and Clean Energy Program grant for a two-story, nearly 25,000 square foot LEED Gold-certified addition to its existing 103,000-square-foot building. The project is expected to, among other things, reduce the school's energy use by nearly half and its water usage by 35%.



Rhawnhurst Elementary School has been awarded a \$2 million Alternative and Clean Energy Program grant to renovate its existing 58,000-square-foot building, achieving USGBC LEED Gold certification. Planned energy-saving measures are expected to reduce the school's energy and water usage and allow the school to eliminate its use of oil for energy production and be solely reliant on natural gas and electricity.

The grant funding is being provided by the Commonwealth Financing Authority, which administers Pennsylvania's economic stimulus packages.

Senior produce voucher applications are now available

The Philadelphia Corporation for Aging is now distributing Senior Farmers Market Nutrition Program vouchers to approved applicants.

Vouchers are limited to one set per person who is age 60 or older by Dec. 31, 2020, and meets household income guidelines. Qualified recipients will receive four \$6 vouchers for a total value of \$24 worth of produce. Vouchers will be sent by mail to those qualified applicants.

Any person who believes they meet the program guidelines may download an application from the PCA website,



www.pcacares.org, through PCA's Helpline at 215-765-9040, or by emailing sfmnp@pcaCares.org.

Applications are processed as they are received for as long as the voucher supply is available.

If you need assistance or do not have access to a computer or printer, please call my office for assistance.

Expect 30 days from the receipt of your application for processing and voucher delivery.

Vouchers are redeemable until Monday, Nov. 30.

The Property Tax Rent/Rebate Program has extended the application deadline for the 2019 Property Tax/Rent Rebate from June 30th to Dec. 31, 2020. Don't delay! Please apply as soon as possible.

In times like these, we, as a community, need to be respectful of others' opinions and beliefs. We should listen to one another with open minds and not condemn one group of people for the actions of a few, including those in uniform. People have legitimate concerns, and while those concerns may not seem as important to you, they are important to them. Without taking a walk in their shoes, we will never know the how or why unless we listen with an open mind and an open heart.

In late March, I was joined by a few colleagues on the House chamber to honor the life of Philadelphia Police Cpl. James O'Connor IV, who was killed in the line of duty on March 13. O'Connor, along with other first responders who have made the ultimate sacrifice to keep our neighborhoods safe.
