DEASY BILL ON POSTING OF VETERANS' BENEFITS SIGNED INTO LAW

Our veterans are part of the fabric of our commonwealth and certainly part of every community. Here in the 27th Legislative District, we fight for every benefit and resource that they have earned through their service to our country. I introduced legislation that requires employers to display information on veterans' benefits and services in the workplace, and that legislation is now law in Pennsylvania.

Too often, veterans miss out on benefits they've earned simply because they don't know what's available. This law is a commonsense way to make sure that every eligible veteran sees the support that they've earned through serving our country, right where they work. We worked hard to get this passed and I'm proud to have it signed by Governor Shapiro.

House Bill 799 – which had bipartisan support in both chambers and is now Act 31 of 2025 (signed July 7, 2025) - requires employers with more than 50 full-time employees to post a notice in a visible area of the workplace or on the company website, if accessible by employees. The poster, created by the Pennsylvania Department of Military and Veterans Affairs and made accessible to eligible employers through the Pennsylvania Department of Labor and Industry, would include details about:

- Contact and website information for the PA Department of Military and Veterans Affairs.
- Information and contact details for federal and state benefits and services for veterans and their families.
- Contact information for county directors of veterans' affairs.
- The U.S. Department of Veterans Affairs Crisis Line.

Moving forward, we will work to enhance those benefits that so many veterans need and have honorably and so heroically earned.

CHAIRMAN'S CORNER

I currently serve as chairman of the PA House Liquor Control Committee. As with all House committees, chairmen try to schedule opportunities to get committee members into the community to learn about their respective issues. In our case, we meet with business leaders in the industry to gain knowledge about their needs, consumer preferences and how we can help them succeed, thereby adding to the economic impact the industry provides to the commonwealth.

Legislation we have moved from committee includes a bill I sponsored providing more flexibility for off-site catering of end-of-life memorials. This bill passed the House by a nearly unanimous vote and is in the state Senate for consideration.

When a loved one passes away, we celebrate and honor their life. These celebrations are different for everyone but oftentimes, they are catered events with food and drink. They also may happen within days of the loved one's passing and timing can be unexpected. Off-premises catering permits allow liquor licencees the flexibility in catering off-site locations.

The current seven-day notification rule to the Pennsylvania Liquor Control Board poses challenges. As these events can occur in less time than seven days, the current law does not allow the opportunity for a business to provide its full service, and it creates scheduling obstacles for families.

The bill would allow eligible licensees to use an off-premises catering permit for an end-of-life memorial event upon 24 hours' notice.

Families are under enough strain without having to worry whether the business they decide to cater with has provided a week's notice.
