NEW FOR 2026

Save Money on your State Taxes

Each year, more Pennsylvanians are qualifying for a break at tax time.

As part of this year's state budget, I voted to give a tax break to nearly a million Pennsylvania families, including more than 200,000 in Philadelphia and Delaware counties.

It is called the Working Pennsylvanians Tax Credit – because working people deserve a break!

If you qualify for the federal Earned Income Tax Credit, you automatically qualify to save an additional 10% on your state taxes. That is money you can spend on groceries, childcare, or any other expense.

This new program is just the latest on our agenda to cut taxes for Pennsylvanians.

If you are a senior, you may already have received more money back as part of an expansion and increase in the **Property Tax/Rent Rebate Program** in 2023. More than 24,000 local seniors became eligible under the expansion and the max rebate increased to \$1,000.

And if your household has expenses for child or dependent care, you may benefit from the **Child and Dependent Care Tax Credit**, which we tripled in 2024, and now families with two or more children can save up to \$2,000. More than 40,000 local families saved money last year.

My six-year journey to get hair discrimination banned in Pennsylvania ended in November, when Gov. Josh Shapiro signed the CROWN Act into law. I was proud that the Governor signed the bill at West Philly's Island Design Natural Hair Studio, and that I got to share the history-making event with my Goddaughter, Lorel. Passing the CROWN Act is a victory for every person who has felt out of place, unwelcome or discriminated against because of their hair style or texture AND a victory for everyone who attended a rally, called their lawmaker or wore their crown with pride.

WEAR YOUR CROWN WITH PRIDE!

Pennsylvania made history in November, when it became the 28th state to pass the CROWN Act; a new law that bans discrimination based on hair type, texture and style.

Like many African Americans, I have felt the pressure to wear my hair a certain way to meet someone else's expectations – and that is unfair. In 2019, I first introduced the CROWN Act in the state House. It took six years of hard work to convince Republicans in the House and Senate to debate the bill, but when they did, the bill earned overwhelming support.

In November, Gov. Josh Shapiro signed the CROWN Act into law at the Island Design Natural Hair Studio in West Philadelphia.

Passing the CROWN Act in Pennsylvania was part of a national movement to ban hair discrimination. And even though it took six years, we never stopped building support from individuals, businesses, and communities, and that support helped us to finally get the CROWN Act signed into law.



I am so proud that the CROWN Act, which I first introduced in 2019, was signed into law by Gov. Josh Shapiro in November at the Island Design Natural Hair Studio. I brought my Goddaughter, Lorel, with me to the bill signing, because I'm hopeful no one in her generation will need to worry about wearing their hair to meet someone else's expectations.



Keep Seniors Safe At Home

Like many in our community, I was devastated by the news of Ms. Rose Maxine Goodman's death during a home invasion in September 2023.

There are many home security devices like doorbell cameras or exterior lighting that can be used to keep seniors safe.

I'm introducing a plan to keep seniors safe at home, even if they are on a fixed income. My bill, "Ms. Rose's law," would create a

In 2024, I created the Speaker's Meritorious Service Medal to honor people who have made important contributions to our state. In the award's second year, I was proud to recognize the bravery and efforts of two Delaware County police officers, Cpl.
