Ensuring Your Voice is Heard

As we enter into what promises to be a very busy election year, I have good news to share regarding voting access and more options for voters.

Among the changes included in Act 77 of 2019, Pennsylvanians who choose to vote by mail can now do so without needing an excuse. In addition, voters can request and submit their mail-in and absentee ballot up to 50 days before the election, which is the longest vote-by-mail period in the country. Voters can now also request to receive applications for mail-in or absentee ballots for all primary, general and special elections in a given year.

Beginning with the primary election in April, voters can submit their mail-in absentee ballots until 8 p.m. on Election Day. Additionally, the deadline to register to vote has been extended to 15 days before an election. Previously, it was 30 days before an election.

Looking ahead, I will be urging my colleagues to consider H.B. 821, which would allow independent, unaffiliated voters to

vote in primary elections.

Voting is a constitutional right, and independent voters should not be shut out of the process solely because they are not a member of one of the two largest parties in Pennsylvania. If elections are going to be truly free, it is vital that our independent voters have the opportunity to fully participate in these elections.

Leveling the Playing Field

Early last year, after receiving significant feedback and concerns from several school districts statewide that the current high school sports playoff system is unfair, I introduced legislation that would establish separate playoffs for both public and private schools.



I believe the current system's rules under the Pennsylvania Interscholastic Athletic Association gives an unfair advantage to private and parochial schools, because they

are not confined by geographic boundaries that public schools are mandated to follow. In addition, unlike public schools, private schools can field more athletes of superior size, strength and speed, creating an unfair advantage and unsafe environment.

My goal – and hope – is to level the playing field by requiring the PIAA to establish separate playoffs. This would make high school team sports both safe and fun again for all students involved.

Currently, my bill is under consideration in the House Education Committee and I am hopeful it will reach the House chamber in the very near future.

Fighting Against Harassment and Discrimination in the Workplace

Throughout my legislative career, I have worked diligently to ensure all Pennsylvanians are treated fairly and with respect. To that end, I have supported several measures to address workplace harassment and discrimination.

Many victims of sexual harassment and discrimination in the workplace don't report these incidents, due to threats of retaliation, or they may fear they won't be believed. No one should be subject to such actions while trying to do their job, and those who commit such acts should be held accountable and a thorough investigation should take place.

I have given my support to H.B. 1619, which would expand the duties of the state Ethics Commission to include the investigation of sexual harassment claims against officials and public employees at all levels of government.

Among additional measures included in this effort that I support is H.B. 1040, which would amend the state's Human Relations Act to require employers to conduct annual interactive discrimination and harassment training for all

employees, interns and volunteers. This bill would also mandate additional training for supervisors and managers in the prevention of discrimination, harassment and retaliation. In addition, I am in support of H.B. 1025, which would require that all employees have the same workplace protections against harassment and discrimination, regardless of the size of the employer or the type of work performed. Both bills are currently under consideration in the House Labor and Industry Committee.

In June, I voted in favor of H.B. 849, which would ban the requirement of nondisclosure agreements related to sexual harassment as a condition of getting a job.

Bottom line, I believe all Pennsylvanians should be free from any and all forms of harassment and discrimination at the workplace. Those serving in positions of power and authority are not immune, and those who are victims must have the assurance that their complaints will be taken seriously and if found guilty, their perpetrator will be punished appropriately. I will continue to fight for the rights of workers on this issue.

Since July, our communities have received nearly \$29 million in state and federal funds to support job creation, protect our environment, help victims of crime, and keep our schools safe.



How to Obtain Open Records

The Pennsylvania Office of Open Records was created in 2008 to enforce the state's Right-to-Know Law and serves as an important resource for all Pennsylvanians in obtaining public records of state and local governments.

Before you can file a Right To Know (RTK) request, you must first determine which state or local agency is most likely to have the record or records you wish to obtain. The next step is determining who the Open Records Officer is at the agency (by law, each agency is required to have one).

Next, prepare and submit a request using an RTK request form, available at the agency or through the state Office of Open Records. The form can be filed either by email, fax, U.S. mail or in person.

Home Heating Assistance



If you – or someone you know – is having a tough time paying home heating bills, the Low-Income Home Energy Assistance Program, or LIHEAP, is available to help.

This program offers cash grants to help with home heating bills and crisis grants to help those in need with emergency situations, such as a broken furnace or an unexpected fuel shortage.

Renters and homeowners who qualify can have a cash grant – which does not need to be repaid – sent directly to their utility company or fuel provider. Grants range from \$200 to \$1,000, based on household size, income and fuel type.

LIHEAP applications will be accepted through April 10.

Pet safety reminder

Winter is a good time to make sure we're taking care of the furry members of our families.



Please follow these tips to keep them healthy (and warm) this winter:

- **Keep your pets indoors as much as possible.** Many pets can be safe in outside temperatures with proper shelter for a short period of time, but if it's below 32 degrees, under state law, pets cannot be tethered outside for more than 30 minutes.
- **Protect their paws.** Use booties or pet-safe protectants to ensure your pet's paws are not susceptible to frostbite. Always wipe your dog's feet after a walk in the snow to remove ice balls and salt deposits from the road. Salt irritates a dog's paws and can be toxic if ingested.
- **Keep older, arthritic pets inside.** These animals should not be left outside under any circumstances. Escort the older dog outside to relieve itself and use a leash if the yard has ice or snow. Older dogs can easily fall and seriously injure themselves.
- **If you're a dog owner, keep your dog on a leash.** Dogs rely heavily on a strong sense of smell to figure out where they are and can easily get lost during winter storms. Snow covering the ground will make their surroundings less familiar. Keeping your dog on a leash at all times – especially during winter storms – can help stop your dog from getting lost.
- **Never leave your pet inside of a parked car.** While most people know this rule for the summer, a parked vehicle can quickly amplify the effects of extreme weather. During the winter, it can act as an icebox and trap cold air inside.
