Subject: HB 158, Health Equality Impact Assessment

Section 7 of House Bill 158 calls for a health equality impact assessment of hospitals that may close. Below is the Center for Rural Pennsylvania's estimated Closure Impact Analysis for three hospitals: UPMC Kane, McKean County; Conemaugh Miners Medical Center, Cambria County; and Fulton County Medical Center, Fulton County.

These hospitals provide a useful case study in hospital financial and closure vulnerability for the Commonwealth. Each has been identified by the Chartis Center for Rural Health as financially vulnerable<sup>1</sup>. Beyond that identification, the hospitals represent different ownership models and institutional sizes. UPMC Kane is a large system, Conemaugh Miners Medical Center is a small system, and Fulton County Medical Center is independently owned.

The impact assessment below follows the nine paragraphs in Section 5 of HB 158. The data are primarily from the 2021 Pennsylvania Department of Health, Hospital Facilities Surveyed Data. Other data sources include the Pennsylvania Health Care Cost Containment Council, the Center for Medicare and Medicaid Services, and the Health Resources and Services Administration, U.S. Department of Health and Human Services. The fiscal impact data came from the Pennsylvania Department of Labor and Industry and are estimates of total wages.

Although the assessment here estimates the impact of hospital closures, none of these hospitals have announced they were closing. This assessment should be thought of as a "proof of concept," which demonstrates that it is possible to conduct a health equality impact assessment as called for in the legislation. Caution, however, should be used when interpreting the data.

These estimates suggest that more than 35 percent of the population in each of the hospital service areas could be forced to seek treatment elsewhere if one of these hospitals closed. Additionally, each of these hospitals are significant employers in their county. While two of the hospitals are part of larger health systems, the revenue contribution to their respective institutions is less than 5 percent.

In 2021, all three hospitals employed more than 75 full-time individuals. If these hospitals were to close, these jobs may be eliminated.

- UPMC Kane was the nineteenth largest employer in McKean County.
- Conemaugh Health System was the largest employer in Cambria County (includes Conemaugh Miners Medical Center and Conemaugh Memorial Center).
- Fulton County Medical Center was the second largest employer in Fulton County.

<sup>11</sup> Payroll data for the three hospitals were not available due to confidentiality rules. To estimate payroll, the Center for Rural Pennsylvania used data from the Census of Employment and Wage collected by the Pennsylvania Department of Labor and Industry. Using 2021 annual data, the Center divided total average wages by total average employment for general medical and surgical hospitals (NAICS 6221). The Center then multiplied this average by the total employment in each of the three hospitals. While this method is not perfect, it does provide an overall snapshot of volume hospital wages.

**9. The estimated fiscal impact on the hospital authority due to the general hospital closure or significant impact closure.**<sup>13</sup>

In 2021, UPMC Health System operated 26 hospitals. The total operating revenues from these hospitals was \$10.1 billion. Total operating revenues for UPMC Kane Hospital were \$21.2 million, or 0.2 percent of UPMC’s total hospital operating revenues.

In 2021, Conemaugh Health System operated four hospitals. The total operating revenues from these hospitals were nearly \$470.2 million. Total operating revenues for Conemaugh Miners Medical Center were \$18.9 million, or 4.0 percent of the Conemaugh Health System’s total hospital operating revenues.

In 2021, Fulton County Medical Center was independently owned. Therefore, 100 percent of its total operating revenues stayed with the hospital.


