



The Water Resource Act

I recently held a news conference unveiling the Water Resource Act, House Bill 2114. The bill would enact a water usage fee on water withdrawals from commonwealth waterways in excess of 10,000 gallons per day. Municipal and agricultural water use would be exempt.

Revenue generated from House Bill 2114 would be used to fund water-related programs and general governmental operations in the Department of Environmental Protection, Department of Conservation and Natural Resources, and the Fish and Boat Commission. Remaining money would be used to fund water-related projects within Pennsylvania's six major watersheds. There also would be an option to use remaining funds to pay debt service on a \$3 billion bond issue for environmental projects. The bill is awaiting consideration in the House Consumer Affairs Committee.

Beware of "IRS" Scams

We have received reports of residents receiving phone calls from persons claiming they are from the IRS. The caller demands that payment be made in full or they threaten to take your house, vehicle or legal action.

Do not give out your personal information. The IRS DOES NOT collect delinquent taxes in this manner.

If you receive such a call, call the IRS Scam Reporting line at 1-800-366-4484 to report the call and give as much detail from the call as possible.

Always monitor your accounts. If you notice any unauthorized transactions, report them to your bank and call the police department to file a criminal report.

Does the state have something that belongs to you?

Nearly one in 10 Pennsylvanians is estimated to have unclaimed property with the Pennsylvania Treasurer's Office. This property includes any financial asset that may have inadvertently been left with a bank, insurance company, business or organization.

Those entities are required to transfer such property to the state Treasurer's Office, where it will stay until the owner claims it.

To find out if the state is holding on to your unclaimed property, contact my office at 717-295-3157. You can also call 1-800-222-2046 or visit www. patreasury.gov/ and click "Unclaimed Property" to search the database. There is no charge to reclaim your property. Please ignore any solicitation from companies or individuals that attempt to charge you a fee to retrieve your property from Treasury.

In an effort to reduce prescription drug abuse and keep our environment free from contaminants, the U.S. Department of Justice's Drug Enforcement Administration is championing a National Prescription Drug Take-Back Day. It's a safe way to dispose of prescriptions that you no longer need but are unsure of how to dispose of them.

As concerns over prescription drug abuse rise and Pennsylvania works to tackle the opioid/heroin epidemic in our state, it's more important now than ever to keep prescription drugs out of the hands of vulnerable citizens.
