Burns vows to fight proposed Ebensburg State Center closure

72nd Legislative District

As news coverage can attest, Rep. Burns is front and center promising to push back hard against proposed legislation that would close the Ebensburg State Center, where nearly 225 mentally and physically disabled adults receive top-notch, specialized care.

Rep. Burns, who has visited the facility and is aware of its value, wants the voices of family members to be heard before any decision is made.

"The current staff does an excellent job dealing with adults who have very serious mental and physical disabilities – and for whom 'round-theclock care' is not just a phrase, but a reality," – Rep. Burns.



"Before we go changing a system that has literally kept people alive, sometimes beyond medical expectation, there should be a full vetting and support from all stakeholders – starting with those who have loved ones in the Ebensburg State Center."

Rep. Burns also is concerned that closure of the facility would eliminate the jobs of its current 702 employees.

Veterans Day Luncheon scheduled for Nov. 12

Rep. Burns is once again inviting veterans from the 72nd Legislative District to his annual Veterans Day Luncheon, held from 11 a.m. to 2 p.m. Sunday, Nov. 12 at Cresson Volunteer Fire Co., 223 Ashcroft Ave.

All that veterans need to do is show their military ID to get the complimentary spaghetti meal. However, those wishing to attend must RSVP no later than Friday, Nov. 3 by calling 814-736-7339.

"Our veterans put their lives on the line for the freedoms many of us take for granted. The least I can do is provide them a good meal to show our sincere gratitude." – Rep. Burns. At the luncheon, veterans will be able to get their photo identification card from the Cambria County Veterans' Affairs Office. To obtain a card, veterans must be a county resident and bring their DD-214 or qualifying discharge papers.

Also, Burns and his staff

will be on hand with information about various programs available for veterans and their families, including health care, education and job placement services.

Veterans may bring a guest; however, there is a nominal \$5 lunch fee for them.



Burns launches campaign to stop bullying in schools

Aware of the detrimental effect it has on students' educational experience, Rep. Burns decided to launch a "Stop Bullying!" campaign at schools throughout the 72nd Legislative District.

Rep. Burns spent much of the early school year visiting classrooms, encouraging each student to sign a pledge to never bully others – and to tell a teacher or parent if they witness any bullying.

fire companies in the 72nd Legislative District as much as possible.



Burns provides proof that he's not accepting a state paycheck

Rep. Burns understands that most folks in the 72nd Legislative District like to take someone at their word, but he's also aware that some like to see proof. That's why he's showing you this letter from the House comptroller, verifying that he's not accepting a state paycheck during the current unfinished budget impasse that began June 30.

Rep. Burns has traditionally gone without a paycheck as long as the state budget is unfinished, most notably during the nine-month impasse of 2015-16, because of a strong belief that legislators should set an example.

Even though Rep. Burns doesn't like to point fingers, he wants you to know that a major reason this job didn't get done earlier is because of profound disagreement between the Republicans in the House and Senate, where they rule by big majorities.

You don't get paid if you don't do your job; Rep. Burns believes the legislature shouldn't, either.
