
Dear Neighbor,

# **Education Update:**

Pennsylvania schools are on track to resume in-person learning this fall, given that we do not experience a severe second wave of COVID-19. Prior to reopening classrooms for in-person instruction, all schools and higher education institutions are required to develop health and safety plans. This includes implementing social distancing practices, limiting the number of students in a classroom and enforcing heightened sanitation practices.

# State legislature passes temporary budget

Gov. Wolf signed a temporary budget in May to last Pennsylvania only five months, with the exception of fully funding education at the prior year levels. This is because the COVID-19 health crisis restricted the revenue necessary to put a sound, realistic budget together for the full 2020-21 fiscal year, so we will revise this spending plan in November.

This budget includes federal CARES Act funding to help protect those most vulnerable to the virus, defend worker protections for essential employees and provide for our education system. Additionally, we were able to correct a \$300M deficit in property tax relief in order to make the full property tax relief payment to school districts and homeowners as in prior years.

From the \$2.6 billion CARES Act funding, the following money has been earmarked to directly offset the ravaging effect COVID-19 is taking on Pennsylvania.

- \$632M for vulnerable populations including long-term care centers and nursing homes, which have been impacted the most by COVID-19
- \$150M toward worker protections
- \$870M for business and local services relief
- \$347M for schools
- \$30M to health care initiatives
- \$225M toward food and shelter resources

Additionally, through separate legislation, we were also able to provide \$500 million to Pennsylvania's long-term care providers and \$50 million in direct financial relief to fire and EMS companies.

# Police reform legislation unanimously passes PA House

In wake of the unjust death of George Floyd, we've seen protests erupt across the nation calling for a change in our country's policing practices, including right here in all four municipalities in the 165<sup>th</sup> District. In June, the House passed two pieces of legislation, with a unanimous

bipartisan vote and the support of the state Fraternal Order of Police, that would update our police training and prevent officers with a checkered past from transferring to different departments. I was proud to see Pennsylvania legislators and law enforcement officials come together in such a meaningful way.

House Bill 1910 is a police training bill that was amended to mandate in-service training on the use of force, de-escalation techniques, cultural awareness and bias; and amended to include training on trauma-informed care, specifically PTSD. Officers would also be required to undergo training on how to recognize the earliest signs of child abuse and make them fully aware of reporting requirements.

House Bill 1841 would expand background checks for police and other law enforcement officers, which was amended to create a confidential repository of employment records relating to misconduct.

# Grants awarded to the 165th

Bringing state funding home to help our community thrive is important to me, as both a resident and as your voice in Harrisburg. I am pleased to report that several grants have been awarded around our neighborhood, which I'm confident will help us overcome the serious economic impacts of COVID-19:

#### **SCHOOL SAFETY GRANTS**

Funding to purchase security-related equipment, support safety-related training, hire school resource officers, hire school counselors, hire social workers and hire school psychologists.

- Radnor Township School District: \$40,000
- Marple Newtown School District: \$40,000
- Springfield School District: \$141,580

#### **SENIOR CENTER GRANT**

Funding from the PA Dept. of Aging to go toward an area senior center's technology needs.

Wayne Senior Center: \$23,194

#### **FAITH-BASED SAFETY GRANTS**

Grants awarded to two community faith-based organizations to enhance their safety and security measures.

- Temple Sholom in Broomall: \$50,000
- Congregation Beth El Ner Tamid: \$29,407

## **WORKFORCE DEVELOPMENT**

A grant from the Pennsylvania Department of Labor & Industry to provide summer internship opportunities to Delco residents.

Delaware County Workforce Development Board: \$137,463

# Make your own spotted lanternfly trap

As summer continues, Delco will once again see an abundance of adult spotted lanternflies. To help fight the invasive species, Penn State's College of Agricultural Science and the Penn State Extension is sharing instructions for a DIY trap designed to catch these invasive pests all season long.

# PENNDOT EXTENDS EXPIRATION DATES ON DRIVER LICENSES, ID CARDS, AND LEARNER'S PERMITS

The Pennsylvania Department of Transportation (PennDOT) announced that driver licenses, identification cards, and learner's permits that are set to expire between March 16, 2020, through July 31, 2020, have been extended until July 31, 2020. This is in response to statewide COVID-19 mitigation efforts and are supplemental to the extensions announced on May 27, 2020.

# Honoring a local fallen hero

I'm proud to share that my motion to declare the bridge on Morton Avenue, a portion of State Route 2025, as "Capt. Michael Malinowski, Sr. Memorial Bridge" unanimously passed the House as a part of House Bill 1597 on Wednesday, June 24. Gov. Wolf signed this legislation into law on July 1.

Michael Malinowski was the captain of Morton Rutledge Volunteer Fire Co. and passed away tragically on Dec. 3, 2019. This was only one day after he reported feeling ill after responding to a call regarding downed trees and wires. Malinowski was a dedicated and hard-working father, firefighter, and friend who is sorely missed by his family, fire company, and community.
