#### Dear Neighbor,

These words were spoken by Robert F. Kennedy on the day that Martin Luther King, Jr. was killed, April 4, 1968. I do not remember the day because I was not even a year old, but the events of that summer, including Kennedy's own murder two months after King's, shaped a generation. Through assassinations, foreign war, and civil unrest, our country forged forward. Our solutions were not perfect, but we maintained our basic character as a country, one based on concepts of equality for all and the need to take care of the most vulnerable among us.

I believe we are going through a similar time now. How we respond to a global pandemic, stay-at-home orders, and civil unrest will either re-establish or further erode our identity as a country that embraces both individual freedom and social responsibility. I am hopeful that we can stay unified and focused on our common values, rejecting messages of division.

I have been doing my part by reporting for work in Harrisburg and here in the neighborhoods. Even though our office closed for in-person visits in early March, my staff have been in regular contact with constituents. They have handled hundreds of unemployment compensation cases, completed rent rebates, and supported the Bridesburg Food Pantry in delivering meals to its most vulnerable senior and disabled participants. Providing services to the community, especially when it is in need, is the first and foremost priority.



In this newsletter, you'll see how we have been doing the work I was elected to do – providing service to neighborhoods in the district while I also reflect the values of community in Harrisburg. I am doing what I can to show that #WeAreAllinThisTogether is more than just a hashtag...it reflects who we are.

# Bridesburg Park set to begin construction with

\$1.4 million from state

Riverfront and meadow views, unstructured play areas, a great view of the Betsy Ross Bridge, parking and restroom accommodations are just a few of the early features of the new Bridesburg Riverfront Park scheduled for construction beginning next year.

Just a few weeks ago, the state supplied the final \$1.4 million needed to begin the first phase of construction on this long-awaited park in our community. The funding was awarded to the Riverfront North Partnership from PennDOT's Multimodal Transportation Fund.

A second phase of park development will include building a stage pavilion, picnic pavilion, terraced lawn seating and a river boardwalk.






Rendering of future Bridesburg Riverfront Park lawn

# **Hohenstein Hosts 2 Policy Hearings for**

**DISABILITY PRIDE Month** 

Thirty years ago, a Democratic Congress and a Republican president came together to pass the Americans with Disabilities Act. The July 26, 1990 signing of the ADA was the culmination of decades of work by advocates and family members of people living with disabilities. As part of Disability Pride Month in July, I hosted two public policy hearings to highlight the contributions and needs of the disability community in Pennsylvania. On July 16 we addressed the needs of the disabled and senior populations at risk in nursing homes and long term care facilities during the COVID-19 pandemic. State officials and advocates discussed the best way to protect this vulnerable population and improve services. On July 23 we discussed my inclusive disability curriculum legislation to integrate students with disabilities into the standard K-12 curriculum and to teach all students about the contributions of people with different abilities and disabilities to recognize the values of everyone in our community. American Sign Language (ASL) interpreters were provided for both hearings.

The COVID-19 pandemic caused a historic surge in the number of people seeking unemployment compensation (UC). Since mid-March, more than 2 million Pennsylvanians filed for unemployment benefits, more than ever before in history.

In addition to regular unemployment, the federal CARES Act expanded unemployment benefits through new programs. My office can help you to understand them.

## **Fireworks Safety**

As summer heated up, my office received dozens of complaints about nighttime fireworks adding even more stress to people's already stressful lives.

For many, fireworks are a fun way to celebrate Independence Day. But too many are making

it a hazard instead of a holiday. Property damage, injuries, diverting law enforcement and emergency services and threatening people's and pet's mental health are the consequences.

Fireworks are available for legal purchase by Philadelphia residents, so the nuisance and havoc they are creating will not disappear unless sensible changes are made.

I am working with my colleagues in Harrisburg to address this issue and have co-sponsored legislation (H.B. 1687) to give municipalities like Philadelphia tighter control over pyrotechnics. I also am introducing legislation that would prohibit using fireworks between 10 p.m. and 8 a.m. every day, except designated holidays, as well as penalize multiple violations with fines.

Working together, I know we can find a balanced answer that emphasizes safety.

# There's a widespread identity theft fraud ring targeting COVID-19 unemployment compensation benefits programs across the nation. The federal Pandemic Unemployment Assistance program is the primary target of this sophisticated scam.

Fraud

Be aware of the following scam warning signs related to UC benefits:

- You have not applied for unemployment benefits but receive a check or direct deposit.
- You receive correspondence about unemployment assistance for which you did not apply.
- Someone comes to your home and tells you that their unemployment assistance check or debit card was mailed to you by mistake.
- Someone asks you to use your bank account to deposit their unemployment assistance.
- Someone, in person or electronically, tells you that you are entitled to unemployment assistance and requests your personal identifying information.
- Someone offers to help you file for unemployment benefits for a fee.
- Someone claims to be from a government office and asks for a fee or personal information to complete your application for PUA or other benefits.
- An employer receives notice that a claim has been filed for one or more employees who continued working and were not laid off or otherwise unemployed.

# Register to vote and request a mail-in ballot now!

It's important that you use your influence to shape our community, our commonwealth and our country. Your voice and your vote matters!

If you aren't registered to vote, you have until Oct. 19 to register before the Nov. 3 general election. If you are registered, you can also take advantage of using a mail-in ballot, which provides you a safe and secure option to vote without having to go to the polls on Election Day.

#### MAIL!

In this year's primary election, Philadelphians requested double the number of mailin ballots than all Pennsylvania voters did in 2016. No-excuse voting by mail is a



new option for our state, so there were a few hiccups, where some voters did not receive their ballots in enough time to mail them back. Luckily, Gov. Tom Wolf signed an order to allow municipalities more time to count ballots and the Philadelphia elections bureau created several no-contact drop-off boxes in secure locations throughout the city.
