#### Dear Neighbor,

I am both humbled and proud to represent the 177th and the neighborhoods where I grew up. The COVID-19 epidemic has challenged our concept of community, the concept of who we are. Some people might say that it has eliminated any sense of neighborhood or community. I disagree. A strong sense of community is more important than ever, and it requires us to expand our ideas of who "we" are by recognizing how much we have in common.

I was talking with a constituent recently and we both commented that the individualistic spirit of America is one of its greatest strengths; but that in the pandemic, it may be doing more damage than good. In my parents' childhood during WWII, the concept of shared sacrifices resulted in Victory Gardens, scrap metal drives, and a sense of common purpose. Now, our shared sacrifices are wearing masks, keeping distance at community cleanups, and finding the strength that comes with dealing with adversity together (even at that socially acceptable distance). The shared experience of going through these difficult times is a building block to a stronger community, if we take the time to recognize it as something we are going through together.

Our recent neighborhood events pictured inside this newsletter and the future events in the calendar are my attempt to help build that greater sense of who "we" are. I hope you see your own experiences and those of your neighbors reflected in them, and I hope to see you at one of the events soon.

#### Do I need a Real ID? That depends.

No Pennsylvania resident is required to get a Real ID-compliant driver's license or ID card — you don't need a Real ID-compliant license to drive.

However, beginning Oct. 1, 2021, a federally accepted form of identification must be used as identification to board a commercial flight or visit a secure federal building. If you have a valid passport or military ID, for example, you do not need a Real ID-compliant license. For a complete list of federally accepted forms of ID, visit www.tsa.gov/traveler-information/acceptable-IDs.

If you <u>do not</u> have one of these federally accepted forms of ID and wish to access a secure federal facility or board a domestic flight, you should consider getting a Real ID-compliant driver's license or photo ID.

If you do not need to access a secure federal facility or board a plane for domestic travel, you do not need a Real ID-compliant license or ID, unless you want one

# When will I need to have a Real ID?

Oct. 1, 2021.





The cost is a \$30 one-time fee, plus the renewal fee for your license/photo ID. Your initial Real ID-compliant license or ID will include any time remaining on your existing ID, in addition to the regular four-year term. Once you have a Real ID-compliant license or ID, there will be no fee to renew it, other than the regular renewal fee.

If you have applied for a driver's license or photo ID after 2003, you may be able to apply online because PennDOT may have your documentation already on file. If not, you must visit a Driver License Center with original or certified copies of your documentation.

### SENIOR CITIZEN Programs

#### PROPERTY TAX/RENT REBATE

#### If you are:

- 65 or older; a widow or widower 50 or older; or 18 or older and permanently disabled; and
- A homeowner and have a total income not exceeding \$35,000 annually; or
- A renter and have a total income not exceeding \$15,000 annually,

you may be eligible for a property tax or rent rebate of up to \$650, or even more if additional requirements are met.

Claimants can deduct half of any Social Security or Railroad Retirement Tier 1 benefits from their income when determining eligibility. Those receiving federal veterans' disability payments and/or state veterans' benefits may exclude that income when applying.

## REDUCED AUTOMOBILE REGISTRATIONS

#### If you are:

- retired; and
- have a total income not exceeding \$19,200 annually, you may qualify to register your passenger vehicle or light truck for a reduced annual fee of \$10 instead of the usual registration

## PRESCRIPTION ASSISTANCE

#### If you are:

- 65 or older; and
- have an individual



income from all sources of up to \$14,500 or, if married, a total income from all sources of up to \$17,700, excluding any Medicare Part B premiums,

you may be eligible for the state's low-cost prescription plan. You pay only the first \$6 (\$9 for brandname drugs) of a prescription's cost with the state Lottery Fund paying the remainder.

A second tier covers seniors who are single with an income of up to \$27,500 and seniors who are married with incomes up to \$35,500. To receive benefits under this tier, seniors must pay a monthly premium—averaging \$37 per individual—and a copayment of \$8 for generic drugs and \$15 for brand-name drugs.

#### ENERGY ASSISTANCE

If you own your own home or rent a residence and meet income requirements, you may be eligible for aid in paying heating bills through the federal Low Income Home Energy Assistance Program.

If you qualify, payments will be made directly to the utility for credit to your account or, if your heat is included in your rent, to the head of your household.

Income limits and funding availability are determined annually. Check with your county assistance office for up-to-date information.
