Update from Harrisburg

On January 5, I was sworn in for my second term as your state representative. The following week, I received my committee assignments, which are reflective of some of my top priorities as a legislator, such as supporting first responders and making fiscally responsible choices. I was also humbled to accept my nomination as chairwoman of the Southeast Delegation.

The Southeast Delegation is a regional collective of Democratic representatives from Berks, Bucks, Chester, Dauphin, Delaware, Lancaster, Montgomery and York counties. As the largest delegation within the Democratic Caucus, consisting of 35 members, we come together to advance policy issues that matter most to our region of the commonwealth.

I hope to use my new platform as chairwoman to call for unity and the willingness to listen to differing viewpoints, and to advocate for the unique needs of Southeastern Pennsylvania. We are living through times of great division and crisis, and to overcome it we must work together and uphold the democracy we swore to protect.

Legislation introduced

Although the 2021-22 legislative session just began, I'm already hard at work authoring bills based on input from residents throughout the district. Here are the bills that I am currently circulating:

Study on nursing homes: To ensure that nursing home residents and their families are protected from substandard care, my resolution would direct the Joint State Government Commission to conduct a comprehensive study to remedy inadequacies brought to light by the COVID-19 pandemic. This study would examine important factors, such as nurse staffing competency and ratios, emphasis on person-centered care, and the recruitment and retention of quality nursing home leaders.

Update from Harrisburg: Legislation introduced (continued)

- Reducing the mental health stigma: An average of 2,000 Pennsylvanians lose their lives to suicide ever year. Due to the stigma associated with suicide, many experts believe this statistic is inaccurate, and suicide is underreported. In an effort to reduce this stigma, my resolution would urge the use of terms such as "died by suicide" and "fatal suicide behavior" instead of "committed suicide," "completed suicide," and using the words "successful" or "failed" when describing suicide attempts.
- Student Borrowers' Bill of Rights: It is estimated that 2.1 million Pennsylvanians carry an average of \$38,521 in student loan debt. My bill would increase awareness of affordable repayment options, ensure borrowers receive accurate information on their loans and implement stronger oversight on lenders from the Department of Banking.
- Early voting: Following the 2020 presidential election, Pennsylvanians learned that our state's election laws need to be modernized. To cut down on long wait times at the polls and ensure those who work on Election Day can cast their ballots, my bill would permit Pennsylvanians to vote up to 30 days before an election. Early voting would take place at the county board of elections and at designated polling places chosen by the county board.

Working for you in 2020

Last year was unique to say the least, but despite all of the mud that 2020 dredged up, I am proud of what my office accomplished for the residents of our community. My staff and I are happy to be of service and we will always keep fighting for the people of Delco through good times and bad.





Increasing donations to the Veterans' Trust Fund: The VTF provides grants to charitable and service organizations that help veterans thrive in the civilian world. To increase contributions, my legislation would create a space on individual tax returns to allow for donations of at least \$5.

I've also already signed on as a co-sponsor to 195 House bills and resolutions. Legislation I'm supporting includes strengthening the rights and inclusion of Pennsylvanians living with disabilities, property tax reform and fairly funding our commonwealth's public education system.

Bringing home \$5 million last year

Throughout my first term, I worked hard to bring your tax dollars back to the district. In 2020, I'm pleased to share that I helped secure \$5 million to benefit residents from Radnor to Morton.

Grants that I've helped to secure from 2019-20 include financial support to strengthen schools' safety and security, fund volunteer first responders, prepare young adults to enter the workforce, protect our environment and so much more.

Here's just a glimpse of how state funding has helped neighborhoods throughout the 165th Legislative District:



\$348,660 to provide local frontline health care workers with hazard pay.

- \$859,598 awarded to Delaware County Community College, Villanova University, Valley Forge Military College, Eastern University and Cabrini University to implement public health and safety plans so they may resume coursework.
- \$179,354 to benefit six local fire and emergency services organizations, helping offset the financial impact of the COVID-19 pandemic.

\$137,463 awarded to the Delaware County Workforce Development Board to provide seasonal internship opportunities through the State/Local Internship Program.

\$425,000 to rehabilitate Marple Township's storm sewer system to prevent overflows which have caused sinkholes, flooding and deposition of sediment into Darby Creek.

\$500,000 to restore and rehabilitate the Springfield Trail and Meadowgreen Park.

Pennsylvania Unemployment Compensation Program Progression

Understanding the Programs & How to get Benefits

- 1. Pennsylvania Unemployment Compensation – Up to 26 Weeks of Benefits
 - Regular Unemployment Compensation (UC) benefits are available to individuals who have lost their job or had hours reduced through no fault of their own and are found financially eligible. Visit **www.uc.pa.gov** and select "File an Initial Claim" to apply.
 - Eligible to receive \$300/week (FPUC) until March 13, 2021 (beginning after December 26, 2020).

2. Pandemic Emergency Unemployment Compensation (PEUC) – 24 Weeks

- Pandemic Emergency Unemployment Compensation (PEUC) becomes available after regular UC benefits are exhausted. Visit **www.uc.pa.gov/PEUC** to learn about applying.
- Weekly Benefit Amount based on regular unemployment claim.
- Eligible to receive \$300/week (FPUC) until March 13, 2021 (beginning after December 26, 2020).

3. Pennsylvania Extended Benefits (EB) – Up to 13 Weeks

Extended Benefits becomes available after regular UC benefits and PEUC benefits are exhausted.

- Weekly Benefit Amount is based on regular unemployment claim.
- Number of Extended Benefit Weeks are typically 50 percent of the amount of regular UC claim weeks you were financially eligible to receive (e.g. regular UC claim eligibility for 23 weeks, means you'll receive 11.5 EB weeks of benefits.)
- There is no application, EB-eligible claimants will receive a letter in the mail after their PEUC claim is exhausted.
- EB claimants will simply file their weekly certification as they did for regular UC and PEUC.
- Eligible to receive \$300/week (FPUC) until March 13, 2021 (beginning after December 26, 2020).

4. Pandemic Unemployment Assistance (PUA) – Up to 50 Weeks

- Pandemic Unemployment Assistance (PUA) is payable for weeks of unemployment, partial unemployment, or inability to work caused by one of the 11 COVID-19 related reasons set forth in the CARES Act, beginning on or after January 27, 2020. Visit www.uc.pa.gov/PUA to apply.
- Weekly Benefit Amount is based on 2019 taxes, 1099's, W-2, or any additional documentation that will verify 2019 earnings.
- Eligible to receive \$300/week (FPUC) until March 13, 2021 (beginning after December 26, 2020).

The U.S. Department of Labor directs the order of Unemployment Compensation programs. You will need to apply, and exhaust all benefits available under each of the programs before being eligible to apply for the next program.

911 system upgrade

I know that many Delco residents experienced difficulties when calling 911 over the last several years. This is an issue that lawmakers from every edge of the county and across the aisle worked together to fix. Last December, we were proud to announce that \$1.5 million will be dedicated to this project.

This funding will strengthen the security and reliability of the county's public safety communication system. This includes 24 tower upgrades, shelter structures, an ice bridge, grounding, electric, HVAC, core work additions and 911 center equipment to communicate effectively in emergency situations with citizens, first responders and with surrounding counties in southeastern Pennsylvania. Thanks to this funding, new radios were recently distributed to our county's police force.

I was so proud to see legislators work together, Democratic and Republican, representatives and senators, to provide for our first responders and the people we represent.



PENNSYLVANIA AND THE CORONAVIRUS VACCINE

As of the beginning of February, thousands of Pennsylvania's frontline healthcare workers and nursing home/long-term care facility residents have received the coronavirus vaccination. The Pennsylvania Department of Health continues to provide updates on its vaccine distribution plan, which you can find at health. pa.gov.

Curious about when you will be able to receive the vaccine? According to the Pennsylvania Department of Health, it might be several months until the public receives the vaccine, but my office will be sure to keep you updated as more information becomes available. I know this is a slow and confusing process, so I am doing all that I can to ensure vaccine distribution throughout Delco is efficient and those who are eligible can quickly be inoculated. My staff has received several questions regarding the vaccine's rollout and distribution order, but I encourage anyone seeking further information to consult the Pennsylvania Department of Health
