Apply Online for Property Tax/Rent Rebate

Applications for the 2020 Property Tax/Rent Rebate Program can now be submitted online at <u>www.mypath.pa.gov</u>. Previously, applications could only be submitted by mail.

This program provides a state rebate on 2020 property taxes or rent to income-eligible residents who are 65 or older; widows and widowers 50 or older; and people with disabilities 18 or older. The maximum standard rebate is \$650.

To be eligible, your household income must be \$35,000 or less if you are a homeowner, or \$15,000 or less if you are a renter. When applying, only count half of your Social Security or federal railroad retirement Tier I benefits toward your total income.

You can obtain information about the program, an application and free help applying through my district office or on the state Department of Revenue's website at <u>www.revenue.pa.gov</u>. The state will begin mailing rebate checks on July 1. The deadline to apply for this program is June 30, 2021.

Haverford Township Library Awarded Million-Dollar Grant

I was happy to help secure a \$1 million grant for the Haverford Township Free Public Library from the Commonwealth's Redevelopment Assistance Capital Program.

The Haverford Township Public Library has been at its current location at 1601 Darby Road since 1934 and has not seen a major renovation since the 1970s. Last September the Haverford Township Board of Commissioners voted to renovate the existing building as opposed to moving the library to another location. The total cost of the renovation project is expected to be a least \$12 million.

Renovations are expected to include making the library ADA-compliant and more energy efficient, new computers, updated lighting, a new elevator, and a new HVAC system. Improvements to parking are also being considered. The project is expected to begin in the late fall or winter.

Online Filing Option Available for PA Taxpayers

The Pennsylvania Department of Revenue has a new online system for taxpayers to file their 2020 Pennsylvania Income Tax Return (PA-40).

This new system is available online at <u>www.mypath.pa.gov</u> and could help taxpayers avoid paying fees for online tax preparation software or to tax return preparers. In addition to filing the PA-40, myPATH also allows taxpayers to make income tax payments, track the status of income tax refunds, and access other services.

Constitutional Amendments on May 18 Primary Ballot

The following proposed changes to the Pennsylvania Constitution will appear on the May 18 primary ballot:

- 1. "Shall the Pennsylvania Constitution be amended by adding a new section providing that equality of rights under the law shall not be denied or abridged because of an individual's race or ethnicity?"
- 2. "Shall the Pennsylvania Constitution be amended to change existing law so that: a disaster emergency declaration will expire automatically after 21 days, regardless of the severity of the emergency, unless the General Assembly takes action to extend the disaster emergency; the Governor may not declare a new disaster emergency to respond to the dangers facing the commonwealth unless the General Assembly passes a concurrent resolution; the General Assembly enacts new laws for disaster management?"
- 3. "Shall the Pennsylvania Constitution be amended to change existing law and increase the power of the General Assembly to unilaterally terminate or extend a disaster emergency declaration-and the powers of Commonwealth agencies to address the disaster regardless of its severity pursuant to that declarationthrough passing a concurrent resolution by simple majority, thereby removing the existing check and balance of presenting a resolution to the Governor for approval or disapproval?"

Note: When this newsletter went to press there was the possibility that an additional constitutional amendment would appear on the ballot, which would provide a two-year window for alleged victims of childhood sexual abuse to file previously time-barred civil claims for money damages.

All registered voters including those unaffiliated with a major party are eligible to vote on these questions.

I have been reappointed Democratic Chairman of the House Environmental Resources and Energy Committee for the 2021-2022 legislative session. The committee advances energy and environmental legislation and oversees the state departments of Environmental Protection and Conservation and Natural Resources.

I have also been reappointed to the Pennsylvania Environmental Quality Board, a 20-member body that evaluates environmental regulations.

These appointments allow me to be a strong voice for good environmental and energy policy.

Register and Vote

Pennsylvania's primary election is Tuesday, May 18. Polls will be open from 7 a.m. until 8 p.m.

In this election, registered Democrats and Republicans can select nominees from their respective parties to represent them in the Nov. 2 general election, as well as vote on ballot questions (see related article). Unaffiliated voters can participate in the ballot questions only.

Contests on the ballot include: Judges for the Pennsylvania Supreme, Superior, Commonwealth and Common Pleas courts, County Council, Register of Wills, Controller, Sheriff, Township Auditor, Township Commissioners, School Board Directors and Magisterial District Judge.

Vitali Reintroduces Billboard Legislation

Recently, I introduced legislation to give our townships more control over the placement of billboards. HB 850 would prohibit signs larger than 32 square feet within 1,000 feet of a school, playground, park, residential housing area, church, or childcare facility without the approval of the Township Board of Commissioners. The bill would require at least one public hearing before the Board of Commissioners could vote on the placement of billboards. This legislation is similar to HB 2300, which I introduced in January 2020.

This legislation is in response to the applications of a billboard company to install 672-square-foot signs on Lancaster Avenue in Haverford and on West Chester Pike in Havertown. These applications have been contested by Haverford Township Board of Commissioners and the case is currently before the Delaware County Court of Common Pleas.

I oppose these billboards. They are not in keeping with the character of our community and could pose a threat to public safety. HB 850 would give our townships a means to block billboards such as these.

The Pennsylvania Supreme Court has held it unconstitutional for a township to completely prohibit billboards.

Unemployment Compensation Benefits Expanded Further

The Unemployment Compensation system has been expanded for the second time since December, to help those who have lost work due to the pandemic. This includes an extension in weekly benefits through the Pandemic Emergency Unemployment Compensation (PEUC) and the Pandemic Unemployment Assistance programs (PUA).

PEUC supplements the standard 26 weeks of Unemployment Compensation (UC) by providing an additional 24 weeks of benefits. This is an expansion of the previously available 13 additional weeks. If you have an open UC claim, the additional weeks will automatically be added to your existing claim. If your benefits have expired, then you must submit an application online at <u>www.paclaims.pa.gov/PEUC</u>.

District Office Assistance During COVID

My Havertown District Office is available to help you remotely with your state-related matters from 9 a.m. to 5 p.m. Monday through Thursday and 9 a.m. to 4:30 p.m. Friday. Please call (610) 789-3900 for assistance. Due to COVID we are not currently accepting walk-in traffic. In-office appointments will be available as conditions permit. PUA now provides 50 weeks of benefits for selfemployed workers, independent contractors, gig workers, and others affected by COVID-19 who are not eligible for regular UC. The program will not provide benefits for individuals that lack work due to non-COVID-19-related conditions. You can apply for PUA online here: <u>pua.benefits.uc.pa.gov</u>.
