Sturla Named Democratic Chair of House Urban Affairs Committee

For the 2021-22 legislative session, Rep. Sturla will serve as Democratic Chair of the House Urban Affairs Committee. This committee oversees critical issues that affect Lancaster and other urban areas daily, including affordable housing, redevelopment, blight and growth management.

In addition to his committee responsibilities, Sturla will continue to work hard this session on fair education funding, a healthy environment, and Pennsylvania's economic recovery from the pandemic.



STURLA'S LEGISLATION

Rep. Sturla is introducing a variety of bills this session, such as:

- **HB 20:** Create the Pennsylvania Water Resource Act.
- **HB 810:** Require fences between livestock and streams.
- HB 812: Funding for higher education.
- HB 814: Increase grants for professional fire services.
- HB 816: Trauma as a factor in school funding formula.
- **HR 72:** Establish a tool to quantify trauma in schools.

He also is working on legislation that would reform cyber charter school funding, mandate a county or regional health department, establish a lead testing requirement for landlords, improve environmental justice, require conservation plans, and create a higher education promotion task force.

ELECTION REFORM

Last November, Pennsylvania and other states were subjected to misinformation and unfounded malicious attacks on the electoral process. Even with a historic pandemic, Pennsylvania had a secure and fair election. Rep. Sturla is working to make voting easier while improving the existing election law, including allowing counties to pre-canvass their mail-in ballots sooner to avoid later false conspiracy theories.

Sturla is also a prime co-sponsor of legislation that would authorize Pennsylvania to join the agreement among the states to elect the president by national popular vote.

This agreement, commonly referred to as the "National Popular Vote Bill," if activated, would guarantee the presidency to the candidate who receives the most popular votes in all 50 states and the District of Columbia.

Furthermore, this agreement would take effect only when states cumulatively possessing a majority of electoral votes, equaling 270, adopt the same agreement. Currently, 15 states and the District of Columbia with 196 electoral votes have enacted this legislation.

After consulting with the Lancaster County Contact Tracing Program, Rep. Sturla's 10th Annual Back to School Event will be held at Lancaster 'Barnstormers' Clipper Magazine Stadium (650 N. It will be open to K-8th grade students who live in the School District of Lancaster area.

Registration is required to ensure proper crowd safety, and you will be assigned an arrival time between 12 p.m. – 3 p.m. Since there will be no special activities this year, we are asking that only registered students and their parent or guardian be in attendance for quicker processing. VOTING DEADLINES

If you voted by mail last year and added yourself to the annual mail ballot voter list, you will be sent one application to receive ballots for every election this year. These applications will be sent each year. For the upcoming Primary Election Day on May 18, applications for mail-in and absentee ballots must be received by the Lancaster County Election Board by 5 p.m. on May 11. If you would like to vote by mail this year or register to vote, apply at www.votespa.com. First-time voters must register by May 3.





REAL ID TAKES EFFECT OCTOBER 1

Starting October 1, 2021, Pennsylvanians will need a REAL ID-compliant driver's license, photo ID card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic flight, enter a federal building or enter a military base. SCHEDULING OFFICE APPOINTMENTS



To follow COVID guidelines and safety measures, Rep. Sturla's Lancaster office at 150 East King St. is only available for in-person appointments for specific services, since most matters can be discussed and completed via phone. If you need assistance, please email RepMikeSturla@pahouse.net or call 717-295-3157. To ensure that staff can return all calls in a timely manner and to help avoid longer wait times for returning calls, we encourage all callers to leave only one message with your full name and phone number.

Once an appointment is booked, staff will call one or two days before your set appointment time to confirm meeting details and complete the COVID questionnaire with you. Masks are required and must be worn to enter the office and temperature checks will be taken at arrival.

PROPERTY TAX/RENT REBATE PROGRAM

While you can submit your 2020 PA 1000 Property Tax/Rent Rebate applications online at mypath.pa.gov, Rep. Sturla's office is still available to help those who prefer not to use the online option.

For assistance, please drop off the following documents in the office mailbox (pictured above) in an envelope with your full name and phone number:

- Proof of income for 2020 (for example: if you work, W-2 or tax return; if you do not work, your letter from Social Security showing how much you received in disability payments or SSI payments).
- If you rent, your rent certificate signed by your landlord.
- If you do not rent, proof that you paid your property taxes to the city, county and Lancaster School District (this may be on your year-end mortgage summary, SS Form 1098, from your bank or mortgage company).
- Proof of identity (if this is the first time our office has helped you).
- Bank routing and account number (if you want the refund via direct deposit).

INCOME TAX
DEADLINE EXTENDED

Due to the pandemic, state and federal personal income tax deadlines have been extended until May 17. You can file your state taxes at mypath.pa.gov for free.
