### LEGISLATIVE UPDATE

Bills sponsored: 211 **Resolutions sponsored:** 50 HIGHLIGHTS:

Decriminalization of Sex Work – All people deserve basic protections in their line of work. As the law stands, thousands of our neighbors lack access to legal resources, face harassment by law enforcement and are denied health services because of their occupation. It is time for this commonwealth to recognize that sex work is work.

Hairstyle Discrimination (CROWN Act) - This legislation would ban discrimination based on hairstyles and protect people so they do not lose educational or career opportunities because of the way they naturally exist. House Bill 2725 and Senate Bill 964 would amend the Pennsylvania Human Relations Act and clarify the term "race" to include traits such as hair texture and protective hairstvles.

No Cash Bail – Pretrial bail costs taxpayers billions of dollars and infringes on the liberty and rights of millions of Americans each year. I am working to introduce legislation in the new session that would end this system and return to non-financial release using standardized, validated risk assessments.

Alternative Fuel Vehicles – We must take calculated steps to reduce our footprint and improve our air quality. In 2019, emissions from fossil fuel vehicles contributed 18% of greenhouse gases produced in the City of Pittsburgh. We are working on legislation to expand the PA Alternative Fuel Vehicle Rebate program to include rebates for smaller electric vehicles, such as e-bikes and scooters, that many use in place of a car.

As the legislative year has progressed, I have proposed several bills and added my name as a co-sponsor on bills I believe would improve lives in District 34 and across the commonwealth. In the new year, many bills that I have supported will be re-introduced. Within the House Democratic Caucus, I was elected by my peers to serve as vice chairwoman of the Pennsylvania Legislative Black Caucus for the 2021-22 legislative session – the premier legislative body of the Black community in Pennsylvania. I am thrilled to have this vote of confidence from my fellow legislators and will continue to advocate for public policies to promote Black social, cultural and economic progress statewide.

At the same time, House Democrats elected state Rep. Joanna McClinton as the first woman – and first Black woman -- to serve as a minority leader in the House or Senate. It is truly wonderful to see the diversity of our commonwealth reflected in our caucus and in the representation of the people of Pennsylvania.

## Churchill Valley project receives \$1 million

Allegheny Land Trust received \$1 million from DCNR to help purchase the former Churchill Valley Country Club in Churchill and Penn Hills, in addition to \$500,000 that was awarded last year. The nonprofit plans to acquire and protect the area for recreational use and stormwater management.



### Braddock Carnegie Library awarded \$750k for renovations

The Braddock Carnegie Library Association has awarded \$750,000 from the Department of Education for a comprehensive building renovation. The funding will go a long way to create better access, sustainability, and community programming. Specifically, the funds will be used to install a new HVAC system and rehabilitate all windows, doors, stairwells and shafts.



### \$100k for Turtle Creek flood control

The Allegheny County Conservation District received \$100,000 from the PA H20 grant program to remove roughly 11,000 cubic yards of sediment from Dirty Camp Run and Turtle Creek. Grants like this help with flood control, as Turtle Creek has been hit especially hard by flooding in recent years.

## **Major Projects Underway**

### Kenmawr Bridge Replacement

Construction began in March to replace the strained and aging Kenmawr Bridge between Rankin and Swissvale. A temporary bridge has been constructed, while the work on the permanent bridge will continue until its expected completion around September 2021.

### Hazelwood Green

The former site of a J&L Co. steel mill, an environmental and public health hazard, has undergone a massive transformation,

showcasing futuristic and comprehensive features. Though it lies just outside of District 34, residents of all nearby neighborhoods will be impacted by its development. Public meetings were held in late October for residents of Hazelwood and surrounding areas to shape future preservation and the repurposing of industrial remains and desired features of the site. Over the summer and into October. drive-in and limited capacity in-person events took place, including concerts, theater productions, and more. The shell of the former mill remains and has been fitted with 4,784 solar panels on the roof, making it the largest solar installation on a sloped

surface in the entire United States. Planning and construction continue, with intent to run an electric shuttle between the Hazelwood business district and Oakland via Boundary Street.

# Need help with filing your annual rent or property tax rebate?

Due to the ongoing coronavirus crisis, our office will not be able to help people fill out their forms in person. We are working on installing a mail slot so that you can securely drop off documentation without in-person contact. Blank 2019 booklets are available on the stand outside of our office. If we are running low or missing something, please give us a call.

### If you need help with rent or property tax rebates:

- 1. Please mail your booklet and information to our office at 501 Braddock Avenue, Suite 105 Braddock, PA 15104.
- 2. Provide all necessary documentation as described below.

### RENTERS

- Proof of ALL your income for 2019. That includes the form you received in January from Social Security stating how much you received in 2019. Do not bring the form you received that says how much you are receiving from Social Security in 2020.
- Proof of the income you received from your pension, interest, wages, unemployment, etc.
- The Rent Certificate completed and signed by your landlord.
- A copy of your current driver's license/photo ID if this is the first time you are filing for the rebate.

\*\*If your landlord is unavailable to complete the Rent Certificate, the form must be notarized and you should speak directly with our staff.

3. All claimants must do the following:

Fill out Section (I), providing your name, address, DoB, SSN and a daytime telephone number.

Complete Section (IV), your signature, and the date.

4. Our staff will complete your forms and mail the original to Harrisburg and mail you a copy for your records. We will call you at the telephone number you provide to let you know when we have completed your forms and when we are mailing them to Harrisburg.



### **PROPERTY OWNERS**

- Proof of ALL your income for 2019. That includes the form you received in January from Social Security stating how much you received in 2019. Do not bring the form you received that says how much you are receiving from Social Security in 2020.
- Proof of the income you received from your pension, interest, wages, unemployment, etc.
- Proof of property tax payment. Your 2019 annual mortgage statement is acceptable, or all three property tax receipts for 2019 – city/borough, school and county.
- A copy of your current driver's license/photo ID if this is the first time you are filing for the rebate.

# **UNEMPLOYMENT UPDATE**

The COVID-19 pandemic caused a historic surge in the number of people seeking unemployment compensation in Pennsylvania. Since mid-March, more than 2 million people filed for unemployment benefits.

If you or someone you know lost their job during the pandemic, there are two unemployment programs available.

Traditional Unemployment Compensation -> www.uc.pa. gov -> File an Initial Claim

Unemployment for self-employed, gig or contract workers (PUA) -> www.uc.pa.gov -> File for PUA

We understand and feel your frustrations with the Unemployment Compensation and Pandemic Unemployment Assistance programs. Over the past several months, we have been able to assist many people as best we can. However, we are experiencing inconsistent and delayed response times from the Department of Labor and Industry on individual claim inquiries. If you do have questions about traditional Unemployment Compensation or Pandemic Unemployment Assistance, please call our office, email us, or complete the appropriate form so we can collect the information we need to help. ### **Q&A WITH REP LEE**

## 1. Paul, Forest Hills - How are you fighting to make a livable wage available to every worker?

Rep. Lee: In Pennsylvania, we have not raised our minimum wage since 2007. The Democratic Caucus has been fighting for one fair wage. We have legislation that could be moved on today, we just need to get it to a vote, but we also need paid sick and paid family time -- that is all part of what it means to have a 'living wage.' We have tried each budget cycle to move legislation to change the minimum wage, but Republican leadership controls which bills are brought to a vote and, so far, have prevented a vote on this issue.

## 2. Janet, Pittsburgh - Where are we with passing meaningful gun safety legislation?

Rep. Lee: Unfortunately, I think we are as far away as we have ever been. We have commonsense legislation that in another time would not be controversial -- background checks, lost and stolen legislation, basic provisions to protect people that right now, we cannot get brought up for a vote in committee, the first step of the process. The reality is that right now gun lobbyists have a stranglehold on some of our legislators and they are not willing to move. But we are still fighting for this and working to solve community gun violence as well as mass shootings.

## *3. David, Edgewood - Where does the police reform legislation stand?*

Rep. Lee: We have been working on that for almost two years now, but thanks to the protests earlier this summer we have been able to move some pieces of legislation. In June, we were able to pass three pieces of legislation to track police misconduct, provide training and PTSD support for law enforcement, and a 'no consent in custody' law. What we still have on the table are some of our bigger ticket items, including a use-of-force bill addressing when and how police officers can use their weapons and modernize our rules around that. We have made some progress, but we are still working on that.
