## Representative Neilson Appointed to Committee Chairmanship

With the beginning of the 2021-22 Legislative Session in January, I was honored to be appointed Democratic Chairman of the House Game and Fisheries Committee. I have been an active member of this committee in every session since first being elected to serve as your representative in the Pennsylvania House. In this role, we are responsible for overseeing the operations of the Pennsylvania Game Commission as well as the Fish and Boat Commission, while also promoting and protecting the outdoor traditions and wildlife resources of our state.

Without a doubt, the Game and Fisheries Committee operates as one of the most bipartisan groups in

the Legislature because all members share the common goals of serving the interests of the hunters, anglers, and boaters of the Commonwealth. I look forward to continuing that work with members from both parties in my new capacity as a leader on the committee.

## New Legislation Will Create Free Therapeutic Fishing Licenses

Fishing has been used as a successful therapeutic activity by health care professionals in the treatment of a wide variety of ailments throughout the nation. Programs that teach fishing skills and provide experiences on the water have helped those with mental and physical disabilities, cancer, and other chronic diseases. They also assist in recovery efforts from addiction, traumatic brain injury, and post-traumatic stress. Organizations that provided these free fishing opportunities include veterans' groups, such as the Wounded Warrior Project, as well as health care advocates, such as Casting for Recovery and Project Healing Waters.

The Fish and Boat Commission has the authority to award free license exemptions to participants of certain educational activities. However, currently the Pennsylvania Fish and



Boat Commission has no specific free exemption for therapeutic activities, relying instead on educational permits, even when the activity may not be technically qualified as such. In the Annual trout restocking in the waters of Pennypack Creek.

recent past, participants in over 60 different service organizations and hundreds of unique one-day fishing events across the Commonwealth would have qualified for a therapeutic license exemption, if it had existed.

It was with all this in mind that I was pleased to introduce House Bill 1108, the Therapeutic Fishing License Act. The bill would allow the Fish and Boat Commission to properly award free fishing privileges to people whose recovery and wellbeing will be improved by



participating in educational fishing programs. The Fish and Boat Commission supports this legislation and agrees with the unique value of this initiative.

My bill won unanimous support in the House Game and Fisheries Committee earlier this year and now awaits attention by the House of Representatives.

## New REAL ID Requirements and Deadlines

Beginning May 3, 2023, Pennsylvanians will need a REAL IDcompliant driver's license, photo ID card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic commercial flight or enter a federal building or military installation that requires ID. REAL IDs are now available to Pennsylvanians who want them. Visit <u>penndot.gov/REALID</u> for more information to help you decide if you need a REAL ID, and for information on what documents you will need and steps you can take to get an optional REAL ID.

## **SEPTA Key Senior Card Availability**

Senior citizens, age 65 and older, with a valid ID, ride FREE at all times on all Transit Routes (Bus, Trolley, Trackless Trolley, Broad Street/Broad Ridge Spur Line, Market Frankford Line/Norristown High Speed Line) and on Regional Rail for travel to and from stations located in the Commonwealth of Pennsylvania. Seniors are also entitled to half fare (50% of the weekday fare) for travel to and from New Jersey and Delaware. To enjoy this benefit and ride,

seniors will need to use one of the following VALID types of identification:

- Pennsylvania driver's license (licenses issued AFTER July 2017 cannot be used).
- Pennsylvania non-driver ID card (IDs issued AFTER July 2017 cannot be used).
- SEPTA Key Senior ID card.

#### There are three ways to apply for a SEPTA Key Senior Card.

- 1. Our District Office at Ashton Center is able to process applications for SEPTA Key Senior cards for our constituents (new applicants only), including taking photographs for the ID.

Due to the COVID-19 social distancing protocols and the desire to minimize non-essential travel, ALL SEPTA Key Senior Cards that expired in 2020 and those set to expire in 2021 have been extended through the end of calendar-year 2022.

## New State Tax Filing System

The Pennsylvania Department of Revenue has introduced a new online portal, myPATH, as an easy-to-use online system available for taxpayers in Pennsylvania who file and pay certain tax types, including Personal Income Tax, and Property Tax/ Rent Rebate applications. ### New Unemployment Compensation System

The Pennsylvania Unemployment Compensation (UC) program is administered by the Department of Labor and Industry and provides temporary wage replacement income to qualified workers. The system has undergone significant enhancements over the past year in response to increased need resulting from the COVID-19 pandemic. The new UC system is easy-to-use and designed to simplify and speed up the claims process. Claimants will now have access to more information and new self-serve options that will reduce the need to contact the UC customer service center.

The new system will make sure people will get the benefits they need while also reducing the opportunity for fraud. The



new UC system requires a log-in using a Keystone ID and password. You might already have one from using a different Commonwealth of Pennsylvania online service (such as PA CareerLink or COMPASS). Individuals currently filing for benefits through one of the programs will use the new UC system to file their weekly or biweekly claims. In the new UC system, claimants may access the UC Dashboard to file claims, access claim information, file an appeal, check payment status and more. ## Verify with **D**.me

ID.me has entered a partnership with the Pennsylvania Department of Labor & Industry (L&I) to facilitate Pandemic Unemployment Assistance (PUA) and Unemployment Compensation (UC).

ID.me is a federally certified identity verification provider that specializes in digital identity protection. ID.me is already assisting several other states with preventing fraud within the PUA program. L&I is continuing to monitor claims for fraudulent applications and working with law enforcement partners in bringing scammers to justice.

"This new layer of identity verification will help ensure PUA payments are going to Pennsylvanians in need and not into the pockets of fraudsters," said PA Department of Labor & Industry Secretary Jerry Oleksiak. "Our partnership with ID.me will allow us to make payments more quickly to legitimate PUA claimants while helping L&I fulfill its fiduciary responsibility to the public to prevent fraud."

#### Be on the lookout for Unemployment Compensation fraud

The Department of Labor & Industry is urging Pennsylvanians to be vigilant of fraud and the warning signs and steps to take if they become a victim.

Across the nation, fraudsters have been applying for unemployment benefits using stolen identities that were obtained in data breaches that occurred outside of state government. Many people whose personal data was leaked are unaware until a fraudster uses their identity to apply for unemployment benefits and they receive notification that a benefits application has been filed in their name.

Anyone can contact the Pennsylvania Department of Banking and Securities with questions or complaints about a financial transaction, company, or product at 1-800-PA-BANKS by using the online complaint form, <u>https://www.dobs.pa.gov/Consumers/Pages/File-a-Complaint.aspx</u>.
