To combat this inaction on such a critical issue, my colleagues and I signed a discharge resolution that would move these bills out of committee and up for a vote. Continuing to remain silent on the issue of gun violence will allow the carnage in our communities to continue and worsen. We can no longer stand idly by while our children die. I urge everyone to use their voice and continue advocating for change that will lead to lives being saved.

AROUND THE DISTRICT




I was honored to join Governor Tom Wolf as we discussed the PA Opportunity Program. This initiative is part of a \$1.7 billion proposal that would strengthen the commonwealth for generations. The PA Opportunity Program would send direct payments of up to \$2,000 to Pennsylvania households with an income of \$80,000 or less.

Right now, there are billions of dollars in federal COVID-19 funds that could be helping people in Reading and all over the state, but instead, the money is locked up in a government vault helping nobody. This money belongs to the people and belongs in their pockets so they can decide how to spend it in the community, multiplying the power of each dollar and helping workers, helping kids, helping seniors, helping small local business, and building a better future.
