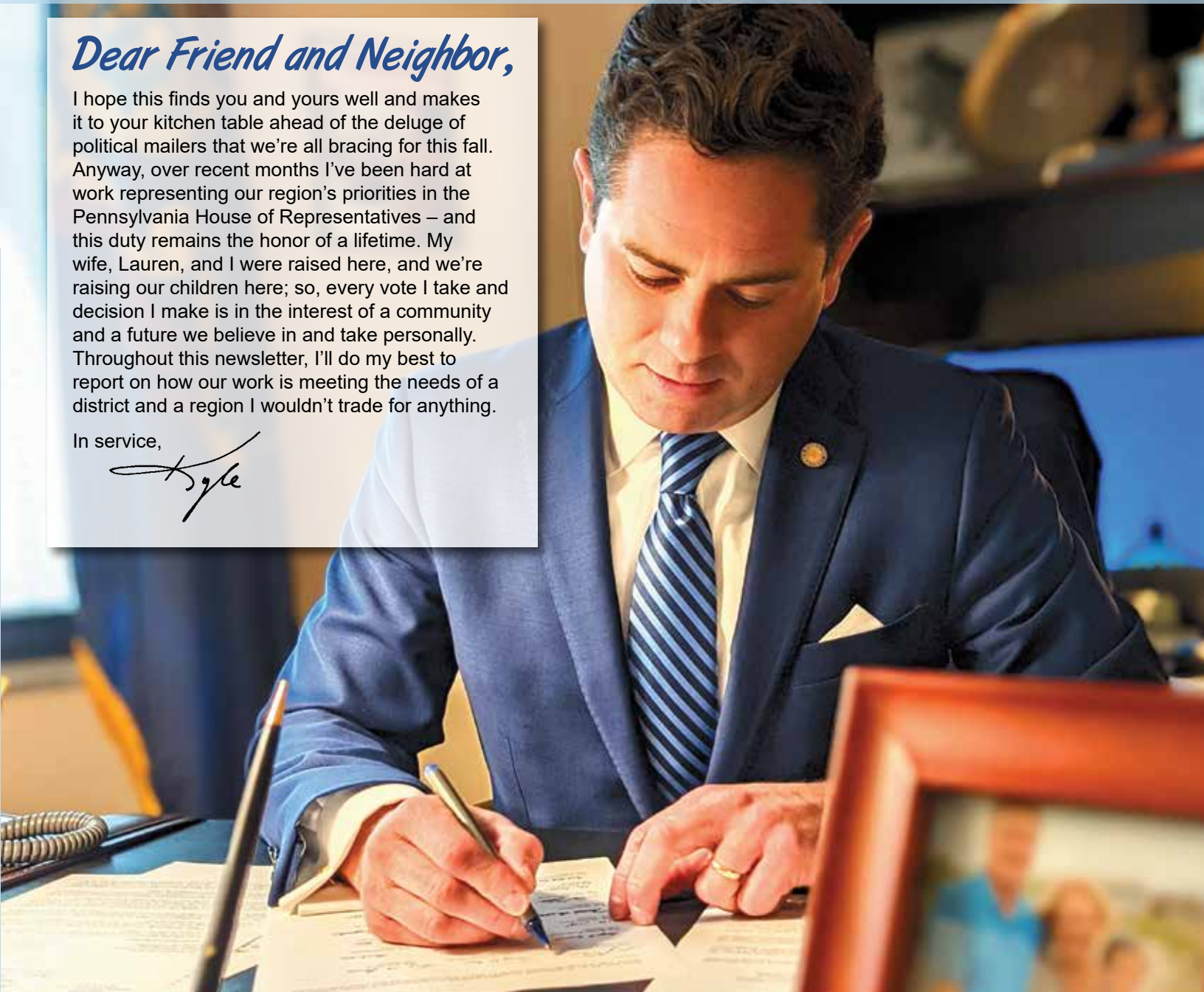

Anyway, over recent months I've been hard at work representing our region's priorities in the Pennsylvania House of Representatives – and this duty remains the honor of a lifetime. My wife, Lauren, and I were raised here, and we're raising our children here; so, every vote I take and decision I make is in the interest of a community and a future we believe in and take personally. Throughout this newsletter, I'll do my best to report on how our work is meeting the needs of a district and a region I wouldn't trade for anything.

BUDGET MESSAGE

Crafting our state's yearly spending plan is one of the chief responsibilities we have as legislators. Because of the diversity of Pennsylvania, it's no wonder that we encounter the push-and-pull you'd expect when it comes to adequately funding a range of worthy programs. While the final budget was the result of compromise, I'm proud to have helped shape historic investments without raising any taxes.

We have a constitutional and moral responsibility to educate our children. This year's budget contains a record investment increase of \$750 million to Pre-K to 12 education. We also increased funding for our career and technical schools by \$6.1 million to ensure that our students have a viable pathway toward a career in the trades. To assist those planning for higher education, the budget also allocated \$7 million for Dual Enrollment grants, something that hasn't been funded since 2010/2011. Our world-class institutions of higher education also received an \$11.3 million increase.

I'm exceptionally proud of the increases we achieved across our health and human service programs because the quality and affordability of the care we receive affects everyone. Along with significant increases across many disease-specific support programs, I'm personally grateful to my colleagues and advocates for securing a historic appropriation of \$1.5 million for

Amyotrophic Lateral Sclerosis (ALS) support services. As you may know, my father is battling ALS, also known as "Lou Gehrig's Disease" – a fatal, neurodegenerative illness that has robbed him and so many of the ability to speak, swallow, breathe without assistance, or walk, along with other, everyday functions. I take these efforts to find cures and improve services for those impacted by this and other rare diseases personally, and my work will continue.

We also increased support for the Department of Drug and Alcohol Programs, with a substantial portion funded by the opioid lawsuit and settlement brought by Attorney General Josh Shapiro. Funding for support, treatment, and prevention efforts was increased from \$5 million last year to \$22.5 million.

These last two years haven't been easy for any of us, and especially not for health care and long-term care workers. With an increase of roughly \$150 million for nursing homes and \$294 million in the Medicare nursing facility rate, we have provided needed aid to Pennsylvania's direct care sector. It's also a challenging time to be a parent or caregiver. In recognition of these challenges, there was a \$25

million increase in child care services for families. To serve an additional 823 individuals with intellectual disabilities waiting for services, the Intellectual Disabilities-Community Waiver program includes an \$18.8 million increase. A new tax credit has been created to provide child care assistance to working families. The highest credit available is for families with income of \$15,000 or less, for which the credit is \$315 for one child and \$630 for two or more children. We also made critical investments in mental health, intellectual disabilities, autism, and child development.

The well-being of our state must also be measured by the reliability of our infrastructure and the health of our environment. That is why we have allocated \$3.9 billion for state infrastructure projects, including bridge, highway, and road repairs. To protect our environment, we have allocated a historic \$640 million in conservation programs, including \$240 million for water and sewer system improvements, and \$100 million for local conservation districts to use on flood control, nutrient management, and other projects.

Creating more family-sustaining jobs requires making our state a better place to do business. I voted to lower the high 9.99% Corporate Net Income tax over the next few years to 4.99% to attract more companies to Pennsylvania.

I also voted to help those who benefit from the Property Tax/Rent Rebate program by issuing them a bonus rebate equal to 70% of the amount received for the 2021 calendar year.

INVESTING IN OUR COMMUNITIES

Another priority of mine will always be to bring your hard-earned tax dollars and other funds back to our area to benefit you and the rest of our region. Over the last several months, I helped to deliver nearly \$10 million in projects that will address major stormwater and erosion problems; honor area veterans; enhance recreational facilities; support downtown development; help to convert old mine lands into a business development; and much more. I was proud to work with other area legislators to secure funding for the following important projects:

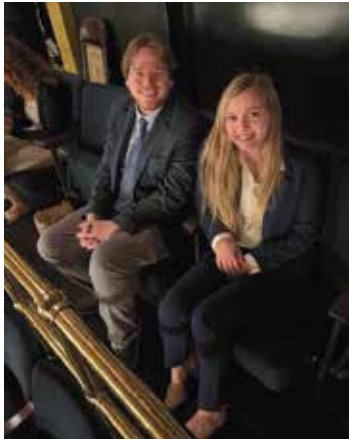
What is the Legislative Fellow Program? East Stroudsburg University's Legislative Fellow program was introduced in January 1999. The program is designed to bring state legislators to campus to participate in a variety of campus activities and to meet formally and informally with students, faculty, and staff throughout the year.

How are Legislative Fellows chosen? Legislative Fellows are selected through a non-partisan process by a committee of faculty and staff members jointly appointed by the University President and the local chapter of APSCUF. Once appointed at the beginning of each academic year, these distinguished political leaders serve for the duration of that year.

What are the responsibilities of a Legislative Fellow?

Fellows are selected based on their records of achievement and service to their community and to the commonwealth. They may serve as guest lecturers in classrooms or symposia and are invited to attend, as our guest, all university-sponsored events on campus including commencement activities.

I have had the opportunity to visit ESU's campus and to meet with Interim President Long, alongside various students and staff. I always cherish opportunities that allow me to meet with the community at large. Being chosen as a Legislative Fellow has been an absolute honor and a humbling experience.
