

PRIME LEGISLATION INTRODUCED

Mobile Home Lot Rental Reform

In recent years, the lot rental fees for mobile home parks have far surpassed the rate of inflation. Families are finding themselves with drastically increased rents, without receiving much-needed improvements to the park. These families deserve a fair deal and need recourse when rent increases become unreasonable.

While the law currently prohibits more than one rent increase in a period of 12 months, park owners can do better to notify their residents before a rent increase takes place. For this reason, this legislation I introduced with Rep. Hanbidge would require park owners to publicly post a proposed rent increase 6 months before it would go into effect. This bill would also allow mobile home tenants to present their case to a magisterial district judge if the proposed rent increase is above inflation. This process gives tenants a voice and allows the magisterial district judge to find an equitable solution.

Our constituents and their families who live in mobile home parks deserve options when faced with drastic rent increases or having to physically move their home.

\$35 Cap on Insulin Prices

Insulin costs have tripled in recent years, leaving more and more people with financial hurdles to overcome to get their much-needed medication; tragic reports of deaths from insulin rationing have become all too common as people grapple with the skyrocketing price of this drug. People should not be forced to choose each month between their mortgage payment or rent and their medicine.

In order to combat this, Rep. Jeanne McNeill and I introduced legislation to establish a \$35 cap on insulin for each 30-day supply. Insulin was made to be an affordable, life-saving drug, and this legislation would provide the means to achieve that goal. Twenty-one states already cap insulin co-payments, including New York, Maryland, Texas and West Virginia. Congress acted in 2022 to cap insulin prices, but only for individuals on Medicare. There is no reason Pennsylvania cannot do the same thing to ensure everyone can access their medicine without breaking the bank.

We believe Pennsylvania should be leading the nation in access to health care, and that means catching up with our neighbors to make insulin accessible.



Workers Compensation for Off-Duty Emergency Personnel

Volunteer emergency responders are the heroes next door – they put their lives on the line to save the lives of fellow Pennsylvanians. However, volunteer ambulance corps members – unlike volunteer fire departments – do not have workers' compensation (WC) protections when responding to an emergency while off duty.

I believe it is important to protect our EMS providers who are dedicated to saving the lives of others, even when they are not officially on duty. That is why I introduced legislation to extend WC protections to off-duty members of emergency medical services agencies. Specifically, my proposal would amend Section 601 of Act 338 of 1915, known as the Workers' Compensation Act, to extend WC coverage to EMS personnel if the following apply:

- Is a member of an EMS agency.
- Is certified by the PA Department of Health as an EMS provider.
- Renders emergency care, first aid, or rescue services at the scene of an emergency.
- When rendering aid, operates within their scope of practice.
- While rendering aid, is injured or dies while providing emergency care.

Whether they respond to a 911 call with their EMS agency for a municipality or freely utilize their expertise in saving a life, EMS personnel deserve to know that they and their families will be taken care of in cases involving injury or death. Expanding WC coverage benefits not only our first responders, but all Pennsylvanians who may receive lifesaving care from an off-duty EMS provider.

BPA Free Food and Beverage Containers

Bisphenol A or BPA is the building block for a hard, strong plastic used to make a variety of products, including compact disks, cash register receipts, and water bottles. In the past several years, the potential health risks associated with the chemical have been well demonstrated.

Even at minimal levels, daily exposure to BPA has been associated with adverse health effects, from behavioral issues in children to malformations during organ development. In 2010, the U.S. Food and Drug Administration (FDA) issued a report identifying the possible hazards to fetuses, infants, and young children – later requiring that BPA be removed from all baby bottles and infant formula. Yet, BPA is still used in a wide range of food packaging.

To fully protect people, I introduced legislation to ban the use of BPA in all food and beverage containers manufactured, sold, or distributed in Pennsylvania. Any manufacturer of these containers would be required to use the least toxic alternative when replacing BPA during production.

GRANT ANNOUNCEMENT

Since January I have had the privilege of announcing five projects throughout the district that have been awarded a share of \$3.5 million in grant funding.

- Ambler Borough \$899,717 for pedestrian improvements along East Mount Pleasant Avenue and Hendricks Street, including 51 ADA compliant curb ramps.
- Horsham Soccer Association \$149,600 for two turf soccer fields at Kohler Park.
- Horsham Water & Sewer Authority \$970,918 to replace the Oak Hill water main.
- Horsham Water & Sewer Authority \$493,636 to repair the sanitary sewer system in Horsham Township.
- Miracle Field of Horsham \$1,000,000 to construct an all-abilities baseball field.

These grants will go to work improving Montgomery County's local infrastructure, including pedestrian safety and sewer sanitation. Grant programs like this are essential for neighborhoods throughout the commonwealth, ensuring the safety and functionality of the communities we call home. I'm especially grateful for the Miracle Field of Horsham's \$1 million award. The Miracle Field will ensure that children of all abilities throughout our district and beyond can enjoy the fun and camaraderie of Little League while creating a sense of belonging and comfort. This is such a worthwhile endeavor that will have a profound impact on children's lives. It's truly wonderful to see state dollars spent on this inclusive effort.

I am thrilled to announce that I received appointments to the below committees.

I am excited to see the work that will be done on these committees to create positive change for the people of not just our community, but the entire state.
