#### **DEAR NEIGHBORS.**

After a long and snowy winter, spring is finally upon us in Northwest Pennsylvania! We've been working hard for you in the district and at the Capitol. I am excited to update you on the progress happening right here in Erie as well as in Harrisburg.

To kick off 2025, we took bold steps to invest in the infrastructure that sustains and enhances our daily lives. We secured \$16.5 million in funding for the Erie City Water Authority. This investment will drive essential improvements to our water system, replacing aging service connections and ensuring that every family has access to safe, clean water—a vital stride toward a healthier, more resilient Erie.

In addition, we've brought a wave of innovation to our local economy with a \$1.7 million investment in Erie's first major business in the life sciences industry. This funding supports the development of state-of-the-art research facilities and creates new job opportunities, positioning Erie at the forefront of medical breakthroughs and technological advancements. These efforts are a testament to our commitment to fostering a dynamic environment where science, health, and community thrive together.

I'm also thrilled to highlight that Summit Township's Upper Peach Street project has received \$400,000 in state funding. This initiative will enhance pedestrian connectivity along a bustling commercial corridor, making it safer and more accessible for residents and visitors alike. We also were able to secure \$100,000 in funding for the purchase of two new Wesleyville Borough police cruisers, along with \$60,000 in funding for critical upgrades to Morrison Park. Greene Township also received a \$50,000 grant to aid in creating a warming center and emergency management response unit.

Moreover, our first responders—those everyday heroes who keep us safe—are receiving much-needed support. We've secured critical EMS and Fire grant funding that will deliver essential equipment upgrades for local fire and EMS departments. This investment, totaling over \$185,000, underscores our commitment to ensuring that the brave individuals who protect our communities have the resources they need to carry out their vital work.



## **BRINGING STATE FUNDING BACK TO ERIE COUNTY**
