- Strengthening public schools through a fair funding system that rectifies structural inequities as well
  as provides varied pathways to high school graduation, which would in turn support different career
  opportunities.
- Supporting strong unions and Pennsylvania's workforce through the establishment of a living wage
  for all workers and apprenticeship programs to help organizations grow their next generation of
  employees, whether in business and industry, education or health care.
- Offering efficient and effective physical and mental health care options that will guarantee reproductive freedom and provide easy-to-understand and inclusive insurance plans and manageable out-of-pocket expenses for doctor visits and prescriptions.
- Ensuring a clean environment by educating youth and families about recycling needs and ways to reduce waste, and by preserving parks and farmlands.
- Making the commonwealth a community where no one is marginalized regardless of ethnicity, religion, socioeconomic class, sexual orientation or gender.

# WORKING TO EXTEND COLA MORATORIUM & PROMOTE RECOVERY-ORIENTED LANGUAGE



I introduced H.B. 923, a bipartisan piece of legislation along with my colleague Rep. Shelby Labs, which would extend the current Social Security Cost of Living Adjustment (COLA) moratorium until December 31, 2027. This would allow PACE/PACENET cardholders to remain enrolled in these programs instead of having their previously approved COLA moratorium expire on December 31, 2025. The bill unanimously passed the House with bipartisan support on April 22 and now is with the Senate for consideration.

Words matter, and that's why I introduced H.B. 1117, Promoting Recovery-Oriented Language, to update the Department of Drug and Alcohol Programs' (DDAP) statutory language by replacing outdated and stigmatizing terminology with recovery-oriented language that promotes dignity, respect and greater access to care. The bill passed the House with overwhelming bipartisan support on May 5, and is with the Senate for consideration.
