A. Brief Concept

Requires coroners to investigate if a death was a Sudden Unexpected Death in Epilepsy (SUDEP).

C. Analysis of the Bill

House Bill 1442 amends Title 16 Pa.C.S. (Counties) to address the handling of deaths caused by Sudden Unexpected Death in Epilepsy (SUDEP).

If a coroner encounters a sudden, unexplained death involving a person diagnosed with epilepsy, they must conduct an investigation or perform an autopsy.

Every autopsy must include an assessment of whether a seizure or epilepsy was the cause of death.

If the coroner concludes that the death aligns with known or suspected SUDEP, they must note this on the death certificate and provide the deceased's next of kin with contact information for an external organization that tracks and studies SUDEP cases.

Definition of SUDEP

SUDEP is defined as the sudden, unexpected death of an individual with a known epilepsy diagnosis that is not attributed to trauma, drowning, status epilepticus, or other known causes. A SUDEP determination is considered "definite" when clinical criteria are met, and an autopsy finds no other cause of death, such as stroke, heart attack, or drug intoxication, although there may be evidence of a seizure.

Effective Date:

60 days.

G. Relevant Existing Laws

CHAPTER 139 of Title 16 Pa.C.S. (Counties) requires coroners to determine if a death needs further investigation or if an autopsy is needed. Under House Bill 1442, the sudden and unexpected deaths of a person diagnosed with epilepsy would automatically require an investigation or an autopsy. In addition, each autopsy conducted would require the coroner to check for SUDEP.

Statute defines "coroner" as an elected or appointed coroner or an elected or appointed medical examiner.

E. Prior Session (Previous Bill Numbers & House/Senate Votes)

HB 2549 of 2023 was reported from the House Health Committee unanimously, where it did not receive further consideration.

A. Brief Concept

Designates the week of September 21 through 28, 2025 as "Idiopathic Pulmonary Fibrosis Research and Awareness Week."

C. Analysis of the Bill

Idiopathic pulmonary fibrosis is marked by progressive scarring of the lungs, causing an irreversible loss of the lung tissue's ability to transport oxygen. It is a a generally fatal condition, often causing death within three to five years. There is no known cause and it often get misdiagnosed or underdiagnosed. More than 132,000 Americans have the condition. Each year approximately 40,000 individuals die from the condition and more than 50,000 new cases are diagnosed.

In Pennsylvania, approximately 7,000 residents are presently diagnosed with idiopathic pulmonary fibrosis. Relatedly, the Commonwealth is a leader in research and treatment of idiopathic pulmonary fibrosis, with more than 15% of all lung transplants in the United States performed in Pennsylvania hospitals. Organizations like the Wescoe Foundation for Pulmonary Fibrosis and the Pennsylvania Idiopathic Pulmonary Fibrosis Support Network play a crucial role in raising awareness and providing support and education for patients, families and health care providers throughout the state.

7	generally fatal disease marked by progressive scarring of the
8	lungs, causing an irreversible loss of the lung tissue's ability

10	WHEREAS, Idiopathic pulmonary fibrosis progresses quickly,
11	often causing disability or death within three to five years;
12	and
13	WHEREAS, Idiopathic pulmonary fibrosis is the most common
14	form of interstitial lung disease; and
15	WHEREAS, There is no proven cause of idiopathic pulmonary
16	fibrosis, and it is often misdiagnosed or underdiagnosed; and
17	WHEREAS, Idiopathic pulmonary fibrosis is five times more
18	common than cystic fibrosis and Lou Gehrig's disease, yet the
19	disease remains virtually unknown and receives a fraction of the

2 WHEREAS, More than 132,000 United States citizens have 3 idiopathic pulmonary fibrosis and more than 50,000 new cases are 4 diagnosed each year; and

5 WHEREAS, 40,000 people die each year due to idiopathic 6 pulmonary fibrosis, the same number as breast cancer; and 7 WHEREAS, Approximately 7,000 Pennsylvanians suffer from 8 idiopathic pulmonary fibrosis; and

9 WHEREAS, This Commonwealth has become a leader in the 10 research and treatment of idiopathic pulmonary fibrosis, with 11 more than 15% of all lung transplants in the United States 12 performed in Pennsylvania hospitals; and

WHEREAS, Organizations like the Wescoe Foundation for Pulmonary Fibrosis and the Pennsylvania Idiopathic Pulmonary Fibrosis Support Network play a crucial role in raising awareness and providing support and education for patients, families and health care providers throughout this Commonwealth; and

WHEREAS, Increased research, awareness and detection of idiopathic pulmonary fibrosis is needed; therefore be it RESOLVED, That the House of Representatives designate the week of September 21 through 28, 2025, as "Idiopathic Pulmonary Fibrosis Research and Awareness Week" in Pennsylvania to increase awareness and understanding of idiopathic pulmonary fibrosis to support improved diagnosis and treatment.

A. Brief Concept

Recognizes October 24, 2025, as "World Polio Day" in Pennsylvania.

C. <u>Analysis of the Bill</u>

The resolution highlights the role of Rotary International as a global network of individuals promoting change through humanitarian action and their role in eradicating polio.

The following facts are emphasized:

- In 1985, Rotary launched the PolioPlus program, and in 1988 helped establish the Global Polio Eradication Initiative, in partnership with the World Health Organization (WHO), the Centers for Disease Control and Prevention (CDC), UNICEF, the Bill & Melinda Gates Foundation, and Gavi, the Vaccine Alliance.
- Since 1988, polio cases have decreased by 99.9%, and the world is close to eradicating the disease.
- Currently, Rotary seeks to raise \$50 million per year for three years, with each dollar matched by two additional dollars from the Gates Foundation, generating up to \$450 million in total.
- Rotary has also influenced government decisions to contribute more than \$10 billion to the global effort.
- There are over 1.4 million Rotary members in more than 46,000 clubs worldwide that develop community projects focused on poverty, disease, hunger, literacy, and the environment.
